# Field Trial and Hunting Test Events Committee – available upon request sent to Barbara Donahue Herding, Earthdog, Coursing Events Committee –

- a. Earthdog: Concerns about the Intro and Novice classes being held in the same areas. (1) Novice Earthdog (NE) A new beginning level testing level. Presented to the Board in August will be voted on in October. If approved, it will become effective February 1, 2022.
  - (2) Earthdog Excellent Title -Six additional passes after earning the initial title earns a dog the Excellent

- title. This applies to each level (Junior/Senior/Master). Presented to the Board in August will be voted on in October. If approved, it will become effective May 1, 2022.
- b. FAST CAT: (1) Electronic timers will be required at all Fast CAT events effective March 1, 2022 (2) Hot Starts will not be allowed effective September 1, 2021. Scent Work: FastCAT® Limits on Participation for Timers, Lure Operators, and Paid Event Secretaries
  - (1) Paid Event Secretaries Dogs owned or co-owned by a paid event secretary, or any member of their immediate family or household, are not eligible to enter an event where the individual is the event secretary. Effective September 1, 2021.
  - (2) Timers and Lure Operators An individual cannot time or operate the lure for the same breed they, or any member of their immediate family or household, own or co-own, if their dog is entered in the event.
- c. Virtual Scent Work Test launched on August 2, 2021 as introduction to Scent Work (SW); 50 submittals per week and judged by approved SW judges.

Chairman's Report

# President's Report

Financial Report: as of September 30, 2021, total assets are 172 million dollars. Litter registrations for Q3 totaled 245,000 which is 17 percent higher than the same period in 2020. Dog registrations through Q3 totaled 619,718, 17 percent higher than the same period in 2020. Litter and dog registrations represent 45 percent of the total revenue for the nine months ending September 30, 2021

Adopted: Vote on the proposed amendment to Article VII, New Section 3, of the Charter and Bylaws of The American Kennel Club, which moves the statement concerning Board Elections from Article VIII which discusses the nominating committee to Article VII which addresses the election of the Board members.

Adopted: Vote on the proposed amendment to Article VII, Section 9, of the Charter and Bylaws of The American Kennel Club, which removes language that is superfluous and not necessary

to understand the specific power entrusted to the Board. (The amendment to Article VII, Section 5, 6 and New Section 7 was approved at the September 2021 Delegate Meeting, so this section was renumbered. When read in September 2021 this was Article VII, Section 8.)

Adopted: Vote on the proposed amendment to Article X, Section 7, of the Charter and Bylaws of The American Kennel Club, which removes language that is superfluous and not necessary to understand the specific power entrusted to the Board.

Adopted: Vote on the proposed amendments to Chapter 3, Sections 2, 4 and 5, of the Rules Applying to Dog Shows – Dog Show Classifications, which inserts language from Chapter 3, Sections 4 & 5 into Chapter 3, Section 2 pertaining to how age is calculated for the purpose of entry into an AKC event. It removes language from Chapter 3, Sections 4 & 5 as to how age is calculated to eliminate redundancy. As the determination of age for entry relates to all classes and not just Puppy and 12-18 Months, insertion into Section 2 applies it globally. This also provides examples for benchmark ages – 6 months, 12 months and 18 months.

Adopted: Vote on the proposed amendment to Chapter 3, Section 8, of the Rules Applying to Dog Shows – Dog Show Classifications, which provides clubs the opportunity to divide the Bred-by Exhibitor Class by age: Puppy and Adult. This follows the same logic as the Puppy and 12-18- month classes. Dividing the BBE class by age would be an option for clubs and not a requirement. An entry from any division of class awarded winners would be counted toward the BBE medallion as it advanced from the BBE class.

Adopted: Vote on the proposed amendment to Chapter 3, Section 11, of the Rules Applying to Dog Shows – Dog Show Classifications, which revises language for consistency, defining that 1st place undefeated dogs of the same sex from the defined classes defined by the rules and all division of them (age, color, markings, etc.) are eligible to compete in the Winners Class. Adds language to clarify that the only required classes to be offered are American Bred and Open, and all others are at the option of the club.

**New Business** 

CHF Update by Dr. Charles Garvin:

- a. In 2021 CHF invested more than 3.4 million dollars in 50 canine health research and educational grants. Of those 42 of the grants, 13 were for cancer research totaling \$1.3 million
- b. CHF earned the four-star rating from Charity Navigator and the Platinum Seal of Transparency from Guide Star
- c. Awarded three new clinician scientist fellowships and two new theriogenology residencies in 2021
- d. Continued support of One Health, which links human and canine researchers. In 2021 some 40 percent of our new grant funding supported studies with One Health significance
- e. Significant discoveries in histiocytic sarcoma, the genetic mutation that causes dwarfism in the Great Pyrenees, DCM, and genetic influencers of hip dysplasia
- f. Added Dr. Daron Collins as CEO and Dr. Jennifer MacLeay as Chief Scientific Officer
- g. Present the CHF 2021 President's Award to Duane and Connie Butherus

- i. PARENT CLUBS:
- a. AKC Humane Fund grants: are only awarded for specific projects. These grants cannot be used for fund raising events or capital improvements. A club may not apply for a Humane Fund grant if has done so twice over a period of 5 calendar years. So that means is that if your Parent Club has a rescue crisis, then you can request a Humane Fund grant, but you can no longer get a grant for non-emergency operations.
- b. Gov Relations: actively working on Healthy Dog Importation Act, HR 5261 (Paws Off"- all products containing xylitol to be labeled as such, Pets Belonging With Family bill- limits breeds in public housing. Foster Care legislation-dogs are seized and the owner (who is incarcerated) is then required to pay for their boarding expenses for the length of trial regardless of its length. This is a violation of due process.
- c. Parent Club Health statements- AKC attempting to reconcile a problem with two different health statements appearing on the breed page and Marketplace.
- d. Disaster Trailer, 440 clubs participate, \$1.696M donated from AKC clubs with \$650K matching grants from AKC Reunite.
- e. Campaign to Fast Track Breeds to Member Club Status

- I. AKC Purebred Preservation Bank- Mission Statement: The mission of the AKC Purebred Preservation Bank is to ensure the viability of purebred dogs. This valuable service is necessary to salvage or restore endangered dog breeds now and in the future by coordinating efforts with nonprofit breed specific clubs. The preservation bank will educate breeders clubs and the public about the importance of safeguarding frozen semen and protecting purebred dog breeds for future decades. Pupdate- 30 Parent Clubs participating, any owner of an AKC registered puppy will automatically receive a breed specific Pupdate weekly for the first 4 years of the puppy's life to help guide new owners through their pup's milestones. There are currently 725,000 Pupdate subscribers. Pupdate added 250,000 new subscribers in 2021. The list is growing at 15 to 20%
- n. Dock&Crop DCPA presented on their veterinary grant program. AKC Government Relations has a new flyer whose purpose is to educate the public on Crop & Dock issues.

- 3. Coordinating Committee Reports of Staff & Board Representatives Karolynne McAteer- Status of AKC today:
- a. 12/16/21 is the 21st anniversary of the AKC National Championships, 1,379 puppies competing and 816 OH and over 5,100 dogs competing for BIS.
- b. At start of Q4, over 500,00 dogs were registered
- c. Empire State Building, NYC, was lit with blue lights to honor Responsible Dog Ownership Day
- d. AKC and United States Police Canine Association (USPCA), National K9 Detection Dog group solidified a relationship. Detection Dog Challenge (DDC) held in Raleigh, NC in November. ESPN televised DDC and Flyball in Oct. When televising dog events, ESPN viewership raises to 50 % women.
- e. AKC quietly helped to fund, via The Kennel Club in England, the return of the Military Working Dogs (MWD) in Afghanistan.
- f. There were 22,400 events within 26 AKC administered sports.

Mari-Beth O'Neill, AKC Events reported:

- a. Vet School Program:
- a. there were 28 "Meet the AKC" veterinary presentations this year including 3 schools that allowed outside speakers to give the presentations.
- b. Vet student fall dog show tours-
- i. have been very successful with vet students from Cornell (Elmira Kennel Club show), Florida State (Space Coast Kennel Club and Central Florida in Ocala); University of Pennsylvania (Kennel Club of Philadelphia) and Tufts (Thanksgiving Cluster in Springfield, Massachusetts).
- ii. Dr. Alastair Cribb, Dean of the veterinary school at Tufts University was also in attendance during the vet student visit. Dr. Cribb met with Dr. Tom Davies, Dominic Carota, and Harold Tatro to discuss possible collaborations relating to Theriogenology between the veterinary school, AKC and AKC clubs.
- c. clubs in the vicinity of a Veterinary School or Vet Tech Program that would like to coordinate such a tour, contact her directly at mari-beth.oneill@akc.org.
- b. Juniors Program:
- a. entry of 141 Juniors at the AKC National. Criteria for eligibility was three wins in Open with competition and a 3.0 GPA or equivalent; reception for Juniors with certificates and awards for the top Juniors by event, top Conformation Juniors by Group, and the Versatility Scholarship recipients. The scholarships, totaling \$11,800.00, are offered by Carolyn and Gary Koch, Elizabeth Fletcher, the NC Triangle Judges Education Group, and the AKC National Junior Organization.
- b. Qualifying dates for the 2022 Conformation Junior Competition has been revised to September 22, 2021 to September 21, 2022 which is consistent with the NOHS dates.

Sheila Goffe, AKC Vice President, Government Relations:

Guy Fisher, AKC Club Development:

- a. Event Applications and COVID
- a. Events held on or before June 30, 2022 the following rules apply:
- i. If it is stated in the premium list that location (indoor or outdoor) will be determined on the day of the event, exhibitors would not be eligible for a refund based on the location of judging on the site.
- ii. There are three opportunities for Championship points on a single day provided one of the three events is a Specialty show.
- iii. All-Breed and Group Clubs can travel up to 300 miles out of their territory in extenuating circumstances to hold a show and

- iv. Specialty Clubs can travel up to 300 miles out of their territory to join another Specialty Club of their own breed.
- b. All events to be held after January 1, 2022
- i. Pre-COVID event application process will apply to all events to be held after January 1, 2022.
- ii. All-Breed Conformation events with an entry limit- premium lists containing these events are required to be published at least 72 hours prior to the acceptance of entries. All-Breed events with an entry limit must have a defined date and time for the opening of entries, which is to be prominently displayed in the premium list.
- iii. All other conformation event types: All-Breed without limits, Group/Limited-Breed (with or without limits), Specialty (with or without limits), and Parent Specialty (with or without limits), are not required to identify an opening date and time for entries.
- b. Club success offer a Canine Extravaganza by adding a few more events at a show; clubs can work with other clubs to host such events. Obtaining a FastCAT® license is recommended so that this successful event can be offered. Club Development reaches out to new show chairs to help them with holding shows. Although many clubs hire stewards for their events, everyone in the club should be able to steward in the event an extra or replacement steward is needed; train club members and others, such as Juniors, in order to develop a larger stewards pool.
- c. Increasing membership interest- contact clubdevelopment@akc.org for information about the Mix & Mingle or Meet & Greet programs. Two resources are "Best Practices for Membership" and the Event Operations Blog on the AKC Club Resources page
- d. Misconduct- Tom Davies suggested developing a video on how to conduct a bench show hearing. Dealing with misconduct can be found on YouTube or www.akc.org/public-education/akc-education-webinar-series/previously-aired-webinars-2019. Online misconduct is an offense and should be reported to the AKC. Example- an exhibitor posting negative comments on Facebook about a Show Chair and Superintendent when Groups started late.
- e. Breed Heritage Project- goal is to create tie between dog owners and a breed from their country of origin; he can be reached at swimcoach@comcast.net. Clubs can offer "mini" Meet the Breed events featuring breeds from various countries. Susan Sholar said she did a presentation on Italian breeds and talked about a breed that was nearing extinction but, thanks to preservation efforts, is doing okay now. #### **AWARD COMMITTEE GUIDELINES**

#### I. PURPOSE:

In line with the policies and procedures approved by the AMSC Board of Governors, this committee will:

- A. Provide the administrative oversight and management of the Annual Breeder Award Program for the AMSC. The intent of the AMSC Annual Breeder awards is to formally recognize the dedication of the Breeders who are the keystone of protecting and promoting the Miniature Schnauzer. The AMSC provides various means in which members and their dogs are recognized for their achievements. Some awards are given annually and others are for lifetime achievement. Some of the awards are not automatically given and require an application to be submitted to the AMSC Awards Committee.
- B. The AMSC Annual Breeder Awards include but are not limited to:
  - The Top Conformation Award Categories
    - Top Winning Dog
    - Top Winning Bitch
    - Top Producing Sire
    - o Top Producing Dam
  - The Top Performance Award Categories
    - o The Top Agility Dog or Bitch
    - The Top Obedience Dog or Bitch
    - o The Top Rally Dog or Bitch
  - C. The AMSC Special Recognition Awards include, but not limited to:
    - AMSC/AKC Sportsmanship Award

The AMSC special recognition awards are not necessarily awarded annually and have unique evaluation criteria. II. PROCEDURES:

- A. The Award committee's chairman is appointed by the AMSC President.
- B. The Chairman is responsible to identify the dog who earned the award in each conformation category. The Chairman is responsible to verify that the breeder(s) of the dogs eligible for the Top Winning Conformation Awards are AMSC members in good standing.

- C. The Chairman is responsible to identify the Performance dog who earned the award in each category. The Chairman is responsible to verify that the breeder(s) of the dog eligible for the Top Performance Awards are AMSC members in good standing.
- D. The Awards Committee Chairman is responsible to order the annual engraved awards.
- E. The physical award will either be presented directly to the recipients at the Annual Meeting or mailed directly to the recipients from the trophy company after the Annual Meeting. The Chairman will contact the recipients to determine their delivery preference. In the case of no response from the award recipients by September 1, the default is that the award will be mailed directly to the recipient's home mailing address.
- F. If a club member is nominated for the AMSC/AKC Outstanding Sportsmanship Award, the Chairman of the Awards Committee is responsible to notify the <u>AKC</u> of the AMSC/ AKC Outstanding Sportsmanship Award medallion recipient and have the medallion available for representation at the Annual Meeting.

#### III. AWARDS

The AMSC Top Conformation Dog award winners and AMSC Top Performance Dogs will be determined based on the statistics reports in the AKC Competitors Reports for the various venues. The qualifying period for the annual awards is January 1 – December 31 for the previous calendar year.

#### AMSC Top Winning Dog Award

This award is presented to the breeder of the male dog with the highest number of Miniature Schnauzers defeated (MSPTS) from the previous calendar year as reported by the AMSC Statistics Committee. Both the dog's breeder(s) and dog's owner(s) need to be members of AMSC in good standing. If the dog is registered with a co-breeder or co-ownership, at least one owner must be an AMSC member in good standing. The first AMSC member breeder listed on the dog will formally receive the physical award. Additional awards can be purchased privately working through the Awards Committee Chairman.

If the Breeder(s) and the Owner(s) do not meet the AMSC membership criteria, the next dog with the highest MSPTS point score and who meets the AMSC membership criteria will be awarded the Top Winning Dog Award for that year.

# **AMSC Top Winning Bitch Award**

This award is given to the breeder of the female dog with the highest number of Miniature Schnauzers defeated MSPTS from the previous calendar year as reported by the AMSC Statistical Committee. Both the dog's breeder(s) and dog's owner(s) need to be members of AMSC in good standing. If the dog is registered with a cobreeder or co-ownership, at least one owner must be an AMSC member in good standing. The first AMSC member breeder listed on the dog will formally receive the physical award. Additional awards can be purchased privately working through the Awards Committee Chairman.

If the Breeder(s) and the Owner(s) do not meet the AMSC membership criteria, the next dog with the highest MSPTS point score and who meets the AMSC membership criteria will be awarded the Top Winning Bitch Award for that year.

The Awards Committee Chairman will use the <u>AKC Breeder Report\*</u> to verify the breeder of record, if necessary. The breeder(s) membership is verified against the current year's AMSC Membership Roster.

# **Top Producing Sire**

This award is given to the breeder of the sire who produced the most offspring earning AKC conformation championship titles in a year period. The annual timeframe is January 1 to December 31 of the previous year. Multiple sires are eligible for this recognition award in the same year.

#### **Top Producing Dam**

This award is given to the breeder of the top producing dam who produced the most offspring earning AKC conformation championship titles in a year period. The annual timeframe is January 1 to December 31 of the previous year. Multiple dams are eligible for this award in the same year.

# Eligibility Determination:

The AMSC Statistical Committee receives monthly, breed specific title summary reports from the AKC. These reports are compiled and sorted on the sire and dam fields. The dogs with the highest number of dogs finishing breed championship titles in a year period are identified. The breeder of the Top Sire & Top Dam must be members of AMSC in good standing. If the dog is registered with a co-breeder or co-ownership, at least one owner must be an

AMSC member in good standing. The first AMSC member breeder listed on the dog will formally receive the physical award. Additional awards can be purchased privately working through the Awards Committee Chairman. Top Agility Dog Award:

The top agility award is awarded to the top Miniature Schnauzer competing at the Masters' level of AKC agility competition in the Regular height division earning the highest cumulative point score for the previous year. In addition, the dog must be owned by an AMSC member(s) in good standing and the dog must have been bred by an AMSC member in good standing. The first AMSC member breeder listed on the dog will formally receive the physical award. Additional awards can be purchased privately working through the Awards Committee Chairman. The AKC Top Dogs competition report ranks the top dogs in Agility events and is based on the total number of points dogs have earned from the Regular Standard & Regular Jumpers with Weaves classes at the master level. Dogs must

The qualifying period is January 1 -December 31 of the preceding year. The winners will be determined by the AKC Agility Score formula (Double Q's x 10) + Points that the dog earned during the qualifying period.

If the Breeder(s) and the Owner(s) do not meet the AMSC membership criteria, the next dog with the highest point score and who meets the AMSC membership criteria will be awarded Top Agility Dog Award for that year. TOP OBEDIENCE DOG AWARD:

The top obedience dog award is awarded to the top Miniature Schnauzer who earned the highest number of OTCH (Obedience Trial Champion) points earned during the period of January 1 – December 31 of the previous year. To be considered for this award, the dog must be owned by an AMSC member(s) in good standing and the dog must have been bred by an AMSC member in good standing. The first AMSC member breeder listed on the dog will formally receive the physical award. Additional awards can be purchased privately.

AMSC Awards Committee will use <u>AKC Top Dogs Obedience Report\*</u> directly from AKC to determine the winner. <u>To Configure the AKC Top Dog Obedience Reports:</u>

- Select the Report Type: By Breed Miniature Schnauzer
- Choose a Reporting Period: Previous Calendar Year
- Specify the Number of AKC TopDogs: 25
- Report is directly downloaded to the requestor\*

The Awards Committee will use the <u>AKC Breeder Report\*</u> to determine the breeder of record, if necessary. The breeder(s) and owner(s) membership will be verified against the current year's AMSC Membership Roster. If the dog is registered with a co-breeder or co-ownership, at least one owner must be an AMSC member in good standing. If the Breeder(s) and the Owner(s) do not meet the AMSC membership criteria, the next dog with the highest point score and who meets the AMSC membership criteria will be awarded Top Obedience Dog Award for that year. TOP RALLY DOG AWARD:

The Top Rally Dog award will be presented to the Miniature Schnauzer who ranks highest competing at AKC Rally competitions based on the total number of points and triple Q's dogs earned from the Rally Master, Rally Excellent B, and Rally Advanced B classes. Dogs must have qualified and earned points in one of these classes to be eligible to be included on these reports; or must have earned at least one triple Q. Dogs will begin to earn RACH points after they have earned the Rally Excellent (RE) title when scores of 91 or better are earned. To be considered for this award, the dog must be owned by an AMSC member(s) in good standing and the dog must have been bred by an

AMSC member in good standing. The first AMSC member breeder listed on the dog will formally receive the physical award. Additional awards can be purchased privately working through the Awards Committee Chairman.

The qualifying period is January 1 – December 31 of the preceding year. The winner will be determined by the AKC Top Dog-AKC Rally Score Report which is a calculation of the dog's (Triple Q's x10) + Points earned during the qualifying period.

AMSC Awards Committee will obtain <u>Top Dog Rally Reports for Miniature Schnauzer\*</u> directly from AKC competitive report to determine the winner.

The Awards Committee will use the <u>AKC Breeder Report</u>\* to determine the breeder of record, if necessary. The breeder(s) and owner(s) membership will be verified against the current year's AMSC Membership Roster. If the dog is registered with a co-breeder or co-ownership, at least one owner must be an AMSC member in good standing. If the Breeder(s) and the Owner(s) do not meet the AMSC membership criteria, the next dog with the highest point score and who meets the AMSC membership criteria will be awarded Top Rally Dog Award for that year.

# SPECIAL AWARDS:

#### AMSC/AKC Outstanding Sportsmanship Award

Each year, the AKC offers to provide a Sportsmanship Medallion to each AKC parent club to be awarded to one of the club's members. This award honors those individuals who deserve special recognition that have made a difference in the sport of purebred dogs, embodied the AKC Code of Sportsmanship, and have been an active and valued member of our club.

Only AMSC members in good standing are eligible for nomination. In a one typed page or less, nominations submitted by AMSC members need to include the name of the nominee, a description of how the individual has demonstrated outstanding sportsmanship during the previous calendar year, and the name of the individual endorsing the nomination. No additional weight is given to a nomination with multiple endorsements. Written nominations must be submitted to the AMSC Awards Chairman by August 1st for consideration to awarded at the AMSC Annual meeting. The Awards Committee Chairman will review the nomination(s) and seek clarifications from endorsers if necessary. The Award Chairman will inform the AMSC President of the name of the recipient and will proceed to work with AKC to procure the AKC medallion in time for official presentation at the AMSC Annual meeting.

This is not intended as an annual award, but will be given only on those occasions when clearly merited. The recipients of the AKC Outstanding Sportsmanship Award are presented with the AKC Medallion at the Annual Meeting.

- Preferred contact and mailing address for the medallion: Award Committee Chairman
- Outstanding Sportsmanship recipient name
- Date of award presentation for recipient

  - The Award Committee Chairman is responsible to ensure the medallion available for representation at the AMSC Annual meeting.
