### June 18, 2004 AMSC Board Meeting

Wyoma Clouss was appointed as the chair of this project, g) Acknowledgement of Constitution & ByLaw changes received. **Other Correspondence (Received)** – 1. Various Newsletters/Magazines, 2. Announcements offering a wide variety of professional services, 3. Hotel/Facility advertisements, 4. Miscellaneous - a) Heartland Community Bank signature verification forms, b) Pet Expo participation request. 5. **The AMSC Spring Specialty** was held in conjunction with the Atlanta Kennel Club on Saturday, April 10, 2004. Ms. Carla Nickerson judged 21 puppy sweepstakes entries. Ms. Mable "Jinx" Gunville judged 93 regular class entries.

#### Report of the Treasurer: Mack Ledgerwood

1. During the period January 1, 2004 to June 1, 2004, the Club had an income of \$17,746.21 and expenses of \$12,587.29, leaving a net income of \$5,158.92. The checkbook balance as of June 1 was \$11,472.96. The balance in the Health Research Account is \$10,486.44 and the balance in the Redi-Money Savings Account is \$34,268.27. Total cash assets are \$56,227.67.

2. The checking account has been moved from the Heartland Community Bank in Camden, AR to the US Bank, a bank with national presence and online access. The AMSC Vice-President has been made a co-signer on the account.

#### 3. Account Changes

a. **Committee made the motion to approve US Bank for the AMSC's checking account. Jan Taylor seconded the motion. Motion passed, 12-0.**

b. **Committee made the motion to approve moving the Redi-Money and Health Research accounts from Heartland Bank to a Charles Schwab, Inc., money market account. Chris Levy**

seconded the motion. Motion passed, 12-0.

c. **Committee made the motion to approve opening a PayPal account for the AMSC, in order to accept credit card payments from within the US and abroad.**

#### 4. Miscellaneous

a. Purina contribution of \$486.00 will be placed in the general fund earmarked for education.

b. The printing cost for AMSCOPE is becoming a financial burden on the finances. The revenue generated by the annual membership dues, are being spent almost exclusively to support the hard copy printing of this document. Lanny Hirstein appointed Mack Ledgerwood to chair a committee to investigate this issue and come back to the board with recommendations. Mack will choose two other members to serve along with him.

c. Investigated the possibility of an external audit to be conducted. It was estimated that the expense would be in the neighborhood of \$2,000.00-\$3,000.00. **Chris Levy made the motion to pay for "staff time" at \$60.00/hour to review our financial procedures. Jan Taylor seconded the motion. Motion passed, 12-0.**

All changes stand approved except for the amendments to Article VI (Meetings), Section 1 (a), Section 2 (a), Section 3 (a) and Section 4 (a), deleting the work "Written" are not approved. **Wyoma Clouss made the motion to add the word written to Article VI (Meetings), Section 1 (a), Section 2 (a), Section 3 (a) and Section 4 (a), as long as the AKC approved this action. Penny Hirstein seconded the motion. Motion passed, 12-0.**

4. DINNER/ANNUAL MEETING: John Constantine No Report.

5. EDUCATION, JUDGES: Lanny & Penny Hirstein, Chris Levy

a. The following qualifications must be met to apply to the Board of Directors to become a presenter; 1) Have knowledge of the background, history, and function of the breed, 2) Must be a member in good standing of the AMSC for a minimum of ten years, 3) Must be a Miniature Schnauzer breed expert whose ethics, integrity and devotion to the breed is beyond reproach and who is willing and able to share knowledge and provide guidance through open exchange of information, ideas and perspectives, 4) Must have met the minimum AKC requirements to apply for their Miniature Schnauzer judge's license. (12 years of breeding with at least five homebred litters and four homebred champions), 5) Enjoy interacting with others and is able to communicate in an understandable clear and insightful manner, 6) Posses the physical energy and flexibility of schedule necessary to accept presenting requests, 7) Demonstrates a commitment of impartiality and the Breed Standard and the AMSC Code of Ethics, 8) All applying presenters must have attended on AMSC sponsored seminar, 9) The applying presenter agrees and understands that an AMSC approved will co-present during their first presentation. It is also understood that if necessary, the applying presenter will pay expenses of approved presenter to attend the presentation; b) The application form to become a presenter was also shared and will be included within the body of AMSCOPE. c) **The committee made the motion to accept the final draft of the presenter qualifications and form. Chris Levy seconded the motion. Motion passed, 9-3-1;** d) Wyoma Clouss presented a seminar to 25 people in Long Beach and will do one for the ADSJ in August. e) The AMSC CD content will be going to Hilde Haakinson right after Great Western and she will be putting it into an interactive format. We will be taking more video & photos at Great Western and then sending them to Hilde during the summer to support the text. We could still use some really good photos of the old, great dogs (no longer being shown), who will be the only dogs that are named on the CD.

6. ELECTRONIC MEDIA: Mack Ledgerwood

Some noteworthy points:  
• Visitors to the AMSC website have tapered off since the first quarter, averaging 787 unique visitors per day in April and 736 per day in May. This amounts to almost 278,000 visitors per year creating

some 3,372,000 accesses to files (hits) on the website.

- We now have 143 breeders listed in the AMSC website's Breeders List section, up from 132 in March.
- We now have 15 Breed Mentors listed on the website.
- As of May 28, there are 220 members subscribed to the AMSC-L email list and 9,644 messages accumulated in the searchable archive.

**Chris Levy made the motion to approve the new structure of the health committee and it's new members. Motion seconded by Kurt Garmaker. Motion passed, 13-0. Motion amended by Carma Ewer to include Cindy Molieri as a member of this committee. Barbara Schulenberg seconded the motion. Amended motion passed, 13-0.**

**Item 2: New Researcher for MAC Study**  
Dr. Urs Giger from the University of Pennsylvania is now the researcher for the MAC (avian TB) study. The DNA study being conducted for Auburn is still on-going, but otherwise the investigation at Auburn is not currently active. The planning phase is underway, and Dr. Giger is accepting blood

samples from MAC affected dogs now. Please contact him at [giger@vet.upenn.edu](mailto:giger@vet.upenn.edu) if you wish to submit a sample from an affected dog, or contact Errolyn Martin at [chattelane@juno.com](mailto:chattelane@juno.com) or 334-703-0166. It is extremely important that Dr. Giger obtain blood samples from affected dogs.

**Item 3: Registry Notes for AMSC Avian TB Open Registry**

The secretary sent all board members a draft of the Health Committee's registry notes to review prior to this meeting.

A discussion took place regarding this very detailed and lengthy document that was shared with board members prior to this meeting. The document included an educational section, a disclaimer statement and an example of a pedigree risk analysis. It was suggested that the pedigree risk analysis section could in fact be placed on the web site and just referenced on the educational and disclaimer statement section as a resource. The board asked Errolyn Martin to remove the pedigree risk analysis section from the document, rewrite it in a simpler version, and resubmit it to the board at the October meeting for approval.

**The committee made the motion to approve the publication of the educational section and disclaimer statement of the registry notes that will accompany the AMSC Voluntary Open Registry for Avian Tuberculosis. Bev Verna seconded the motion. Motion passed, 12-1.**

A. C&JC: Kurt Garmaker, Carole Weinberger  
1. Update on Retinal Dysplasia The full article on RD in Miniature Schnauzers has been published in Veterinary Ophthalmology. The health committee will be submitting the article to the AMSCOPE editor for publication. Direct quotes from the article: "Generalized retinal dysplasia in Miniature Schnauzers in our study population is congenital, inherited, and has clinical manifestations similar to this disorder in other breeds of dogs. However, it is unique in that the retinal dysplasia was extensive, many puppies were blind secondary to retinal detachment, and it was associated with a mild, unilateral or bilateral PHPV. The early ophthalmoscopic manifestations of this retinal dysplasia were subtle light-gray folds. However, the dysplastic areas often appeared less obvious as the dog matured."

"In conclusion, we report congenital retinal dysplasia, associated with retinal detachment and PHPV in Miniature Schnau-

zers. This disorder is inherited as an autosomal recessive condition." **The committee has reviewed the article, and motions the AMSC board of directors approve the formulation of a letter from the AMSC to the Canine Eye Registration Foundation, requesting that CERF designate retinal folds in Miniature Schnauzers be a non-certifiable condition. Hearing no second on the motion, the motion died for lack of merit.**

The board of directors had many questions and discussed this issue at great lengths, but didn't feel ready to support this motion at the present time. Lanny Hirstein asked that this issue be addressed again at a later board meeting once the board members have a chance to review the entire article that is referenced in this report.

2. No new reports of any type of cataracts.

B. PRA:

Committee will become a part of the Eye Committee in the future. Lanny Hirstein directed Kurt Garmaker to meet with Dr. Aguirre regarding the status of the PRA research project.

C. Urinary: Patty Ledgerwood, Bob Baws, Kennalea Pratt

Quotation for JRD Funding from DNA Solutions, LLC

This item was initially discussed in April, and the committee recommended we decline funding at the time. The initial proposal was vague about how the breed club funds would be applied and did not provide for accountability of funds. Dr. Mary Whitely has revised and resubmitted the proposal. The revised proposal indicates AMSC funds would be used for scientific study of this defect in Miniature Schnauzers. Additionally, Dr. Whitely has agreed to provide a periodic accounting summary. AMSC members should realize this study is starting from scratch. There are no guarantees that the mutation responsible for JRD in our breed will be identified through this study. Since DNA Solutions is a for-profit organization we cannot use the CHF donor-advised fund. The AMSC can fund each phase of the proposal as progress is made. The funding for the first phase of this work is \$6,000.00. Total funding if completed will be \$ 23,500.00.

**The Urinary Committee motions the AMSC approve the initial \$6,000.00 funding request for the first phase of the research. Mack Ledgerwood seconded**

**the motion. Motion failed, 2-11.**

The board asked the committee to come back with the researcher's definition of "completed". The committee also reported that the Canine Health Foundation (CHF) agreed to review the research project for scientific merit. The board asked that the researcher submit the proposal to the CHF for scientific review as soon as possible.

Some clubs offer trophies for the best time in class, some offer prizes for anyone who qualifies. If we would like to donate a trophy per class, there are classes for: Novice, Open, Excellent Standard, and Jumpers

With Weaves each day. It sounds to me like 4 possible trophies per day X 3 days - 12 trophies possible. Trophy statements (that appear in the premium list) are due to the Trial Secretary by July 1st. If we are going to offer any sort of trophies for the classes, we need to decide post haste. We do not have to decide WHAT will be offered....only that SOMETHING will be offered and get that information to the Trial Secretary by July 1st.

This is all the information I have been able to gather at this point. I would like to offer the trophies for all classes each day. If our budget will allow it, that would be great. Furthermore it is my understanding that the AMSC has a small 'stash' of miscellaneous trophies from years past, which might be quite suitable for these events.

The board asked that the committee investigate the number of miniature schnauzers who compete in this event and come back to the board to request trophy donations in 2005.

**UNFINISHED BUSINESS:**

1. Membership Application and Sponsorship Forms At the October Board meeting, the Board discussed possibilities of knowing more about potential members beyond their name and two sponsors' names, as is current practice. The Board discussion centered around increased information, rather than limiting membership. After that meeting, Chris Levy shared an excellent sponsor form and membership application from the Silver Falls Kennel Club. These forms would provide good information about each prospective AMSC member, and the information could be shared with Board members prior to voting for membership approval.

The AKC defines a foreign member as one who is not residing in the US, regardless of citizenship.

2. **Wyoma Clouss made the motion to accept the following people as new AMSC members, Betty Blank, Marty Morgan, and Jeri Muntis. Jan Taylor seconded the motion. Motion passed, 11-0.** The following applicants will need to reapply after the foreign membership application has been developed and approved; Mari Szquerzopf. The application for Laura Sue Bochniak was tabled pending the receipt of letters in support of her membership from her two sponsors.

3. The AMSC received some correspondence from a prior member who missed the deadline of March 1, 2004 and was denied membership for 2004. Lanny Hirstein will send her a letter inviting her to reapply for AMSC membership.

**NEW BUSINESS:**

1. The nominating committee will have their slate prepared prior to the July 1, 2004 deadline and will send the information to the membership in a special mailing.

**2. Wyoma Clouss made the motion to add live links to the miniature schnauzer web sites of members who have their names listed on the breeder referral list on the AMSC web site. Chris Levy seconded the motion. Motion passed 11-0.**

3. Gloria Lewis made a request to dedicate an AMSC specialty to long time AMSC member Virginia Rice. It was the consensus of the board that the Florida MSC specialty be dedicated in her memory.

4. Gloria Lewis asked that the secretary's duties be divided into that of corresponding and recording. It was decided that the most time consuming part of the secretaries duties seemed to be answering email from visitor's to the web site, and it made more sense for a position to be created that could support the secretary in handling this task. The person's email address will be live on the front page of the web site, in lieu of Terrie Houck's address, under a heading of "For More Information Please Contact". Lanny Hirstein will ask for volunteers to fill this new position in the near future.

## from the desk of.....

### Lanny Hirstein

In response to statements made on the internet by two members, I (Lanny Hirstein) have had their concerns looked into and these are the findings.

#### 1. The AMSC should start selling afghans and other paraphernalia on its website.

The AMSC is a nonprofit organization. If it starts acting as a retailer, it will have to file income tax returns and pay taxes. Furthermore, its non profit status would be jeopardized if sales were more than *de minimus* (small).

#### 2. The Board has put the AMSC in legal jeopardy by not holding annual meetings and by not auditing the books.

The AMSC is a nonprofit corporation in good standing according to its state of incorporation. The AMSC has held its annual meeting at Montgomery County each year. It is irrelevant whether anyone formally announced at the beginning of the meeting that it was the annual meeting. Any member could have asked to have business placed on the agenda and could have asked to have been recognized at the meeting. Since that did not occur, no-one's rights have been violated. Written notice of the meeting (the dinner) was given to members in AMSCOpe. Even if the AMSC's books have not always been audited exactly annually, they have been audited periodically and no discrepancies have been found. Thus, any omission to have audits done annually has caused no harm. In any event, there is no legal requirement that the book be audited at all, so while any omission in conducting audits could be a subject of complaint by members, it is not a matter that places the AMSC in violation of law.

#### 3. Under the laws of the state of incorporation, clubs are required to have an annual audit.

Corporations are required by state law to keep books and records. There is no requirement that they conduct audits.

#### 4. It is standard for clubs to publish audited financial statements for their members.

It is common for large clubs with substantial income (like the AKC) to do so. It is very unusual for small clubs to do so because the expense is prohibitive for them. The AMSC Bylaws provide that the books shall be audited. They do not require that the AMSC prepare audited financial statements, or that the audit of the books be conducted by a Certified Public Accountant. There is no require-

ment in the Bylaws that the results of the audit be transmitted to the Board by the auditor rather than the Treasurer. That would assuredly happen if the auditor found the books to be incorrect. If, as apparently was the case, the auditor found nothing wrong, it is irrelevant who reports that result.

#### 5. A lack of formal audits could also jeopardize IRS tax exempt status

There is no IRS requirement that nonprofit social clubs conduct audits, formal or otherwise. Nor is there any IRS requirement that nonprofit social clubs conduct annual meetings. Under the First Amendment right of association, it is up to clubs to determine those things themselves. The IRS's concern with nonprofit social clubs is that they not be used to conduct profit-making activities without reporting and paying the tax thereon.

#### 6. Have the new changes to the Bylaws been submitted and approved by the state of Maryland?

Amendments to the articles of incorporation must be filed. Amendments to the Bylaws need not be filed or approved by the state of Maryland.

#### 7. The AKC is not your ultimate master – the state of Maryland is

The AMSC must comply with the laws of the state of Maryland if it wishes to continue as a corporation incorporated in Maryland. The AMSC must comply with the rules of the AKC if it wishes to continue to be recognized by the AKC as the parent club for Miniature Schnauzers. Fortunately, the two sets of rules are not inconsistent.

#### 8. The AMSC is also prohibited from excessive lobbying to influence legislation. This would include anti-breeding or breed specific legislation.

The AMSC can lobby all it likes on any subject it likes. Lobbying is prohibited for IRC 501(c)(3) organizations, but the AMSC is not a 501(c)(3) organization (charitable organization). It is a 501(c)(7) organization (social club). The rules are very different because contributions to a 501(c)(7) organization are not tax deductible. The IRS thus does not need to ensure that the activities of a 501(c)(7) organization would qualify for a tax deduction.

#### 9. The ChromaGene test for Labradors, poodles, cockers applies equally to Miniature Schnauzers.

Not according to VetGen, which developed the test. VetGen has expressly told the AMSC that the test has not been determined to work with Miniature Schnauzers and should not be used to try to determine color genes in Miniature Schnauzers. It would be foolhardy for the AMSC to adopt the view of an untrained member over those of the trained geneticists who developed the test in question.

#### 10. The AMSC Treasurer is able to sign checks with a single signature.

There is no legal requirement for two or more signatures. It is up to each club to determine how best to conduct its financial affairs. Safeguards to ensure against improper use of club money must always be weighted against the cost and difficulty of implementing such measures. With a national club whose members are scattered around the country, it is impractical to require that two board members sign every check. On the other hand, the AMSC has implemented a dual signing requirement for its savings account since there is less need for immediate access to a savings account than to a checking account.


