Membership:

As of 10/6/16 our membership totaled 427 Regular, 5 Life, 31 Foreign (w/voting privileges), and 29 Foreign (w/o voting privileges) for a total of 492. There are 13 new member applicants (11 Regular and 2 Foreign). There have been 5 deceased members in 2016.

Local MS Clubs:

REPORT OF THE AKC DELEGATE - Don Farley  
AKC Delegates Meeting 9/11-12/2016

COMMITTEE MEETINGS: Parent Club Committee Summary (Pat Laurens, Chairperson):

— To date, there are 40,100 CGC titles. Not all are part of AKC; mixed breeds must have an AKC "Partner" ID. If the dog is not registered, they can only get a CGC Certificate not a CGC "Title."

— There at 200 Breeds involved with the HEART Program.

— Pet Disaster Trailers: 341 Clubs have participated

— there have been \$1,016,506 in donations; \$250K is being donated by ReUnite, for a total of \$1,266,506

51 trailers have been donated in Indiana, the trailer was on-site within 12 hours along with the Red Cross trailers

in Louisiana, clubs are working to get trailers to New Orleans and Baton Rouge; there were none in the immediate area

The question came up if an area needs to be declared a "disaster" in order for the trailers to be deployed. does it need to be in the contract for the area?

It can be deployed for other "disasters" besides tornados, floods, fires, etc.

— Parent Club Self Evaluation:  
Median score: 96/130  
Mean score: 93/130

58 were compliant with: boiler plate membership form; Code of Ethics; most had judges education, breeder and judges' mentoring. 7 out of the 58 responding clubs only do conformation

The question was raised at to what the Parent Club Committee (PCC) was going to do with all this data — they will publish a master list for PC Delegates.

There were comments on what/how much the PC's learned by going through this process. No specific conclusions were made.

— Archives for Parent Club materials

AKC has an Archivist that can help clubs with their own archiving

Clubs should inventory their collections before contacting AKC Archivist

Archivist is putting together guidelines on what to do for archiving

— Specialty Show: Steven Pessech (SBP@AKC.org) will help Parent Clubs be sending emails for their Specialties

— Parent Club Conference:

They are considering another Parent Club Conference. Details will be sent to the people on the Parent Club Conference List. Peter Piuze will send the email. One of the challenges is finding a ballroom large enough at a place which can also take care of meals.

**MINUTES..from p.2**

There will be a Canine Health Foundation Parent Club Conference in August 2017 in St. Louis. The last conference was 2010; it takes 3 years to plan and execute, so the next one can't be until 2020.

Suggestion as made to focus on 2018 - the opposite year from the Canine Health Parent Club Conf.

Need a budget discussion and decision made. AKC did not release the actual cost of 2010 conf. so PCC doesn't know how much it cost per person/club.

Legislative Report: Sheila Geoff gave a report. They're monitoring over 2000 Federal/State/Local issues on owning dogs. They're tracking at the Federal level but don't have the same ability at the local law level. AKC is relying on the Legislative Liaisons from each club to share that information.

HSUS has an agenda against commercial breeders. HSUS is trying to force retailers to ONLY get dogs from shelters/rescues and not from responsible breeders

**Clubs joining AKC:**

AKC is trying to get parent clubs to join AKC when they move from Miscellaneous to regular groups. Question was asked what exactly are the requirements to be a Member Club? No answer was provided.

How many Parent Clubs do not have Delegates? No answer provided

**Other items:**

— Showing spayed & neutered Dogs: the Board decided this did not work positively with where AKC wanted to go. Since the Board shut this down, nothing further will be considered by the PCC.

— Juniors: what about when foreigners want to compete — one option is to transfer owners for the ONE event (seems an odd choice). Suggestion to focus on 4-H engagement to encourage Juniors.

— Vet Outreach: there are scholarships from the AKC, and some clubs are providing scholarships also

— AKC Marketplace: suggestion to identify Parent Club Rescues on the Marketplace; Breeders —> Parent Clubs —> Rescues

— Group Realignment: 551 emails sent out, 361 responses. 71.79% Yes address restructuring; 71.71% Yes create new groups; 70% Yes rearrange existing groups. The discussion with include Clubs not just Delegates. The question was asked about doing a group at a time; Board member said that was too involved, and the re-programming impact was more difficult than it seems

— Genetic Diversity: prompted by the NPR story against Bulldogs; UC Davis said they were not genetically diverse and made other derogatory statements. They noted Switzerland had laws against "torture breeding" brachial cephalic breeds; more going on in Europe and will be coming to US. Breeders were sited as the problem no longer being responsible.

— AKC has a Scientific Committee and proposed each Parent Club has their own scientific resource to speak about their breed's genetics and health

— DO NOT HAVE ADVERSE MESSAGES on breed websites as the first item people see! This was emphasized by the PCC

— Reinstatement Procedure: Club must be notified 2 weeks in advance and agree to it; demonstrate insurance on the dog provided by the owner; AKC provides insurance for al judges; dogs must leave the grounds immediately; at time of DQ, must swab for DNA. Means DNA swabs must be available at EVERY event; is this realistic? Who would do the swabbing. Increase the cost of reinstatement also. NOTE: Identifying the dog is different from identifying the "breed" of a dog

**By Laws Committee ("BLC") Summary (Gretchen Bernardi, Chairperson):**

— Need to address Delegate Eligibility

— "Glossary of Terms" needed: Constitution vs By Laws; Member Club vs. Associate Club vs Licensed Club

— "Determine the Rating of each breed" will be posted to the Delegate list for feedback.

— Note: the Delegates vote on RULES, we do NOT vote on REGULATIONS

— Proposal to have no fee for Delegates who are judges who want to get a new breed since they are unable to recoup that expense because they are prohibited from charging a fee. This is a policy not a by-

law. The Committee can ask the Board to change this policy. The BLC voted to have the Chairperson request a non-binding sense of the Delegates vote.

— All judges should have a contract. And Delegate Judges may NOT request a "contribution" if it's a condition of their agreement to judge.

— Nominating Committee: Propose a 9 member Nom. Comm. for Board seats; could be 1 member from each Standing Committee or from the Delegate Body.

Chairperson selected by them.

Electioneering by Board nominees is discouraged

Caucus should be chaired by someone from the Nom. Comm.

Currently the Nom. Comm. is chosen by the Board; this would let Delegates choose the members

Suggest Nom. Comm. have set of 15 questions to be answered by each candidate

Alternate N.C. members should be involved throughout the nominating process

— "Parent Club Membership": question was raised if, when a "new" Breed is recognized, should the Parent Club automatically become a Member Club? Discussion tabled for later date.

**Crop & Dock Ad Hoc Committee (Peter Piuze, Chairperson):**

— Anyone not receiving emails, let Peter know and he'll add them to the Yahoo list.

— He asked if we should respond to the Bulldog article written by Karen Bulliard. I said yes, we should respond and quickly. I said we should have some standard pro-C&D materials ready to use as responses all the time. We should not be waiting to decide days or weeks later IF we're going to respond as an AKC group. The other Delegates present agreed and tasked Peter with sending a response.

— Government Relations: Marilyn DeGregorio from the Doberman club is dealing with govt. issues. She's helped the Doberman club prepare positive arguments/rebuttals, and they have positive messaging on their website.

— One reason noted for no support by Vets is they believe they will lose business if they

promote crop or dock, even for non-canines, i.e. sheep, pigs, other livestock. AKC's official veterinarian, Dr. Jerry Klein, is scheduled to talk about Crop & Dock at the December Delegates' meeting.

— the Association for Preservation of Purebred Dogs ("APPD") is the Canadian pro-crop & dock group. They want to work with AKC and the NAlA.

— Suggestion was made to collect and compile the questions we receive about C&D, and how we answer them so the C&D group could put together an FAQ-type of resource.

— The AVMA has little info on C&D; one person said vets are not taught to crop or dock anymore; sources for AVMA information — one Scientific Journal article and a compendium on C&D written for the AVMA.

— One Delegate noted that even our own Delegates and Member Clubs are discriminating against us, sometimes being unaware of the results of their statements or actions.

— The Ministry of Agriculture in Canada controls the Standards, as does the Kennel Club in the UK, which allows them to prohibit C&D. We discussed AKC's lack of visible and vocal support in our positions; and noted that because these are "cosmetic" we are not allowed to make them DQ's.

— Suggestion made to compile short movies/promo materials showing puppies being okay after docking, and showing puppies that are not harmed by proper cropping. Should there be a possible channel on YouTube or put these on a website:

— Do we have a C&D position statement on the AKC Website? The PWCCA.org has a position statement on their website.

AKC DELEGATES MEETING:

### Highlights from meeting:

Three new members clubs were approved: Berger Picard Club of America, Hendersonville Kennel Club, and Irish Red and White Setter Association of America.

Financial Report: Net assets of \$74.3 million have increased by nearly 14 percent since August of last year. Total revenue of \$43 million has been offset by total expenses of \$38.6 million, which reflects an operating income of \$4.4 million. Dog registrations are

currently 359,000, which is 11 percent above the eight-month period of 2015.

Voting: The first vote is on the proposed amendment to Chapter 3, Sections 4, 5, 7, 17, and 19, of the Rules Applying to Dog Shows. This amendment would in Section 4, change the italicized paragraph to become part of the rule rather than a Board clarification, with no change to the wording; in Section 5, it would add the statement regarding the first day of a multiple-day show being used to calculate age; in Section 7, it would change the italicized definition of professional handlers to be part of the rule, not a Board clarification, with no change to the wording. Additionally, in Sections 17 and 19, it would change the italicized paragraph to become part of the Rule, not a Board clarification. The only change to the wording is removing the effective date. There were two-thirds in the affirmative and the amendment was adopted.

The second vote is on the proposed amendment to Chapter 6, Section 9, of the Rules Applying to Dog Shows. This amendment would allow entries in any form to be accepted for 24 hours after the closing date and time when it falls on a postal holiday. There were two-thirds in the affirmative and the amendment was adopted.

Read for voting at the December meeting: The proposed amendment to Chapter 6, Section 9, of the Rules Applying to Dog Shows, would extend the closing time for entries to be no later than 11:59 p.m.

### Additional Notes:

—Carl Ashby discussed the AKC PAC and urged Clubs to participate and help fund candidates believed to be favorable in helping protect our rights as dog breeders and owners.

—Six Delegates were acknowledged for having served as Delegates for 25 years. Three Clubs were also noted for celebrating 100 years of membership in the AKC: Atlantic Kennel Club, Detroit Kennel Club, and Louisville Kennel Club.

—The election of members for the Standing Committees was completed and all seats filled.

—The Nominating Committee was introduced and Patti Strand, chairperson, presented the nominees for the Class of 2021: Rita Biddle, from Ingham County Kennel Club; Dominic Carota from the Pharaoh Hound Club of America; Dr. Gregory Paveza, from the Elm City Kennel

Club; and Harvey Wooding from Westminster Kennel Club.

Carole asked me if I would chair this committee—

- Why place retired dogs?
- Why feed 30 dogs if you are only showing or breeding 10 of them?
- Why pay vet expenses for dogs you aren't doing anything with?
- Why not let them have a home of their own? the kind we all want out puppies to live in where they are:
- Live in a family with a couple of dogs and get more individual attention than we can give them
- Live in the house and share a close bond with their family
- When a person nears the end of their career, gets ill, has financial difficulty, etc, there will be far less dogs needing urgent placement.
- Why place through a rescue:
- Rescue guarantees home for life, Must return to us, if they ever can't keep
- You won't have to worry about getting this dog back when they're 12 yo
- Rescue has the resources to do a thorough screening including:
- Hour phone interview (discuss keeping on leash, feeding good food, appropriate vax, grooming requirements, etc.)
- Reference call to veterinarian to verify their current/past dogs are well cared for
- Home visit (we have people all over our areas to do HVs/hard for most people to do)

Three pronged approach:

- Help people get their number of dogs down to just what they are currently using
- Then, start placing dogs as they retire.
- This gives the dog more years of a family life
- Allows people to focus attention and finances on the dogs they are using
- Keeps number down so if there is an emergency, there are less dogs to place, and ensures there will be no emergency where we have a lot of older dogs that need homes
- Easier on rescues to place dogs at 6yo than 10yo
- Place dogs in any emergency situation: illness, death, financial difficulties

Updated Performance Committee Guidelines for Board Approval:

AMSC Performance Committee

PURPOSE: In line with the policies and procedures approved by the AMSC Board of Governors, this committee will:

Educate the general membership about the sports of obedience and agility, rules pertaining to AKC Obedience or Agility Trials, and training techniques. The Performance Committee shall answer questions from the membership regarding any of the above. The Performance Committee will foster positive relationship with the general membership by emphasizing positive training techniques, good sportsmanship and proper care of dogs trained in AKC obedience or AKC agility. The Performance Committee will address question posed by non-members as needed in order to foster education and good will with the public. The Performance Committee will be responsible for gaining AKC approval for AMSC Obedience or Agility trials in conjunction with selected AMSC specialty shows. Procedures: The Performance Chairperson shall serve as the primary point of contact for the general membership, officers of the club, or the board of the AMSC for all obedience and agility-related issues. The Performance Chairperson shall also address any issues posed by AKC or non-members to the club regarding obedience or agility concerns or questions. The Performance Chairperson shall write a column titled STAND FOR EXAM to be submitted to the *AMSCOPE* editor as

appropriate. The column should address tips, techniques, discuss changes to AKC rules and regulations for obedience or agility trials, or simply inform the membership on a particular topic. The Performance Chairperson will designate a Co-Chair as needed to perform duties related to hosting Obedience or Agility Trials. At all times, the Performance Chairperson shall try to maintain a professional demeanor, and shall remain in good standing with the AKC; with the intent of maintaining good sportsmanship and upholding the sports of AKC obedience and AKC agility. After discussion, the following will be added to the committee guidelines: There will be a liaison to the Montgomery County All Terrier Trial performance trial. Add Barnhunt. The committee will be an integral part of the planning of official AMSC performance trials. Luana Nedich, with a second by Kaye Kirk, made a motion to approve the committee guidelines as amended.

**Constitution & By-Laws:** Chris Levy, John Constantine, Wyoma Clouss  
Chris Levy is working with the parliamentarian at this time and will have something for the next Board meeting in Portland.

**Montgomery County Hospitality:** Barbara Donahue and Luana Nedich  
Barbara ordered dinner to be catered at the board meeting and has organized the Saturday night get together. Luana will have hospitality on Sunday at the show.

**Education:** Wyoma Clouss, John Constantine –  
John Constantine presented the AMSC Judges Education at Louisville, KY, and Wyoma Clouss presented at the MiniPalooza in Grey Summit, MO. Discussion by the Board for education at the Portland 2017 Specialty resulted in a preference for a Top 20 instead, with all possible time slots otherwise occupied. We will be part of the AKC/DJAA Judges Institute in Orlando. Our presentation will be on 12/16/16 at 8:30 AM. John Constantine will be the presenter. These institutes typically draw very large numbers nowadays. We expect about 20 - 30 judges.

**Electronic Media:** Chris Franck, Jana King, Vicki Kubic  
The website continues to expand. The public MAC page is constantly kept up to date and has about 10K hits. As we update our Committee Guidelines, A section in the Members Only section will be added for them. Our largest number of hits is on our Referral pages at approximately 99K followed by our interactive map at about 60K hits. All About Mini Schnauzers 36K, Pet Grooming received 45K hits, Members Long-In page almost 16K, General Health 21K, Photo Gallery of Colors,

Activities, Regional Clubs, Breed Standard and Rescue all received about 19K hits.

**Ethics:** Margo Klingler, Marcia Feld, Patti Henderson, Marie Murphy –

Although the committee has not met, we have talked in length about possible changes to ethics issues. The committee members were asked to make suggestions and bring them to the meeting on October 8, 2016 at the Devon Dog Show. As soon as comments and suggestions are made, the Committee will present to Marie Murphy for a legal interpretation and then to the President and Bylaws Committee.

The Committee suggests more presence to enforce whatever suggestions are made and changes accepted. The committee suggests publishing policy in AMSCOPE and then maybe having members sign a new Code of Ethics policy which will be kept on file. These harsh statements are to include social media, personal assaults, both verbal and physical. If the Code of Ethics policy is signed and dated and with Marie's review of legalities, I would like to see memberships terminated. I just do not know the legalities of this action. I would like to see 1, 2, 3 warnings and final terminations. These complaint forms can be downloadable from the website. If written or verbal threats are made against the AMSC, these should be admissible.

I understand that after review of the Constitution and Bylaws, Code of Ethics can be included with this review. I would also ask that no one but the Ethics Committee members review what is presented on the form. I will develop a form for the internet use once the Board decides what items should be included in the letter and form. Although actions are nebulous at this time, clarification will be clear after suggestions from the Board.

A motion was made by Luana Nedich, seconded by Patty Ledgerwood, to add Marie Murphy to the ethics committee. The vote was all in favor with Marie abstaining.

**Guidelines:** Luana Nedich  
A motion was made by Patty Ledgerwood, seconded by Brian Bogart to appoint Luana Nedich to take over the guidelines committee. She will contact each committee to work with them to make sure all committee guidelines are updated and posted for club members to have access to.

**Health:** Patti Henderson, Paula Steele DVM, Lisa Sarvas DVM, Kurt Garmaker, Sheila Marks, Patricia O'Brien  
AMSC Health Committee has had a very busy year since last annual report. Ultimately our

primary focus became the administration of the MAC DNA program which put other plans on the back burner for the greater part of the year. We were successful in several projects – Genetic Education Program for AMSC members (AMSCOPE articles) coordinated and developed by Dr. Sheila Anderson plus 2 excellent seminars to augment breeder education in genetics by Dr Carmen Battaglia PLUS ongoing research in Stone Disease in Miniature Schnauzers presented by Dr Eva Furrow – both outstanding speakers and researchers. Dr Giger's grant approval by the AKC/CHF was approved for funding in March 2016. In May 2016, he contacted the Health Committee to advise he had found a DNA test and would hold any announcement until we had a process in place to manage the sample testing. This we did as quickly as possible, identifying helper surrogates who knew the process and had DNA swabs to send out for Europe, UK and South America. By the beginning of June 2016 word went out worldwide that a DNA test had been found and testing began immediately with Legends, Sandypaws and DestineeZ being the first to participate. MAC DNA testing has been added as an optional test on CHIC. Clear by Parentage still remains problematic for the CHIC program but is recognized. As a result of our leadership managing the MAC project, we have been able to identify promising collaboration for PRA Research in Europe and have begun work to establish solid contacts with non-US Health Committees and similar organizations. Our global outreach has been reciprocated and we have received financial and volunteer support in our MAC DNA project from several European Clubs as well as appreciation for our efforts. We have not had as much success with our Russian Miniature Schnauzer breeders despite earnest efforts. We will continue to reach out to anyone needing support and assistance to take advantage of this testing. So far the AMSC Health Committee has distributed Over 1400 swabs and we have received 210 results of which 14 are carriers. This is closely comparable to what Dr Giger's data has shown in the past. He will review the complete dataset at MCKC. We were able to identify the Lola case sire which only furthered support for the accuracy of the test. We would like to give special thanks to Brenda Fishburn for her assistance and cooperation in helping to identify the Sire of Lola.

**SUMMARY**

1. The AMSC Health Committee policy was rewritten, submitted and approved by the Board with corrections. An additional section was suggested for Record Storage and is a top priority project for this upcoming year. As part of this project, our Progeny Software program is being reevaluated for its

usefulness to accommodate record storage requirements and solve data retrieval issues. Since whatever we will use will be pivotal in any Record Storage policy statement, the HC database has to be nailed down first. Past use/access by a single individual is not appropriate and must not be permitted. Estimates for a web-based 5-User license is far too expensive (\$2500/Annually) and we are now looking at alternatives and have requested possible solutions from the vendor to reduce recurring costs. A subgroup will be developing a plan to use that will afford analysis and retrieval. Our current system is virtually unusable for meaningful analysis.

2. We are attempting to catalogue all AMSC Health Information projects from CJC, PRA, Cataract, etc. Narrative summaries of specifics of the program and program development and administration are being developed with project coordinators. This will serve to document health issues that have occurred in the Breed and will provide a rich history for future use. How this information is archived will largely impact record storage and retrieval plans.

3. There has been an additional case of PRA reported from UK not previously included in any report from the Health Committee, Jaxman's Moves Like Jagger, a 4-year-old, with US lineage. Pedigree available upon request. We are establishing a collaboration with Drs Maria Kaukonen and Hannes Lohi at Helsinki University in Finland for PRA research and have been given access to the complete (1990-2016) list of PRA affecteds from the Finnish Database <http://jalostus.kennelliitto.fi/frmkoirat.aspx?TK=13&TA=162&VuosiA=1990&VuosiY=2016>. While disclosure is not mandatory in Finland, the breeders recognize the benefit to a central open registry and fully participate for the benefit of the Breed.

MAC DNA testing is continuing to grow primarily outside the US. We have helped to coordinate a Skype meeting between Dr. Giger and several European clubs whose breeders are meeting in September. The Danish MS Club is reimbursing every breeder \$50 for each DNA test they perform. In addition, Swedish, Norwegian & Danish clubs have now assumed full responsibility for obtaining swabs for European requestors. The MAC DNA project has helped to significantly open the communication between the AMSC and Non US Miniature Schnauzer clubs.

We received a donation to the Health Fund of \$275.00 and a \$255 donation to offset MAC project mailings. At the date of this report, the Health Committee remains well below its

projected budget despite unplanned expenses resulting from MAC DNA testing.

We are in the process of LOOKING INTO the possibility of establishing a non-profit Health Trust for the Health Committee whereby members or interested individuals can make donations which will have tax advantage for them as individuals. This will be patterned after the Non-Profits which have been set up for other larger kennel clubs. I have asked Sharon Edwards to help us get this started to investigate the possibilities which will be presented to the Board for their approval or further discussion as to how this might best be used for our club. The discussion of a Non-profit foundation was tabled.

A motion was made by Patty Ledgerwood, seconded by Bonnie Keyes to have Vicki Kubic a donation button on the AMSC health webpage if anyone is interested in donating to any health committee projects. She will also install one on the future AMSCare page and rescue page. Motion passed unanimously.

The AMSC Health Committee Code of Ethics & Conduct was approved. The motion was made by Patty Ledgerwood and seconded by Amy Gordon. Motion passed unanimously. Upon approval by the Board, all members of the committee, including the President are required to re-sign the committee Code of Ethics.

**AMSC Health Committee Code of Ethics & Conduct**

Membership on the AMSC Health Committee (AMSC HC) is by specific appointment and is a unique and honored position of all the committees in the organization because of the nature of the work and the standard of conduct set for all members. The AMSC HC is the central repository of sensitive and, oftentimes, confidential health information within the American Miniature Schnauzer Club. Thus, the AMSC Health Committee member has access to highly private, sensitive and confidential information concerning breeding programs. The protection of this information is paramount and access to this information is crucial for a productive and successful health committee. As a member, each individual is required to sign this oath of behavior and confidentiality and referred to the AMSC Health Committee Code of Ethics & Conduct, in addition to what is required as an active AMSC member. In so signing, members must adhere to the highest standards of interaction and conduct and must behave in a manner that serves to credit the position held and to leave NO perception that inappropriate disclosures are occurring. Any infringement of ANY AMSC HC member will

be presented to the Health Committee by one of its members and thoroughly investigated by the Health Committee under the guidance and oversight of the President of the AMSC; facts will be presented and, if substantiated, recommendations for action (to include expulsion from the AMSC under constitutional guidelines) will be made to the full Board. Any breach of confidentiality will not be tolerated and information received by a Health Committee member as an individual or as a collective group will be deemed confidential and subject to disciplinary action beyond an individual's membership/tenure on the committee

Confidential information received by any member of the Health Committee from any member or non-member regarding Health matters will become the property of the AMSC Health Committee. (NOTE: Exempted in this pledge is the veterinarian patient-client information) Information will be shared with the entire committee or not accepted. At no time will information be held by one member and one member solely.

Project assignments for committee members will require all communication to be shared either in summary when verbal or as copies of email correspondence to and from the Health Committee member. Every member will strive to ensure that ALL members will be as informed regarding any project as the member who is specifically assigned. There will be no member who is singularly privy to information or communication regarding a committee directed project.

There will be no discussion among members in a public environment where it can be misconstrued to be an infringement of confidential information. "Curbside Consults" are not excluded.

There will be NO personal feelings or references to personalities included in discussion of any issue on Health Committee email. We will deal only with content of discussion/opposing opinion as it pertains to Health and leave personalities out of the discussion. Every member is expected to moderate the discussion and conversation to maintain focus on the content and mission of the AMSC Health Committee. Discussions will be respectful at all times –differences of opinion are encouraged but discussion will be presented in a strictly factual and non-emotional way.

Protection of Confidential information gained while a member of the Health Committee will extend beyond membership and will be subject to disciplinary action.

The Health Committee member recognizes and acknowledges that the AMSC Health Committee possesses certain confidential information that constitutes a valuable, special and unique asset of the Health Committee and the AMSC. Confidential information is defined as any information received while a member of the Health Committee which includes ALL information and materials and files belonging to and used by and in possession of the Health Committee related to its purpose and existence. To the extent any inventions, technologies, reports, memoranda, studies, writings, articles, plans, designs, specifications, exhibits, media or other materials are prepared by the member during his/her tenure on the committee, these shall be deemed property of the Health Committee. ALL documents, magnetically or optically encoded media, and other tangible materials created and maintained while a member of the Health Committee as part of the services of the Health Committee shall be owned by the AMSC Health Committee and will be turned over to the Health Committee or the President, AMSC, within 2 weeks of termination of membership. In addition, all materials as described above, either in hard copy or residing on electronic storage and computer devices belonging to any individual no longer a member of the Health Committee, will be removed upon termination of membership.

The AMSC Health Committee member agrees that upon termination of membership all materials as described above will be returned in total to the AMSC Health Committee. Confidential information is not excluded. The following AMSC Health Committee member acknowledges and agrees fully with this AMSC Health Committee Code of Ethics and Conduct statement and will abide by its tenets:

## Understanding Your Dog's Fear of Thunderstorms

Watching your dog suffer through a thunder-  
storm is almost as terrible for you as it is for  
them. You want to tell them that everything is  
ok and that there's nothing to be afraid of...but  
how? Understanding our dogs' fear of thun-  
derstorms is the first step toward comforting  
them in their time of need.

Does my dog have an anxiety problem?

Not necessarily. This deep-seeded fear is so  
prevalent in canines, experts estimate that over  
40% of all domestic dogs share it. The Merck  
Veterinary Manual defines a noise phobia as a  
"Sudden and profound, non-graded, extreme  
response to noise" which the animal manifests  
"as intense, active avoidance, escape, or anxi-  
ety behaviors." Destructiveness, excessive  
salivation, excessive vocalization, hiding, in-  
appropriate elimination, remaining near the  
owner, pacing, panting, self-trauma, and trem-  
bling are all common symptoms of a noise  
phobia.

But why is my dog so afraid?

There are a few of different factors at play. First,  
there's the obvious noise. An incredibly loud,  
booming sound is as terrifying to dogs as it is  
to little kids—actually more so, due to their sen-  
sitive ears. Secondly, thunder has frequencies  
above and below our own human hearing. To  
dogs, the sound signifies an imminent threat  
of enormous proportions. There's another  
theory that suggests the build-up of static elec-  
tricity and shock is also an additional cause of  
fear. It is thought that dogs hide in bathtubs  
and against toilet bowls to sooth the electricity  
they feel in their bodies using the grounded  
porcelain fixtures.

What can I do about it?

First, ignore your human instincts. Cuddling  
and comforting a fearful dog is the same as  
encouraging the behavior. Dogs may take your  
actions as a reinforcement of their fears, or  
learn that giving in to their anxieties earns them  
a positive reaction from you.

Below is a list of tried and true methods that  
may help calm your dog in the moment.

1. Allow them to hide without getting angry or  
emotional.
2. Give them a safe, comfortable  
spot to retreat and calm down.
3. Stay calm  
yourself.
4. Drown out the noise with relaxing  
classical music.
5. Administer a calming aid  
such Rescue Remedy.
6. Rub them with dryer  
sheets to eliminate static electricity.
7. Try using  
ThunderShirt or tight-fitting dog garment  
to help them feel safe.

Whatever you do, don't force it. These tech-  
niques are intended to eliminate stress, not  
add to it. Listen to your dog and take cues from  
his behavior. Just like humans, sometimes all  
your dog wants is to be left alone while they  
ride out the storm.

## The Do's and Don'ts For Happy Howlidays

Keep your little elf happy and healthy all season  
long with these easy-to-follow holiday Do's and  
Dont's.

Do puppy-proof your tree. Low-hanging orna-  
ments, strings of lights, and sticky pine needles  
all look like fun new treats to a curious dog. To  
avoid intestinal blockages, punctures, and other  
dangerous injuries, keep your tree in an out-of-  
the-way area and focus your most tempting deco-  
rations on the tree's upper branches. For the tree's  
bottom branches, try strings of bells. The cheer-  
ful chimes will alert you when your naughty pup is  
up to no good!

Don't decorate with seasonal plants. Bad news  
for holiday botanists. Poinsettias, holly, and mistle-  
toe are all toxic to dogs and cats. If someone gives  
you one of these live plants, keep it far out of reach  
of your pet and beware of falling leaves. Check  
your plants for signs of chewing and, if ingestion  
occurs, call your vet asap!

Do tire him out. Releasing anxiety and energy  
through a long walk or jog is a must before a big  
event. Some pet owners who live in very cold cli-  
mates even invest in specially designed treadmills  
in order to allow their dogs to jog out the stress on  
a frigid day.

Don't force him to socialize. Everyone loves your  
dog, but too much attention can be overwhelming  
for him. Never force your fur child to give kisses,  
do tricks, or cuddle with relatives and friends.  
Dogs, unlike humans, process the stress hor-  
mone cortisol very slowly. This means that a se-  
ries of small stressors can cause an excessive  
buildup in their system. The result of too much  
cortisol is sometimes anxiety or aggression.

Do give him an escape plan. Watch for physical  
signals that you dog may need a break. Bring a  
comfy crate with you while traveling and allow your  
dog to retreat into his "cave" whenever he needs  
to. Knowing that he has a safe place to hide away  
from the crowd will give your dog the peace of  
mind he needs to endure the hectic holiday sea-  
son.

Don't let family members sneak food under the  
table. We all have one well-meaning relative who  
wants to be Fido's favorite, but don't let your guests  
guilt you into making your dog sick. Get ahead of  
an awkward dinner conversation by explaining  
beforehand that everyday human food can cause  
serious damage. Cooked turkey bones can splin-  
ter, large food items can cause intestinal block-  
ages, and onions, garlic, raisins, and chocolate  
can all be toxic.

Do stay calm. With holiday joy, comes holiday  
stress. But, if you're overly anxious about family  
members visiting, last minute gifts, and holiday  
travel, your dog will be too. Staying calm and  
happy is the best way to help your four-legged  
friend deal with the changes to his daily routine.  
When you lead by example and keep these tips in  
mind, your holiday season will be merry and bright.

# American Miniature Schnauzer Club

All members agree to abide by the American Miniature Schnauzer Club's [Constitution and Bylaws](#), the [Code of Ethics](#) of the AMSC and the [Rules and Regulations](#) of the American Kennel Club and the precepts of good Sportsmanship.

## CODE OF ETHICS

### PREAMBLE

This Code of Ethics serves as a guide for members of the American Miniature Schnauzer Club to follow, recognizing their role as guardians of the breed, and having a common interest in the protection of the AMSC and the well-being of the breed and of the individual dogs that members own and produce in their breeding programs. Implicit in membership in the American Miniature Schnauzer Club is the understanding and full acceptance of the Code of Ethics recognizing that a violation(s) or blatant disregard for the Constitution and Bylaws, Code of Ethics and AKC Rules and Regulations may result in discipline as authorized by the Bylaws and Constitution up to and including suspension of your AMSC membership or expulsion from the AMSC.

### GENERAL CONDUCT

Members of the American Miniature Schnauzer Club will:

1. Comply with the Rules and Regulations of the American Kennel Club (AKC), the Constitution and By-laws of the American Miniature Schnauzer Club (AMSC) and the Code of Ethics.
2. Conduct themselves in a manner that reflects positively on themselves, the breed, and the AMSC, the board and committees of the AMSC
3. Exhibit good sportsmanship and good will at all dog-related events in accordance with the AKC precepts of good Sportsmanship. Winning and losing with grace is the minimum standard of good sportsmanship and all forms of competition. Good sportsmanship and general civility are consistent. The interaction of fair play, honesty, courtesy, and vigorous competition are essential in every aspect of AMSC membership, whether inside or outside of the ring. It is not simply a goal for the AMSC member, it is a requirement.
4. Make no false or misleading statements concerning the Miniature Schnauzer breed or other breeds or breeders.
5. Refrain from the use of any slanderous or defaming statements or innuendo against another breeder, a specific dog/kennel, the AMSC and Judges, etc. on any public forum including social media. Use of social media to disparage the AMSC or any AMSC member will be viewed as an overt act prejudicial to the breed and the AMSC and will not be tolerated.
6. Be responsible dog owners, treating their dogs humanely and providing them with

adequate food, water, shelter, veterinary care, exercise, grooming and the socialization and training necessary for them to be good family companions.

7. Make every effort to learn about the structure, anatomy, action, inherited traits and behavior of the dog, especially where such learning applies to the Miniature Schnauzer.

8. Use the official standard of the breed when evaluating and breeding their own stock, and encourage its application in judging when appropriate.

9. Participate in efforts to assess and improve the health of the individual dog and of the Miniature Schnauzer breed, including, but not limited to, participation in valid, reliable and responsible testing for hereditary diseases, providing samples and information for development of hereditary disease tests, and sharing health information with other AMSC members. Be honest, factual and not misleading or fraudulent in any written or oral statement about dogs and breeding programs, whether about their own dogs or those of others.

### BREEDING

Members of the American Miniature Schnauzer Club, as guardians of the breed, strive to breed conscientiously, taking responsibility for the lives they produce, including responsible placement of all puppies produced by any breeding, to ensure the safety and well-being of the individual dogs and of the breed.

Accordingly, members of the American Miniature Schnauzer Club will:

1. Educate themselves to recognize the correct conformation of the Miniature Schnauzer, familiarizing themselves with the AKC breed standard and representative dogs, prior to breeding a stud dog or a brood bitch.
2. At all times breed for the improvement of the breed as exemplified by the AKC standard.
3. Breed only animals that are in good health and who are physically and temperamentally sound.
4. Strive to produce puppies of such quality that they will serve to improve and complement the breed and avoid breeding individual Miniature Schnauzers known to have, or are strongly suspected of having, a

serious inherited disease or defect that will likely be passed on to offspring and that, if inherited, would significantly affect the quality of life of any offspring that would be produced.

5. Represent each puppy sold as accurately as possible.

6. Share information gained through breeding with other Miniature Schnauzer owners.

7. Act as a mentor to persons with whom they place puppies and encourage an open dialog for the life of the dog.

### Members of the American Miniature Schnauzer Club will:

1. Sell each puppy or adult with a written health guarantee, a three-generation pedigree, a record of immunizations, care and feeding instructions, and registration papers where applicable.
  2. Inform the buyer of the characteristics of Miniature Schnauzers, and make available to the novice the benefit of his advice and experience.
  3. Sell any companion puppy or companion adult having a known hereditary health defect only with a Limited Registration and Spay/Neuter Contract.
  4. The breeder will not sell or dispose of any dog through wholesalers, commercial dealers or a broker.
- If a puppy is sold as a companion animal, it may be sold one of two ways:

1. On a Limited Registration.
2. On a Spay/Neuter Contract between the breeder and the buyer.

The breeder shall remain responsible for the welfare of every dog he breeds, sells or places. This means making himself available to aid the new owner if and when the need presents itself. If in the future the owner is not able to keep the dog, the owner should be instructed to contact the seller and the seller will have the responsibility either to take the dog back or find it a new home.

### HERITABLE DISEASES/CONDITIONS

Members of the American Miniature Schnauzer Club will:

1. Make a determined effort to have all breeding animals tested for the presence of all heritable diseases or conditions known to afflict Miniature Schnauzers and not breed those discovered to be affected.
2. Send a report of the adverse test results to the AMSC Health Committee.
