## Who Will Care for Your Pet After You're Gone?

Sadly, an estimated half million dogs and cats are euthanized each year after their owners pass away with no provisions made for their pet.

What would become of your dog, cat, bird or other companion if something happened to you?

I realize this isn't a pleasant thing to think about, but it's actually not complicated to make arrangements for your pet in the event you're no longer able to care for her.

And the peace of mind you'll receive from setting everything up ahead of time will be well worth the effort.

### Planning for Pet Care in the Event of Your Death

Your will or testament is one vehicle by which you can legally arrange for the care of your companion animal in the event of your death.

One or more people who agree to take responsibility for your pet are named in the document, along with any assets you want to leave to that person to help with the expense of caring for the animal.

You can also leave your pet with one person and the money to another person, with instructions for reimbursing the new owner for pet-related expenses.

Unfortunately, wills are not handled immediately upon the person's death, and settlements can sometimes be dragged out for years.

To make matters even more complicated, specific instructions for a pet's care contained in a will are not enforceable, nor does a will allow for disbursement of monies over the remaining lifetime of the animal.

So including pet care in your will is only a first step. You'll also need a legal document called a pet trust to make further, specific provisions for your animal.

### Pet Trusts

There are different types of pet trusts to consider.

A traditional pet trust gives you a great deal

of control of your pet's care after your death. You can specify, for example:

- The person who will handle the finances for your pet (the trustee)
- The new owner (caretaker/beneficiary)
- What expenses the trustee will reimburse to the caretaker
- The type of care your pet will receive
- What will happen in the event the caretaker you specify can no longer keep the animal

This type of trust is legal in all 50 states in the U.S.

Another type of trust is the statutory or honorary pet trust, which is in effect while you're alive as well as upon your death. This type of trust controls how monies are disbursed, including prior to your death if you choose. A statutory trust provides more flexibility than a traditional trust and is the simplest to do, especially if you already know who your pet's caretaker will be after your death, and that person is aware of and agrees with your wishes. Only a handful of states do not recognize the statutory pet trust.

A third type of trust is a revocable living trust, which avoids probate after your death. The benefit of this type of trust is it can eliminate the majority of disputes and challenges to a standard will.

### The Importance of Preparing

#### Legal Documents

It's really important to assign ownership of your pet in your will or a trust.

Otherwise, your four-legged family member will automatically go to your residuary beneficiary (the person or persons who'll receive everything not assigned in your final legal documents).

If you have no will or trust upon your death, your pet will go to your next of kin.

When you adopted or purchased your pet, did you sign a contract agreeing to re-

turn the animal to the breeder, shelter, or some other entity in the event you can no longer keep your pet? If so, it's a good idea to attach those documents to your will or trust and give a copy to your assigned pet caretaker as well so everyone who may need the information has it. (Breeders and shelters are only interested in insuring your pet isn't abandoned. As long as you've provided for the animal in a will or trust, it will satisfy their requirements.)

An option for paying for future health care for your companion animal is to make a separate arrangement with your vet. Depending on how you feel about your DVM, you can leave money with her, or you can draw up a contract and leave a credit on your account for expected future services your pet may need.

Another option is to purchase pet health care insurance and then designate funds to keep the policy in place after your death.

### Who Will Care for My Pet When I No Longer Can?

Certainly this is the most important question of them all. And you know better than anyone who would be the best person to take on responsibility for your pet when the time comes. Give the subject careful thought, because it's possible the people you feel closest to are not the best choice for pet owners.

Not everyone is a 'pet person' – perhaps not even your best friend or your own child or grandchild. Think about how you want your pet to be provided for after you're gone, and then think about who you know with the time, energy and other resources necessary to care for your pet as you would.

Some people don't have the time available to properly care for a pet. Others have too many obligations already or are too busy with careers, child rearing, etc. Perhaps you want your furry best friend to continue eating a raw diet or receiving chiropractic care. Does the caretaker you have in mind share your overall pet care philosophy?

When you decide on someone, then repeat the process all over again and come up with a backup caretaker.

You and your identified caretaker(s) should discuss your plans at length, and it's a very good idea to have the future owner's name, contact information and your pet's

care plan in writing. Make sure the caretaker has a copy, close family members, people who visit you regularly, and/or a neighbor you're friendly with. Consider leaving a copy of the document in a conspicuous spot in your home as well.

This will help to prevent a situation in which your pet is relinquished to a shelter because no one realized a plan was in place.

If there is no one you feel would be appropriate to care for your pet, there are fostering options which can provide a temporary home for your pet until a new owner can be found. These include:

- The breeder or shelter you bought or adopted your pet from
- A breed or other rescue organization
- Your local animal shelter
- Your veterinarian

Obviously you'll need to make arrangements ahead of time with one or more of these organizations to take charge of your pet when the time comes, and a method for notifying them immediately.

### Ways to Fund Future Pet Care

You can use cash, life insurance, stocks, bonds, annuities and assets like your home or car to provide funding for your pet, and there are various ways to make the funds accessible to your pet's caretaker after your death.

For example, if you have a living trust you can transfer cash or other assets into it yourself. You can also name your trust as beneficiary of your life insurance policy.

I recommend you talk with an attorney or other qualified professional about how to fund your pet's financial future and the proper way to go about it based on your individual financial situation.

## IMPORTANT: ACTION NEEDED

This goes to the USDA & APHIS, nothing to do with your Senators. This is Federal and is entirely a different system of regulation than whatever your State or City does locally.

It is vital that we share with APHIS the issues with their proposed regulations — somewhere, they've gotten the idea that their little rules will only affect 900 people across the country.... not even close to reality!

What is APHIS proposing? APHIS is proposing to revise its definition of "retail pet store" to close a loophole that has in some cases threatened the health of pets sold sight unseen over the Internet and via phone- and mailbased businesses. Under the current definition of "retail pet store," which was developed over 40 years ago and predates the Internet, some breeders selling pets are taking advantage of a loophole that improperly exempts them from meeting the basic requirements of the Animal Welfare Act.

The proposed rule will close this loophole, ensuring that animals sold over the Internet and via phone- and mail-based businesses are better monitored for their overall health and humane treatment. The proposal will restore the definition to its original intent so that it limits the retail pet store exemption to only business and residences:

- where buyers physically enter to observe the animals available for sale prior to purchasing them, and
  - where only the following animals are sold or offered for sale at retail for use as pets: Dogs, cats, rabbits, guinea pigs, hamsters, gerbils, rats, mice, gophers, chinchilla, domestic ferrets, domestic farm animals, birds, and coldblooded species.
- APHIS is also proposing to increase the number of breeding females from three to four that small hobby breeders can own and still be exempt from licensing requirements. To meet the exemption requirements, these breeders can only sell the offspring of the breeding females that were born and raised on their premises, and sold for only pets or exhibition.

Why does APHIS want to change this rule? This proposed rule is intended to help ensure that consumers will be purchasing healthy animals for pets. The current definition of "retail pet store" was written in the 1970s to exempt from federal regulation traditional pet stores and other facilities whose animals are subject to a certain degree of oversight from customers who enter their shop. Today, the Internet

allows retailers to sell animals directly to the public sight-unseen. Because the current definition is broadly defined, those retailers continue to qualify for exemption, even though they don't meet the intent of the definition. As a result, some buyers have received animals with a contagious disease, general illness, genetic deformities or other medical and social issues. Some of these buyers also received animals that were too young to be weaned.

APHIS wants to restore the original intent of the Animal Welfare Act and modernize its regulations to reflect today's business practices. The change to the small hobby breeder licensing exemption will increase the number of breeding females from three to four. This will allow us to focus more on the facilities that present the greatest risk of noncompliance with the regulations.

How will this affect retail pet stores? This proposed rule would not affect traditional retail pet stores, breeders, and other dealers whose buyers physically enter the premises. They will continue to be exempt from licensing and inspection under the Animal Welfare Act. However, they will still be subject to any applicable individual state and county regulations.

How will this affect Internet, phone- and mailorder retailers?

The proposal will affect these retailers if they currently sell their pet animals to buyers sight-unseen. Pet animal retailers will have a choice. They can either sell their animals to buyers who physically enter their store to visibly observe the animals available for sale, or they can obtain a license under the Animal Welfare Act and allow APHIS inspectors to inspect their facility.

What will this mean for consumers? The changes will help protect consumers. Under the proposed rule, no dog or other pet animal will be sold at retail without either public or APHIS oversight. What is the Animal Welfare Act? The Animal Welfare Act sets standards for humane care and treatment that must be provided for certain animals that are bred for commercial sale; exhibited to the public; used in biomedical research; or transported commercially. The act does not apply to cold-blooded animals or agricultural animals used for food or fiber. Individuals and entities licensed under the Animal Welfare Act must provide their animals with adequate housing, sanitation, nutrition, water and veterinary care. They must also protect the animals from extreme

weather and temperatures.

What does a proposed rule mean? APHIS has issued this proposed rule as part of its rulemaking process. It is just a proposal, issued for public review and comment. It has no immediate effect on potentially regulated facilities. What is the next step in the rulemaking process?

The proposed rule is available for public review and comment for the next 30 days. Once the comment period closes, APHIS will consider all comments received. How can I comment on this proposal? To comment on this proposal, you can submit your comments one of two ways:

House training puppies in crates is effective and humane just as putting dogs in crates for travel is safer than letting them loose or crating them at night to sleep. Think about your name being placed on a State or Federal list for animal abuse because you were given acitation for keeping your dog in a crate. That is a possibility if PETA and HSUS get their way here in the USA. They are pushing for State and Federal government to list all people convicted of animal abuse. The same principle as sex offenders.

Some of you will say no way that could happen. But remember PETA's mission in the animal rights world is to shock and do the ridiculous so that people (who have little or no knowledge on animals) start thinking that maybe there *is* something to whatever it is they are preaching. PETA was the first to introduce to the public that fishing was cruel. At first people just laughed and paid no attention. Within 5 years they had convinced many people around the world that it *is* cruel. PETA's strategy with crating will be to take their time and let the idea settle in people's minds. Lots of ridiculous stunts and the media will give them coverage. Then, once the movement starts, HSUS will jump on the band wagon and take the campaign up a notch. It is the way they work.

## Stop Theft – Tips to Safeguard Your Pet

What steps can be taken to ensure your beloved pet is not a victim of dog theft? PetParnters, Inc., the provider of the AKC Pet Healthcare Plan asked the AKC Companion Animal Recovery for tips on how to safeguard your pet. Listed below are tips to keep your pet safe.

### In Your Neighborhood

- Don't let your dog off-leash – Keeping your dog close to you reduces the likelihood it will wander off and catch the attention of thieves.
- Don't leave your dog unattended in your yard – Dogs left outdoors for long periods of time are targets, especially if your fenced-in yard is visible from the street.
- Be cautious with information – If strangers approach you to admire your dog during walks, don't answer questions about how much the dog cost or give details about where you live.

### On the Road

- Never leave your dog in an unattended car, even if it's locked – Besides the obvious health risks this poses to the dog, it's also an invitation for thieves, even if you are gone for only a moment. Leaving expensive items in the car such as a GPS unit or laptop will only encourage break-ins and possibly allow the dog to escape, even if the thieves don't decide to steal it too.
- Don't tie your dog outside a store – This popular practice among city-dwell-

ing dog owners can be a recipe for disaster. If you need to go shopping, patronize only dog-friendly retailers or leave the dog at home.

In the event that your dog does end up missing, listed below are steps you can take to recover your dog.

- Protect your dog with microchip identification – Collars and tags can be removed so make sure you have permanent ID with a [microchip](http://www.akccar.org). Thieves will not know the dog has a microchip until a veterinarian or shelter worker scans it so keep contact information current with your microchip recovery service provider. For more information, enroll your pet in a 24-hour recovery service and sign-up at [www.akccar.org](http://www.akccar.org).

If you suspect your dog has been stolen – Immediately call the police / animal control officer in the area your pet was last seen and file a police report. If your dog has a microchip, ask to have that unique serial number, along with the dog's description, posted in the "stolen article" category on the National Crime Information Center.

Canvass the neighborhood – Talk to people in the immediate vicinity where your pet went missing for possible sightings of the actual theft.

- Have fliers with a recent photo

ready to go if your dog goes missing – Keep several current photos (profile and headshot) of your dog in your wallet or on an easily accessible web account so that you can distribute immediately if your pet goes missing.

- Contact the media – Call the local TV station, radio station and newspaper and ask to have a web post put out about your missing pet.
