COVER STORY Call it puppy love

The kindness of strangers and a Chesapeake veterinarian recently saved the life of a miniature schnauzer named Belle, the best friend of a seriously ill and frail child. Hannah Winters, the 6-year-old daughter of a Navy family in Virginia Beach, underwent a double-lung transplant when she was just 1 due to the ravages of a severe lung disease. The kindergartner must take anti-rejection medicines to keep her body from rejecting the new organs, but their strength has laid waste to her kidneys, reducing them to 10 percent capacity. She now needs a kidney transplant. Because of her weakness and deafness, Hannah can't go out and rough and tumble with peers at Corporate Landing Elementary School. That's what made the gift of Belle so special, and why they became best friends. "She's not around a lot of children," said Amber Winters, whose husband is stationed aboard the Oak Hill, a dock landing ship homeport-

Thanks to the kindness of strangers and a Chesapeake veterinarian, a miniature schnauzer named Belle is healthy again. And she's back to being best buddies with 6-year-old Hannah Winters, who has been ill with lung and kidney problems.

Four years ago, the family met up with a dog breeder in Taylorville, Ill., who had puppies for sale. The Winters thought a small schnauzer would make a fuzzy sibling for Hannah. Winters said she never mentioned Hannah's condition, but on the day they picked up Belle, the breeder found out. was diagnosed with bladder stones and needed an operation as soon as possible. "She was one sick little dog," Winters recalled. The veterinarian said the surgery would cost \$1,000 to \$1,200. Winters knew there was no way they could afford the canine operation. "Now, all our money is tied up in Hannah," Amber Winters said. "But we sure didn't want Belle to get any sicker. She's part of our family."

Winters said the doctor would be willing to do the operation on a pro bono basis but the family had to sign the dog over to him so he could offer Belle to another family. That was unacceptable.

"When he (the veterinarian) told me this, I broke down in his office," Winters said. "I told him we didn't want to lose our dog; we want her home with Hannah. I just felt there was nothing there, no compassion. Well, at least

they gave us the option not to put Belle down, I guess."

Despondent, Winters discussed the situation with her aunt in Indiana, Theresa Humichrous, who went online looking for help. She discovered the American Miniature Schnauzer Club and its national rescue chairman, Michele Smith.

"The aunt called me and wanted to know if we could help with the finances," Smith recalled from her Highland Park, Ill., home. "Unfortunately, we're not funded to do that, but I told her I'd see if I could find help." Smith then contacted a New Jersey schnauzer rescue, which led to Marcella Beard in Suffolk.

duper breed, but she's cute as a button, and she's that girl's dog. That was enough."

Beard contacted her own veterinarian, Dr. Geoffrey Campbell, who recently opened his own practice, Edinburgh Animal Hospital, in Hickory.

The story touched Campbell's heart. "I have a 5-year-old daughter, and I could think of something like that happening to her," Campbell said. "I grew up in a Navy family and with the dad out to sea, I could relate to that as well. It sounded like it had gone round and round with their original vet. I heard the choices they had and couldn't think of them losing their dog, not with all they've been through."

[Michele originally contacted New Jersey Schnauzer Rescue Network about the problem with this dog, thinking that NJSRN still covered VA (limited resources caused NJSRN to narrow the area of coverage). Sherri Ruschmeyer, a long-time member of NJSRN, picked up Michele's message and relayed the information to the group. Marcella had been a member of NJSRN back in the days when NJSRN covered Virginia, and still does rescue in the Virginia Beach area and would want to help. So Sherri suggested to Michele that she contact Marcella.]

Beard, a member of the AMSC agreed immediately to get involved. "She's the type of little girl you'd do anything for," Beard said about Hannah. "And her dog, a white miniature schnauzer, is really no show dog or a super-

He agreed to perform Belle's surgery Feb. 6 for free.

She was reunited with Hannah a few days later. Winters said Belle's doing great, adding, "She seems like a different dog." And she can't thank Campbell enough for his kindness – as well as her new friends in the schnauzer club.

Belle requires special dog food, and club members have agreed to pick up the bill for as long as needed.

With Belle home and in good health, things are a bit brighter at the Winters' home. "She and Hannah are driving me nuts again," mom said last week. "Belle's at my feet and Hannah's smiling, pulling Belle's ears."

Report Of The AKC Delegate: Don Farley

At the December Delegates Meeting, the following business was addressed:

1. There are four vacancies to be filled on the AKC Board – one for 2010 and three for 2012. These will be voted on at the March Delegates Meeting.

Nominations for AKC Board members are:

The Class of 2010: Dr. Carmen L. Battaglia, representing the German Shepherd Dog Club of America. Dr. Fred C. Bock, representing the Key City Kennel Club was nominated as an additional candidate by petition.

The Class of 2012: Dr. Thomas M. Davies, representing the Springfield Kennel Club; Walter F. Goodman, representing the Skye Terrier Club of America and Ronald H. Menaker, representing the Rockford-Freeport, Illinois Kennel Club.

Each nominee was given three minutes to speak to their qualifications. Anyone who would like the text of their speeches can contact me and I'll extract it from the meeting transcript. The only contest is for the one vacancy for the class of 2010. It is between Dr. Battaglia and Dr. Bock. The Board vote instructed the AKC Delegate to vote for Dr. Battaglia.

- 2. The amendment eliminating term limits for Board members did not pass. Term limits are still in place.
- 3. The Amateur Owner-Handler Class was approved, and the Novice class will be retained.

- 4. The delegates also voted to allow the removal of any delegate who was convicted of a felony for stealing, embezzling, or misappropriation of funds or property from and AKC sanctioned club. Two paragraphs were added to Article VI, Section 5
- 5. The proposal to allow a Board member who was no longer a delegate to server out their term was amended. The rules now read:

"If a Director shall be removed as a Delegate prior to August 1, of any year, he/she may only be continued by the Board until the next annual meeting.

"If a Director shall be removed from that position after August 1, and he/she has more than one year remaining on his/her term, he/she may be continued for a period of six months. If at the end of this six-month period, he/she has been approved as a Delegate, the Board may vote to continue him/her on the Board."

At the March meeting we will be voting on the AKC Board nominees. The other item being voted on at the March meeting is to allow changing a dog's name under certain conditions which will not affect the stud book or event records. This is the proposed wording of the change, new wording underlined:

Chapter 3, Section 7. The name of a dog registered with The American Kennel Club will be allowed to be changed provided the dog was whelped in the United States and in cases where the breeder(s) first individually registered the dog, their written consent would be required. A dog name containing a Registered Kennel Name cannot be changed without the written consent of the owner(s) of that Registered Kennel Name.

However, no change in the name will be recorded by The American Kennel Club after the dog has produced or sired an AKC registered litter or received an award at an AKC licensed or member event.

Any name change must comply with all AKC

Item 1: Grants Funding Requests for the Canine Health Foundation: The committee received abstracts from the Canine Health Foundation for 25 separate grants in need of funding from parent clubs. While none of these were breed-specific, several involve defects that are reported to affect our breed (see attachment A). The committee reviewed all of these requests and selected those with the greatest significance considering factors such as impact on health and longevity, reported incidence, reproduction, improved diagnostics, better treatment options, and exploration of genetics. Funding for all CHF grants will be provided through our CHF Donor-Advised Fund currently containing \$165,000.00.

Total funding requested for the following 7 grants is \$ 15,291.00, approximately 9% of available funds.

Wyoma Clouss made a motion, seconded by Jinx Gunville to fund the first 3 grants (305, 1003A, 1026A). Motion passed unanimously.

*AKC/CHF Grant # 305 – Histocompatibility Alleles Conferring Susceptibility to Canine Diabetes, Immune-Mediated Thyroiditis, and Immune-Mediated Hemolytic Anemia

(Wayne Potts, PhD, University of Utah)

Requested amount: \$1,780.00
All 3 of these auto-immune diseases affect our breed. Diabetes Mellitus was the 4th most common defect diagnosed in our breed at veterinary teaching hospitals from 1990-2000 (see attachment A) and is often difficult to manage. Hypothyroidism continues to be one of the most commonly diagnosed endocrine disorders in dogs. The goal of this study is to identify those autoimmune diseases having a restricted number of susceptibility alleles, to

enable development of diagnostic tests and to enable the reduction of incidence through selective breeding. (autoimmune/longevity)

*AKC/CHF Grant # 1003A – Variation in Thyroid Hormone Concentration and Thyroglobulin Autoantibody Status with Stage of the Canine Estrus Cycle

(Rebecca Davies, PhD, University of Minnesota) Requested amount: \$1,000.00

Hypothyroidism is a common diagnosis in canines, and is diagnosed based on serum thyroid concentration. Often, dogs with low serum thyroid levels are prescribed medication to manage their thyroid level. Thyroid hormone levels can fluctuate naturally due to an animal's reproductive stage. The goal of this study is to determine whether thyroid hormones and thyroglobulin status are variable in bitches in different phases of their estrus cycle, to improve the accuracy of diagnostic testing in cycling bitches. If a correlation is identified, diagnostic methods will improve, thereby reducing the risk of misdiagnosing cycling bitches and placing them on unnecessary thyroid supplementation. Since thyroid status is also indicated as a factor in reproductive health, improved diagnostics will enable practitioners to eliminate thyroid issues as a cause of infertility in problematic bitches. (reproduction/endocrinology)

*AKC/CHF Grant # 1026A - Molecular Characterization of Valvular Interstitial Cells in Canine Chronic Valvular Degenerative Disease (Allison Heaney, DVM,MS,DACVIM, Washington State University)

R e q u e s t e d amount: \$1,500.00

Mitral Valve Disease (MVD) is the most common acquired heart disease in dogs, resulting in valve leakage and heart failure. According to veterinary cardiologists, Miniature Schnauzers are among the breeds prone to degenerative mitral valve disease. MVD was the 5th most common defect diagnosed in our breed at veterinary teaching hospitals, with heart murmur of unspecified nature the 2nd most common diagnosis (see attachment A). The health committee periodically receives calls from Miniature Schnauzer owners asking why their previously healthy middle-aged dog has developed a heart murmur and mitral valve leakage.

The goal of this study is to determine if there is a difference in the balance of specific collagen regulating proteins in normal and diseases valve cells, which will help target future research in determining the cause of this prevalent disease process.

*AKC/CHF Grant # 779 – Characterization of the Canine Y-Chromosome: Identifying Genes that Cause Male Infertility (William J. Murphy, Texas A&M University) R e q u e s t e d amount: \$5,000.00

This study will characterize the gene content

of the dog Y chromosome in an effort to identify testis-specific genes that play a role in spermatogenesis and to identify specific genes that when defective cause infertility. (reproduction/genetics)

**AKC/CHF Grant # 908 – Serotonin Type 2A Receptor Antagonist Therapy for Preventing the Progression of Myxomatous Mitral Valve Disease

(Mark Oyama, DVM, DACVIM, University of Pennsylvania) R e q u e s t e d amount: \$3000.00

The goal of this study is to investigate a correlation of MVD with heightened activity of the serotonin pathway, to determine serotonin's influence on cells, and to determine if a specific serotonin-blocking drug can slow or reverse progression of naturally occurring MVD in canines. (heart/longevity)

**AKC/CHF Grant # 1031A – Determination of Target Antigens in Canine Primary Immune-Mediated Hemolytic Anemia

(Darren Wood, DVM, DVSc, DACVP, University of Guelph) R e q u e s t e d

amount: \$1,011.00

The goal of this study is to identify if there is a particular protein or set of proteins found in some cells that are targeted by the immune system. Understanding the causes or triggers for IMHA may lead to better treatment for primary disease. (autoimmune)

***AKC/CHF Grant # 851A – The Effect of Physiologic Dexamethasone on Blood Glucose Level in Dogs Following Congenital Portosystemic Shunt Ligation

(Beth Johnson, DVM, University of Tennessee) Requested amount: \$1,000.00

Liver shunts are not uncommon in our breed, and a number of cases have been reported to the health committee in the last 2 years. Surgical closure of a shunt is a viable option for some affected dogs. Post-surgically, over 50% of dogs develop low blood sugar that does not respond the standard treatment. A similar phenomenon has been documented in humans. The goal of this study is to determine if administration of a cortisol-like drug after surgery will effectively prevent low blood sugar, eliminating this treatment complication in dogs. (treatment for congenital defect)

***AKC/CHF Grant # 998A – Microbiology and Histopathological Features of Canine Acral Lick Dermatitis (Amy Shumaker, DVM, Dermatology Clinic for Animals) R e q u e s t e d amount: \$ 1,000.00

Acral lick dermatitis, (a.k.a. lick granuloma), is a common disease in dogs. Successful treatment often requires identification of initial cause and treatment for secondary infection. With the increase in resistant bacteria, traditional treatment methods are likely to fail. The purpose of this study is to better characterize the histopathological and microbiological features

of acral lick dermatitis to increase the options for successful treatment. Breed predispositions will also be studied. (treatment)

Item 2: Update on AKC/CHF Grant 732 – Identification of Mutations Responsible for Hereditary Neurodegenerative Disorders in Dogs. (Matin Katz, PhD, University of Missouri)

The AMSC co-sponsored this study related to investigation of candidate genes for Neuronal Ceroid Lipofuscinosis for our breed and other breeds of dog. The progress report for the end of the first year includes a number of significant findings and the elimination of a number of candidate genes for several breeds. Work is continuing, and samples are being requested from affected dogs of any breed. We have updated the current link to the research on our webpage to include a recommendation from Dr. Katz regarding diagnosis and sample submission from dog owners. Definitive diagnosis of this disorder can only be made post-mortem by examination of brain tissue. Dr. Katz states owners of dogs exhibiting signs similar to NCL having had other possible disorders ruled out should contact his team. They are able to store DNA via a blood sample on a potentially affected dog and then process it at a later date once a postmortem diagnosis of NCL is made. Owners of potentially affected dogs should contact Dr. Katz in advance of euthanasia or death of the dog so samples and tissues can be prepared and submitted properly. For more information on this disorder, clinical signs, and contact information for Dr. Katz please go to www.caninegeneticdiseases.net/CL_site/ mainCL.htm

Item 3: Dedicated Breeder and Researcher Team Up to Investigate Liver Shunts in Our Breed

She's asked that we not identify her at this point, but we want to commend the hard work of a dedicated Miniature Schnauzer breeder. Several months ago she contacted our committee to advise us she was working with a researcher to collect DNA samples and data on liver shunts. She solicited our assistance in developing a genetic pedigree for this work, and we've supported her efforts. At this phase the researcher is not soliciting funding or samples from the breed at large, but if this changes we will advise the membership. Hats Off to a breeder who genuinely cares about the welfare of our breed!

Item 5: AMSC Webpage Updates on Health The following items have been or will be added to the webpage:

- AHT Information outlining their study on eye diseases and providing contact information for members interested in contributing by submitting DNA from affected dogs and relatives. This will be added to the webpage at the eye committee's discretion, pending a decision on how to proceed.
- Valley Fever Article explaining this disease and the current research on treatments.
- Dr. Katz recommendations for owners of dogs potentially affected with NCL.

Item 6: Urinary Committee Report JRD Testing Report/DNA Test - In early December, the Chair of the Urinary committee was contacted by Dr. Whiteley of Dogenes, Inc. to advise that an error had been found in the DNA testing for juvenile renal dysplasia in Miniature Schnauzers. After further investigation and retesting over 100 dogs, Dr. Whiteley informed us of her findings; a) the mutation in Miniature Schnauzers differs from that in other breeds, and is inherited as an autosomal recessive with low penetrance

- b) virtually all Miniature Schnauzers tested are homozygous mutant
- c) a handful of related dogs have tested as "carriers"
- d) no dogs have tested homozyous normal*

*Subsequent to Dr. Whiteley's initial report, an AMSC member has reported one dog has tested homozygous normal.

The Urinary Committee is hoping to obtain more detailed information from Dr. Whitely on the mutation and the revised test as soon as Dr.Sarvas has the opportunity to speak with her. At this point, the committee advises that until we can determine the prevalence of juvenile renal dysplasia in the general Schnauzer population, it is premature to make any recommendations on the usefulness of this test, or the significance of her findings.

To that end, we continue to encourage members who encounter cases of JRD to submit that information to the Urinary Committee, We also plan to make available general information on how to gather and submit wedge biopsies from clinically healthy dogs, for those members who wish to participate. The costs to date of the JRD research to the AMSC have included \$7500.00 in initial funding, and an additional \$1200.00 on kits which

were used for data collection on full litters.

Note: during the original test when initial JRD test results began to show an unexpectedly high ratio of carriers to clear among adult breeding stock, questions arose as to whether unidentified factors were swaying breeders to select carrier dogs over clears when evaluating puppies, or if the ratio was present at birth. It was decided to test three litters of carrier to carrier breedings, in an attempt to shed light on the issue. With the revision of the test, these litter results no longer applied to the original goal of the testing, with all puppies reported to date testing homozygous mutant. The genotype of the parents of these litters using the revised test has not yet been reported to the owners. A complete report will be provided once all data is received.

Item 7: Eye Committee Report

The Eye Committee is waiting for "kits" to be sent from AHT, and has contacted breeders who have reported cases of cataracts to the eye committee to insure their participation. AHT needs DNA from affected dogs, parents of affecteds, and siblings.

The Eye Committee is also looking at ways to participate in the AHT study. We are considering a genetic pedigree for the health committee and collection of DNA. This will allow us to have a complete package of DNA samples and a genetic pedigree ready when additional research opportunities arise. Further the eye committee is looking into ways of insuring confidentiality, so that no participant need worry that information will be divulged on their dogs, without their express written consent. When we reach a decision on how to proceed we will post our recommendations with the AHT article on the webpage.

Item 8: Committee Chairman's Report: Some important changes are in the works for how our committee functions. We are discussing the feasibility of a confidentiality agreement all committee members would need to sign for the AMSC.

We are also currently archiving important resources and non-identifying information such as genetic pedigrees so this information is not lost with turnover of committee members. This also allows us to utilize the various talents of our committee members without compromising confidentiality.

We are examining further research options regarding JRD through the CHF. A primary goal for the Urinary Committee in 2008 is to address Urinary Calculi and disseminate upto-date information. The Eye Committee is investigating a cataract study underway at the Morris Animal Foundation.

The Eye Committee is working on developing a strategic plan to assemble a package of DNA samples and a genetic pedigree for Cataracts,

to facilitate research with the AHT while protecting confidentiality. An added benefit would be a ready-to-go package in the event other research options for cataracts become available. The committee is still developing this plan and more details will be announced soon.

We are also re-examining the CHIC Program and the AKC DNA Repository and will have a recommendation at the next meeting in June. We are determining if this program might be the most viable option for a database for our breed.

And finally,

We would like to thank those who have conquered their fears and worked with us by reporting health issues in their dogs. We understand it takes courage to step up, and we want you to know it really does make a difference for our dogs.




