AMSC Board Meeting

The American Miniature Schnauzer Club October Board Meeting was called to order by President Lanny Hirstein, at 7:10 pm, 231-N McCormick Place, Chicago, IL.

President Lanny Hirstein welcomed everyone to the meeting and asked Terrie Houck to advise the board of the Policy set June 17, 1983, "Voting Procedure at Board Meetings".

Barbara Schulenberg motioned to adopt the agenda. Seconded by Carole Weinberger. Motion passed, 18-0.

The board was asked if there were any corrections to the minutes as published in AMSCOPE. The following corrections were brought to the attention of the board, * The 2006 Roving Specialty will be supported by the Cincinnati and Columbus MS Clubs who will host specialties, at this point it is not known if the Cleveland MS Club will be involved.* The matter concerning Associate Members was a item that was brought up in the general discussion during the finance report. Jerry Kyser did not bring this topic up during his report. Jinx Gunville motioned to accept the minutes to include the changes as discussed, John Constantine seconded the Motion. Motion passed 18-0.

Report of the President: Lanny Hirstein

AVMA vaccine report surprises skeptics

Sandy Spring, Md.-For years Dr. Lorraine Jarboe followed a cookie cutter approach to vaccinations, immunizing dogs with a myriad of annual boosters.

Then the American Veterinary Medical Association's (AVMA) Council on Biologic and Therapeutic Agents (COBTA) published its much-anticipated canine and feline vaccine report. Reading the Nov. 15 Journal of the American Veterinary Medical Association (JAVMA), Jarboe says she's now at ease promoting individualized vaccine protocols. For those once-habitual yearly inoculations, she modifies, pitting patient need against side effects and risk.

"I can feel comfortable vaccinating against diseases like distemper on a case-by-case basis," she says. "I'm really happy. The AVMA finally said something."

'A new era'

What AVMA says is "vaccines are a potent medical procedure associated with benefits and risk." The COBTA report tells practitioners it's OK to buck the tradition of annual vaccinations and consider "exposure probability, susceptibility, severity of disease, efficacy and safety of vaccines, potential public health concerns and owner's preferences" before inoculating. In other words, AVMA stands by a veterinarian's clinical judgment in vaccine decision-making rather than blindly inoculating.

"It's a new era," says Dr. Don Klingborg, former COBTA chair and researcher on the document. "We've come an amazing distance on this. The report brings with it a great opportunity to move forward on the issue of vaccines."

Inside the report


Critics have long debated the efficacy, duration of immunity and necessity of many vaccines, associating annual inoculations with cancer and autoimmune disease. While the COBTA report calls for education and the profession's reduced dependence on vaccine

The American Veterinary Medical Association's recently published vaccine report separates core and noncore vaccines. Core vaccines protect pets against pathogens posing a substantial risk of severe disease in essentially all cats and dogs. Vaccines against diseases of less frequency and risk are considered noncore, which are outlined in Table 2, page 32.

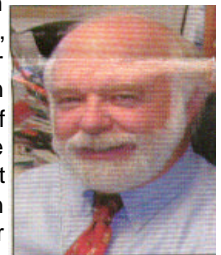
sales, for many veterinarians, it also legitimizes some long-held uncertainties untouched by previous AVMA Principles of Vaccinations reports, which detractors deem vague and useless.

"I'm impressed because this new report really provides a whole new mindset and approach to vaccines," says Dr. Ron Schultz, an immunologist at the University of Wisconsin-Madison School of Veterinary Medicine. At the forefront of vaccine research, Schultz has cautioned against vaccine overuse for more than 30 years. "This is a big step for AVMA. This report is, in fact, not too different from things I've written in my own papers and have personally been striving toward for years."

Changing mindset

Schultz and his colleagues suspect vaccines not only have harmful side effects, they last much longer than manufacturers indicate.

The United States Department of Agriculture (USDA), which oversees biologics, bases its annual booster recommendations on manufacturer duration of immunity tests, which the agency mandates for just up to one year. USDA then inserts annual booster recommendations in the sleeves of most vaccine



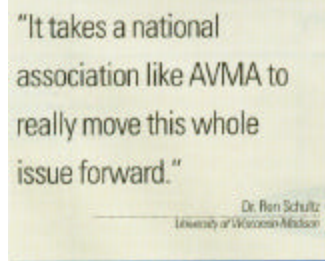

products, charging veterinarians to follow the suggested protocols.

Changing federal standards can be an arduous process, Klingborg says, but so far, the agency has worked with AVMA on supporting its new stance.



"Government moves slowly," he says, "but we couldn't have better interaction. They understand fully where we are coming from. What they want is more science on the table."

That science isn't easy to come by. The extreme expense of isolating animals for years at a time hampers manufacturers' ef-

"I'm hoping this report is a turning point," Schultz says. "It takes a national association like AVMA to really move this whole issue forward."

A step back?

But the national association still isn't reflecting the viewpoint of practitioners in the trenches, claims Dr. Jean Dodds, an immunologist and hematologist in California. While the AVMA report invites reader input, at presstime, Dodds was the organization's sole respondent. Her letter, criticizing the report's section on serologic tests, and COBTA's response to it, can be read in the Jan. 15 JAVMA issue.

"The report says titers are generally unreliable for gauging resistance and that's just nonsense," she says. "Average practitioners today need some assurance that animals have memorable immune memory before deciding against boosters. That's what titers provide."

AAHA report to come

It's a topic the American Animal Hospital Association (AAHA) is sure to cover when it comes out with canine vaccine guidelines this spring, Dodds adds.

"It'll be so embarrassing for AVMA when the AAHA report comes out and says entirely different things," she says.

But the AAHA report, likely to run in a March JAVMA issue, encourages many of the same ideas found in the AVMA's work, says AAHA Executive Director Dr. John Albers.

It goes further to make specific vaccine recommendations, but the AVMA's report is an important overview, he adds.

"I think it's actually well done," Albers says. "I don't think there's anything in it we or anyone else can take issue with. They did a great job of summarizing what's known about vaccines."

The AMSC had decided at a previous meeting that we would not support this at this time. c) Barbara Schulenburg has an appointment with the AKC during the spring meeting in New York, to assist Jerry Kyser in acquiring information for the breed history.

Committee Reports

A. Special Committees

1. SPRING SPECIALTY: Barbara Schulenburg, Marcia Feld a) Judges and entry information was shared for the AMSC National Specialty on Sunday. Trophies have arrived. The Chicago Miniature Schnauzer Club received a letter from Lou Auslander thanking them for his their congratulations on his AMSC life membership. b) Roving Specialty - Atlanta, GA in 2004. Nothing new to report at this time.

2. SUMMER SPECIALTY: Gene Matic, Vera Potiker No report

3. FALL SPECIALTY: Jenny Moore, Brian Bogart Received approval from the AKC to hold the specialty on October 5, 2003. In addition, Parade of Veterans and Parade of Title Holders classes will be held. Linda Drost will serve as the advertising chairperson. The trophy list will be needed by April 15, 2003.

B. STANDING COMMITTEES

1. AMSCOPE: Carla Borrelli Marcia Feld brought up the subject of allowing Foreign BIS winners on the front cover of AMSCOPE. After a brief discussion Marcia Feld motioned that the original guidelines on this issue would stand, which simply states that only USA BIS wins will be placed on the front cover. BIS wins in all other countries will be placed on the inside of the newsletter. Jerry Kyser seconded the motion. Motion passed, 16-2.

2. ADOA: Carol Somers The AMSC makes a yearly donation to the ADOA, \$35.00 membership fee and \$165 donation to the Canine Defense Fund. We also donate \$200 to the NAIA each year. Are we interested in increasing our amount? Jerry Kyser made a motion to continue to donate to the organizations, broken down as described above. Jinx Gunville seconded the motion. Motion passed, 18-0.

3. CONSTITUTION AND BY-LAWS: John Constantine a) Inquiry into the cost of printing up the newest edition of the Constitution and Bi-Laws was shared by the committee. Carma Ewer made a motion that the committee purchase 1500 copies of this document at the best price that they can find. Carla Nickerson seconded the motion. Motion passed, 18-0. b) Marcia Feld was asked to bring up the topic of two members of one household serving on the Board of Directors at the same time and was this something that the nominating committee may want to try and avoid in the future. There was some discussion, but the topic was dropped and no action was taken on this issue.

4. EDUCATION, JUDGES: Lanny & Penny Hirstein a) Seminars - One was conducted in Monroe, MI in September of 2002. Another was conducted on this very day in conjunction with the IKC. b) Mentoring Program - After a lively discussion on the second draft of the general qualifications needed to be met in order to apply to become a breed mentor, Marcia Feld motioned that we adopt the mentoring criteria provided that the changes be made to this proposal that were agreed upon by the board members present (all changes have been made to the qualifications which are listed in the minutes to follow). Chris Levy seconded the motion. Motion passed 18-0. General Qualifications (with changes included): (1) Must be a member in good standing of the AMSC for a minimum of ten years. (2) Must be a Miniature Schnauzer breed expert whose ethics, integrity and devotion to the breed is beyond reproach, and who is willing and able to share knowledge and provide guidance through open exchange of information, ideas and perspectives. (3) Must have met the minimum AKC requirements to apply for their miniature schnauzer judging license. (4) Have knowledge of the background, history and function of the breed. (5) Enjoys interacting with others and is able to communicate in an understandable, clear and insightful manner. (6) Possesses the physical energy and flexibility of schedule necessary to accept mentoring requests. (7) Demonstrates a commitment to impartiality and to the Breed Standard and the AMSC Code of Ethics. There is an application that accompanies the qualifications and it will be changed to match the criteria described above. In addition to matching the criteria it was suggested that item #4 become item #1 on the application. The committee will make the changes to the application and present it at the June Board

Meeting as the final draft. c) John Constantine shared the new Judging Approval Procedures that the AKC Board of Directors is considering adopting. There are five proposed changes, John Constantine encouraged individuals to send comments on their thoughts about these changes, specifically to the third item, "Institute a re-evaluation procedure which might culminate in the removal of permission to judge a breed". Comments on all of the five changes can be made on the AKC web site. d) Marcia Feld was approached at a breed seminar where one of the attendees is a current judge of MS. The judge told her that he was advised not to consider dogs under 13" because it was too small. Marcia Feld explained the breed standard to him, and that judges should be considering MS from 12"-14", and that there is no longer an ideal height of 13.5" mentioned on our standard any longer. Carole Weinberger read a statement written on June 20, 1998, which was included in a judges' newsletter. Barbara Schulenburg made a motion to resubmit the AMSC statement to the judges' newsletter as soon as possible. Jinx Gunville seconded the motion. Motion passed, 18-0. After some discussion on the motion, Carole Weinberger made an amendment to the motion that an emphasis be placed on the fact that there should be no preference for any size that is within the 12"-14" range. Chris Levy seconded the amended motion. Amended motion passed, 18-0. Terrie Houck will amend the letter and submit it to Mary Beth O'Neals office at the AKC for inclusion in a future judges' newsletter.

5. EDUCATION, MEMBERS: Penny Hirstein a) Tentative approval from Vera Potiker for a breeder seminar to occur during the GWTA weekend. b) AMSC CD Committee Progress Report. An outline has been completed of subject areas to cover on the educational CD. The need now is for photos and video of dogs. The Committee would like to solicit photographs from the membership. Any photos/images not provided by the membership or by Dan Kiedrowski, will be taken within the next few months. The membership may be solicited again should a need arise for a photograph to illustrate a specific point. The current AMSC slide presentation will be scanned, and hopefully will be good enough the images can be used for the CD. It is planned to have a rough draft of the educational material available at the June Board meeting. It will not be in the final format, but the information will be substantially complete. - Photographs should preferably be in color (black & white is acceptable for old photos), and be clear, with good definition. (In other words, if the dog is 1" high on a 3x5 photo, have the photo enlarged, then scan it or send it.) Photographs and images submitted may or may not be used in the Educational CD, at the discretion of the Committee. It is up to the committee to determine what points the photograph or image may portray. No dogs' names will be used (except possibly for the old, great ones). When used for the CD, the educational point made using a photograph may be a point the dog does not actually have, but does appear to have it in the photograph/image. Pictures cut from magazines or newspapers are not acceptable. Photographs submitted will be scanned and returned. It is preferred that the submission be electronic (and will not be returned). Submit electronic images at least 120 dots per inch, in jpg format, to abiqua2@teleport.com, subject: AMSC CD image. Please state in what area you believe the photo will be of benefit (it may or may not be used for that point, but will be put to the best use that is needed at that time). Chris Levy made a motion to purchase the Macro-Media software for AMSC use in developing the CD. Gerald Mager seconded the motion. Motion passed, 18-0. It was decided that Mack Ledgerwood would investigate and find the best price for this piece of software.
- 6. ELECTRONIC MEDIA: Mack Ledgerwood**
- a) "The AMSC's email list, AMSC-L, may be, but is not required to be, moderated at the discretion of the AMSC President, on advice from the Moderators. The Moderators would come to a consensus on whether the list should or should not be moderated and make a recommendation to the President for a decision. Moderation means that messages sent by members to the list are required to be reviewed by a Moderator before the message goes on to the list members. This review would test the message against the AMSC-L list's rules and its intent to be a positive communication medium for members. Messages deemed inappropriate by the Moderator currently on duty would be sent back to the sender for modification. There will be at least three, but no more than five Moderators, all of who are appointed by the Electronic Media Chair." Marcia Feld motioned that the policy be adopted as stated, with the addition that an individual could be placed on moderation as well. Carma Ewer seconded the motion. Motion passed, 17-1. b) Discussion took place regarding the Breeder Referral List. Carole Weinberger made a motion that individuals on the Breeder Referral List must have signed all pledges each year in order to remain on the list. Chris Levy seconded the motion. Motion passed 17-1.
- 7. ETHICS: Carma Ewer** a) A puppy buyer sent in a written complaint about a breeder and their failure to send them their AKC papers as promised in their signed contract. The documentation was extensive on the part of the puppy buyer. Carma Ewer made the motion that the AMSC should mediate the complaint first and if it can't be resolved and an agreement reached that is acceptable to both sides, then the complaint will be discussed at the subsequent AMSC Board Meeting. Chris Levy seconded the motion. Motion passed, 15-3.

- a) Have received an update to the Electronic Committee Guidelines from Mack Ledgerwood. No committee guidelines have been sent out to new committee chairs due to the learning curve associated with the latest and greatest software from Microsoft.
- 11. HEALTH: Vera Potiker, Errolyn Martin, Gwen Mulheron**
- a) Information on the CHF/CHIC Program will be postponed until the October 2003 board meeting. b) VetGen has been requesting DNA from Juvenile Cataract affected Schnauzers and their relatives. Our last inquiry about breeder response was not very good. Most of the DNA collected to date has been that collected by the cataract and health committees in relation to the test-breedings that have been performed. We want to remind AMSC members of our club's co-sponsorship of this project. Funding is essential for these works, and breeder participation can be equally as important. The AMSC has done their part by assisting in funding this study - now breeders need to do their part. Our committee discovered that no DNA from our breed was being used, but DNA from the other breeds was. We contacted the researchers and they agreed to collect DNA from our breed to include in this study, which among other things is comparing available canine DNA to numerous candidate genes, which cause cataracts in various other species. Mention the Miniature Schnauzer Juvenile Cataract Study. c) In February 2002 our committee made an initial report of cases of Systemic Aspergillois. Aspergillus is a fungus, and an opportunistic pathogen, which exists in the environment. Investigation into pedigree relationships with those of another defect were continued on p.6, column 1...Minutes

suggestive, but not conclusive. However, recently acquired information about a Primary Immunodeficiency Disease (PID) in humans suggests that this inherited defect of the immune system predisposes subjects to a range of opportunistic infections including aspergillosis and mycobacterium avium. Other symptoms of these immune compromised subjects may include the development of histiocytomas. This was a concurrent finding in one of the Miniature Schnauzers diagnosed with systemic aspergillosis. This dog was the offspring of a bitch that later produced an avium-affected bitch in a test-breeding. It is a plausible inference that these opportunistic infections in some Miniature Schnauzers may be caused by an underlying genetic defect. It is potentially useful to start thinking of the avian TB problem as a PID rather than simply a susceptible to avian TB alone. We would encourage breeders to inform the health committee if a dog contracts any unusual fungal, mycobacterial, or other opportunistic disease. Your support in this is crucial. This does not imply that every unusual infection or disease is associated with the same defect. Please contact a member of your health committee for assistance. **HOW CAN YOU HELP?** Our committee, in cooperation with researchers at a number of vet schools and other research facilities, is actively investigating all possibilities in the area of blood testing to determine if susceptible dogs can be identified prior to clinical illness. This type of work can not be done with tissue or DNA from dogs, but must be accomplished with fresh blood from still-living affected dogs. We need your cooperation to perform these tests. We need breeders and owners of affected dogs to report these cases to the health committee before the dog perishes or is euthanized, so blood can be collected and sent to the researchers for these tests. In fact, we currently have one researcher on hold waiting for blood from an affected dog, so he can run a particular test that holds some promise. We need your help. We understand this is a tough decision, but your contribution might make the difference.

11a. PRA: Margaret Pratt As of the end of 2002, Optigen tells us that 32 MS have been checked for Type A PRA. Four of these were checked in the October-December 2002 period. None tested positive. It is of interest that four were from the following areas; Sweden (2), Japan (1), USA (1). Dr. Aguirre reports that work continues to identify a second type of PRA, but such a gene has not been identified yet.

11b. C&JC: Carole Weinberger, Kurt Garmaker Our committee has been investigating late-onset, otherwise known as juvenile cataracts in our breed. To this end two bitches were test-bred, one with a one-eyed

non-CJC cataract and the other with bilateral cataracts of CJC origin. The first was bred to a dog that produced offspring with a one-eyed cataract. This resulted in 6 puppies clinically normal at 8 weeks of age by CERF exams. The latter bitch was bred to a dog with bilateral cataracts of non-CJC origin. This resulted in 3 clinically normal puppies at 8 weeks of age by CERF exams. The committee plan is to re-examine all test puppies at 6 month intervals to track the first appearance of a defect. Our committee also collected DNA samples from all test puppies, their parents, and many of their extended family and submitted them to VetGen to be used in the juvenile cataract study that the AMSC funded and co-sponsored. The committee has also solicited the membership to submit DNA for this project. This defect, late-onset cataract, being clinically expressed as juvenile cataracts is believed to be inherited in our breed. These cataracts can be unilateral or bilateral, and non-progressive or they may progress to maturity. They need not occur in both eyes simultaneously, but frequently; as the dog ages both eyes will show some affection, although not always uniformly. Affected dogs seem to experience little to no discomfort and little vision loss, making removal unnecessary. The earliest reported symptoms occurred in a dog at 6 months of age, and most ophthalmologists agree that changes in the eye after 6 years of age may not be inherited in origin, but may be advanced signs of senility of the eye. Of particular interest to the committee is the earliest signs of affection that would include both age and areas of the lens that are affected. Affected dogs have shown opacities in the cortical areas of the lens, both posterior and anterior. Questions still remain as to whether thickening of suture lines or the existence of capsular cataracts are a prognosticator for future development of opacities.

Members of the AMSC are urged to do two things: 1) - conduct juvenile or baseline examinations of all puppies, and at least annual exams of breeding stock. 2) - report any unusual findings during ophthalmic exams to the cataract committee. It is only through this type of cooperation that any progress will be made in eradicating late-onset cataracts from our breed.

11c. Urinary: Karl Barth, Bob Baws, Kennalea Pratt A complete copy of the results from the web survey concerning health issues in the MS, conducted by Dr. Joe Bartges from the University of TN, was included in the agenda at the board meeting. This information will be submitted for future publication in a veterinarian medical journal. Lanny stated that a report will be given by this committee at the board meeting in California in June.

12. HISTORIAN: Jerry Kyser a) Copies of the AMSC History covering 1933 through 1995 are now on CD in pdf format as requested at the last board meeting. Reaction to the savings to the club in printing cost was very positive. Jerry was asked to provide the history in this format whenever possible. b) Barbara Schulenberg is supposed to gather more history from the AKC library when she goes to NY in March. That info will be a big addition I can include in an updated history.

13. INSIGNIA: Nancy Banas No Report.

14. JUDGES SELECTION: Eunice Revsbech A discussion took place regarding the judges' selection guidelines for payment. An example of a contract was included within the body of the agenda. The board had given the chair of this committee the authority to hire judges at a cost that she felt was reasonable, but this flexibility has raised some concern. Lanny Hirstein formed a committee to investigate this issue and bring a recommendation back to the board at the meeting in June, 2003. Members who will serve on this committee are; Lanny Hirstein, Gerald Mager, Jinx Gunville, Eunice Revsbech. Jan Taylor reminded the board that the guidelines for this committee can be changed since the board approved the current guidelines.

24. RESCUE: Bolivia Powell & Michele Smith Local club rescue chairs have started discussing setting up a rescue list. One of the issues they will be discussing is ideas for fundraising. There were 223 schnauzers that were placed in new homes in one year.

25. SPECIAL PROJECTS: Millie Shultz & June Shanklin 10/1/02 - 2/12/03 this account saw an income of \$2458.00 and expenses of \$1804.00 for a net gain of \$654.00. Inventory value is approximately \$3400.00.

27. USE OF THE M.S. IN ADVERTISING & WHITE M.S.: Shirley Cole a) Translation of Margrit Roloff's materials on the White MS by Marcia Feld and Bev Pfaff. 2. A group of six AMSC members made a very well organized presentation to the AMSC board proposing that a Versatility Award be created and adopted by the AMSC. 4. John Constantine asked Kate McMillian to inform the board of an independent health registry that is being organized. Here is her report:

Several months ago the Miniature Schnauzer Club of Canada balloted our membership on the question of whether they supported the principle of an open health registry. The response was overwhelmingly in favour. The question was then sent to the MSCC Health Committee for consideration and suggestions for how to implement such a program. Studying the issues, combined with research into how other breed organizations have tackled open registries, has led to a realization that information on affected dogs is useless or even harmful to a breed if presented in a vacuum. It was obvious that to use such information in a positive, progressive manner, it would have to be presented in a positive and progressive atmosphere. Such a project was going to be beyond the capacity of any single breed club. To this end, the MSCC switched focus. Instead of a simple open registry, we have begun work on the launch of a completely independent, international Miniature Schnauzer Health Foundation. It is towards this goal that the MSCC is now working. While we are providing the seed money and volunteer effort, we intend our involvement as a breed club to be temporary. The sole mission of the MSHF will be to foster education and communication among serious breeders of the Miniature Schnauzer, worldwide. The Foundation will be membership based, and include programs of continuing education, genetics, breed surveys and data storage and analysis, as well as a voluntary, open health registry. Planning is currently in a preliminary stage, but we are optimistic that the establishment of the Foundation will be complete by the end of 2003. AKC URGES USDA TO MAKE IMPORTANT CHANGES TO AWA

New York, NY - The American Kennel Club (AKC) is urging the US Department of Agriculture (USDA) to make important enhancements to the Animal Welfare Act (AWA) that will improve the enforcement of the AWA and the overall welfare of purebred dogs.

In a letter to USDA Secretary Ann Veneman the AKC urged the USDA to:

• Close a loophole in the small breeder exemption in current regulations.

• **The small breeder exemption exempts persons from licensing requirements if they maintain three or fewer breeding females. However, some individuals have argued that they are not required to be licensed even when they keep more than three breeding females on the premises so long as any single member of the household does not own more than three. This practice is not in keeping with the intent of**

the act and regulations should be clarified to apply to the premises, regardless of ownership.

• Strengthen the authority of the USDA to deny licenses to unsuitable applicants.

USDA should be allowed to deny a license application to a person who has violated any federal, state, or local law or regulations relating to animal cruelty, neglect, or welfare OR who would be operating in circumvention of those laws OR who has provided false information to any government agency. USDA also needs explicit authority to deny a license application or renewal during the period when an applicant's license is under suspension.

• Make it harder for dealers to operate illegally.

USDA should prohibit Class B Dealers-persons who buy and sell dogs they have not

bred and raised-from knowingly obtaining dogs from persons who are required to be licensed and are not licensed. The agency should also require Class B dealers who obtain dogs from persons who are exempt from the licensing requirements of AWA regulations to obtain a certification from that person stating the basis on which they are exempt.

"These simple changes will dramatically improve enforcement of the Animal Welfare Act and prevent unscrupulous dealers from manipulating the system," said Noreen Baxter, AKC's Vice President of Public Education and Canine Legislation. "The AKC looks forward to working closely with the USDA to implement these changes that we believe will ultimately protect the welfare of all dogs as well as the dog-purchasing public."
