### The Facts About Canine Lyme Disease

The first diagnosis of Lyme Disease was made in a resident of Lyme, Connecticut in 1975. Over the decades, the seriousness of this debilitating tick-borne disease has made many people weary of wandering outdoors during seasons when ticks are active. If you live in the Northeast or upper Midwest states, there's a good chance you know someone who has had a Lyme Disease diagnosis. A decade after being diagnosed in people, Lyme Disease was first recognized as a condition that also affects dogs.

### What exactly is Lyme Disease?

Lyme Disease is an infectious disease that is caused by the bacteria Borrelia burgdorferi, which is found in several varieties of ticks, but is mostly associated with the common deer tick. The disease is transmitted when a tick carrying the bacteria bites a dog-or humanand feasts on the host's blood. It should be noted that not all deer ticks carry the disease, and not all bites from infected deer ticks successfully transmit the disease. For the bacteria to be passed into a dog, the tick must have been attached to the dog for about 48 hours. So if a tick is removed from a dog shortly after he is bitten, there's a good chance the dog will not contract the disease. However, deer ticks are extremely tiny and are difficult to see, especially when covered by a dog's fur. Your vet is trained to spot and remove ticks. If you happen to notice a tick on your dog and want to attempt to remove it, use small tweezers and carefully grasp the tick where it is making contact with the dog's skin. Then gently lift the tick away. If you suspect that it's a deer tick, take your dog-and the tick-to the vet for exami-

#### What are the symptoms?

Lyme Disease isn't easy to diagnose, especially in senior dogs, because the initial symptoms can be mistaken for other conditions, such as arthritis. Lyme Disease symptoms include limping—which can shift from one leg to another—swelling of lymph nodes, lethargy, loss of appetite, and fever. Initially, the affected dog may simply experience mild joint and muscle discomfort in his limb(s). However, the pain can become severe over time, and multiple joints can be involved Even with treatment, Lyme Disease can cause permanent joint damage. There have also been reports of severe progressive kidney disease linked to Lyme Disease.

#### Is there treatment for Lyme Disease?

Lyme Disease is generally treated with antibiotics. In many cases, affected dogs respond well to those meds. However, if treatment is halted too soon, the dog may get a relapse. Even in dogs that show full recovery, the bacteria that causes Lyme Disease may still be present in their bodies, even though the dog no longer displays the symptoms of the disease. Senior dogs with severe cases of arthritis—in addition to Lyme Disease—and those dogs that are severely affected may also be treated with pain relievers.

### How can Lyme Disease be prevented?

Since Lyme Disease is serious and can be debilitating, dog owners want to take measures to prevent their pets from contracting the disease. Here are a few things you can do to help minimize your dog's chance of getting Lyme Disease.

- Avoid areas that are likely to be tick infested. During the seasons when ticks are active, try to avoid taking your dog into heavily wooded areas or other places where large deer populations live.
- Spray your immediate home/lawn area with an appropriate insecticide. If you decide to use an anti-tick spray, make sure it's safe for dogs.
- · Vaccinate your dog. If you live in a high-risk region, ask your vet about the latest generation of Lyme Disease vaccinations. He may recommend one that he deems effective.
- . Use a topical anti-tick insecticide. There are currently several brands of topical insecticides on the market. They generally help in two ways: (1) By repelling ticks, and (2) By killing ticks that manage to attach themselves to dogs. Ask your vet about the brands he recommends. Please note that most flea and tick collars are not effective against the ticks that cause Lyme Disease. Only collars with amitraz have been shown to kill the ticks that spread this disease.

If you live in—or your dog has visited—a Lyme Disease hot spot and suspect that he is suffering from this condition, do not hesitate to take him to the veterinarian for an examination.

### The Serious Benefits of Play

Incorporating various forms of play into your dog's daily routine is vital to helping him develop a healthy, loving personality.

Playing and having fun helps to eliminate stress from you life—and the same holds true for your dog. In fact, incorporating various forms of play into your dog's daily routine is vital to helping him develop a healthy, loving personality.

#### The benefits of play

Here are some of the ways that playing and having fun is important:

- Physical health. Active play helps keep your dog's heart healthy, keeps the joints lubricated, and improves his overall balance and coordination.
- Mental health. Games with rules force your dog to use his brain, not just his body. This can help keep his mind sharp and focused.
- **Social skills.** When your dog plays with other dogs and other people, it helps improve his overall social skills. He learns basic rules and how to play by them.
- **Bonding.** Even if it's only for a few minutes a day, playing with your dog helps strengthen the bond between you.
- Your health. What better way to alleviate the stress of a busy workday and get a bit of exercise than to come home and play with your dog? It's a win-win for both of you.

### How to play with your dog

There are right ways—and wrong ways—to play. The most important thing to remember is that you're the boss. You decide what games should be played and you set the rules. This helps establish your credibility as the pack leader. It also helps keep your dog from getting overly excited and out of control while you play. If your dog does become difficult to manage, simply put a stop to the game until he calms down again.

When you're teaching your dog a new game, reward him when he does well. Remember, rewards don't have to be just treats. You can also reward him with his favorite toys or lots of hugs and praise.

When you start out teaching your dog a new game, keep it simple and go through the game slowly, until your dog fully grasps the rules. Also, wait until he fully understands one game before you teach him a new one, otherwise it will end up confusing him.

### Playtime tips

Avoid games like keep away, wrestling, or tug-of-war. Those games encour-

age biting or dominant, aggressive behavior.

- Stay in control of the game at all times. Show your dog that you're the pack leader, not just another member of the pack. Retrieval games are good at teaching control.
- Don't include your body or clothing as part of any game.
- Incorporate the SIT or DOWN and STAY commands in every game.
- You decide when it's time to end the game, not your dog. The best time to stop the game is when your dog is still eager to play.
- If, for some reason, your dog doesn't seem to understand the game at some point, go back to the beginning, or simply leave it and try again a few days later. Don't get angry if you're dog isn't "getting it" right away. Remember it's supposed to be a fun experience for both of you!

#### **Credit Card**

Our Club does not have a credit card. Most of our expenses are invoiced and paid by check and a few are paid by Paypal. There are situations in which a credit card is necessary to prevent a member from incurring a club expense on his/her personal card when the vendor will not accept a check or when the vendor requires immediate payment. Most instances involve a deposit required for a future event in order to reserve the date and facility. Typical examples include catering for Montco hospitality and the deposit required to reserve a venue for our club dinners. The other instance requiring a credit card arises when time is of the essence to meet a deadline and the vendor will not wait for a check to be mailed.

Bank of America requires Board approval for the issuance of a credit card to a non-profit organization. Minutes evidencing this approval must be submitted to the bank with the application. I request approval for a Club credit card. The users of the card will be the Treasurer and President. The use of the card will be to make payments such as those outlined above; normal reimbursable expenses (travel, office supplies, postage, etc.) will continue to be handled via expense reports.

We are currently in the testing phase for the AMSC Health Survey which will be announced and ready to be used very soon. It will be important that everyone complete this online form when it becomes available. The survey will be used to identify priorities for research and future educational efforts for the membership; results from the survey will be provided Dr. Bell for his review and discussion in October. We would like to recognize Health Committee member Patricia O'Brien for coordinating this project. As stated previously this survey will provide general information (and aggregate data will be available to any members as it is being collected) and will drive further more

comprehensive and specific information gathering as a corollary.

The MIT/Broad Institute (Dr. Andrew Lundquist) submitted a pre-proposal to the AKCCHF for a grant to study Renal Dysphagia in Miniature Schnauzers and 2 other breeds in March. The AKCCHF approved the pre-proposal and requested a full Grant request submission which MIT did in May 2012. We expect to hear if this research is approved by September in which case we will be asking for fund support. The research has identified a candidate gene which appears to be very promising and is located similarly to one identified in humans.

The Health Committee would like to report that Errolyn Martin has resigned from the Committee in June. While we certainly appreciate and recognize all the work she has done over the years, she has indicated her interest in participating on the world stage with the Facebook page, Global Miniature Schnauzer Community. We wish her well in her new endeavors and expect nothing less than success in whatever she chooses to do. We are in the process of retrieving the Health Committee files, correspondence etc that Errolyn has amassed during her tenure as a member and developing operational policies in addition to what has already been developed. The Progeny software and data files have been retrieved. In the meantime, we will be looking for candidates with unique skill sets to augment computerization efforts.

### Item 1: Schnauzer Rescue of the Carolinas

Prior to the last meeting, the board was given detailed background on Schnauzer Rescue of the Carolinas (SRC) and its placement of a Glen of Imaal Terrier in spite of receiving notification that the breeder wanted the dog returned to her. That action was in violation of the spirit of the AMSC Minimum Rescue Guidelines; therefore, I recommended that they be removed from the AMSC Rescue Program.

### Item 2: AMSC Rescue Program

I have been researching how other national breed clubs operate their rescue programs and the standards and practices of those programs. Since the AMSC Rescue Program requires many of the same things required by other national rescue programs, I am only recommending some minor changes. There are some differences in the benefits that the national club (or its trust or foundation) offers for rescues and the information that rescues are required to provide to the national rescue program. The first three items below are designed to address the "benefits" part of the AMSC Rescue Program.

### Item 2(a): Seek Charitable Organization Status from the IRS

Allowing the AMSC Rescue Program to seek appropriate charitable organization status from the IRS would:

- allow those donating funds to the AMSC Rescue Program to claim a charitable deduction on their income taxes;
  - John commented that this would be done as a separate entity from the AMSC. He would like further study as to how other clubs do this and have discussion at the next meeting.
  - make the AMSC Rescue Program eligible to seek grant funds on behalf of recognized rescues (by "recognized," I mean only groups and individuals that have completed our requirements and are eligible to be recognized on the AMSC Rescue Program page), which would encourage collaboration among these groups and help them to meet the eligibility

requirements of some large grantors; and

allow individual members who incur expenses for rescuing a dog – and who are not part of a local rescue group – to claim a charitable deduction on their income taxes.

### Item 2(b): Disaster grant program

Following a natural disaster or other emergency, it is important to get funds in the hands of the recognized rescue as quickly as possible. Since the Board meets three times per year, I am recommending Board approval to authorize the Rescue Chair, President, and Treasurer to jointly agree to release up to a certain amount (e.g., \$2,000) in emergency situations. Notification would be provided to the Board following release of funds, and would be included in a subsequent Rescue Committee report.

# Item 2(c): Provide space for recognized rescue(s) to host an educational and fund-raising table at specialty events.

Events such as Schnauzapolooza 2013 provide an opportunity for recognized rescues to highlight their work while raising much-needed funds for both the rescue and the AMSC Rescue Program.

### Item 2(d): Revision of AMSC Rescue Program Requirements.

Suggested revisions are marked below:

AMSC Rescue Program Minimum Rescue Requirements

May 05, 2011 June xx, 2012

Any rescue group wishing to be recommended by the AMSC must be following these minimum guidelines. If you adopt a dog from a group who was recommended by the AMSC, and they are not following these guidelines, please contact AMSC Rescue at MS\_Resq@comcast.net.

Rescues recognized on the AMSC Rescue Program page have agreed, in writing, to adhere to the AMSC Rescue Program's Minimum Rescue Requirements, and their rescue practices are periodically checked for compliance. If you adopt a dog from one of the recognized rescues and believe that they are not following these guidelines, please contact AMSC Rescue at MS Resq@comcast.net.

### MINUTES...cont'd from p. 6, col. 3

If you are part of a rescue group that is not recognized below, please contact AMSC Rescue at MS Resq@comcast.net for an Application for Recognition by the AMSC Rescue Program. contacts currently listed on the AMSC website are there at their request, and are not necessarily approved by AMSC Rescue. If you would like to know of a reputable rescue contact in your area, please contact MS\_Resq@comcast.net.

All dogs of appropriate age and health placed MUST BE <u>SPAYED</u>/NEUTERED/SPAYED PRIOR TO PLACEMENT.

Known bBiters and terminally ill dogs are not placeable.

All dDogs should receive a health check from a veterinarian prior to placement.be vet checked to verify that you are placing a healthy dog.

All dogs placed must be <u>current up to</u> date on <u>routine</u> vaccinations, <u>including</u>: rabies, distemper, parvovirus, coronavirus, <u>and</u> parainfluenza. In states where infection has occurred, <u>dogs they</u> should also be tested for heartworm and the owner informed of the results.

<u>All dogs</u>Schnauzers should be reasonably and recently groomed.

An aAdoption fee must be charged to discourage unscrupulous people from acquiring a free dog that they can turn over to a laboratory for animal testing, use as a bait dog in dog fights, etc.

An aAdoption agreement is required contract must be completed for each dog placed. The agreement Contract MUST stipulate that the dog must be returned to the rescue organization if the new owner cannot keep the dog, at any time and for any reason.

AKC papers are NEVER to be given to <a href="mailto:the-new">the-new</a> owners per AKC Policy and Guidelines.

Registration papers from any other registry are NEVER to be given to the new owners.

An oowner surrendering a dog must sign a contract relinquishing all claims to the dog.

Vet records for owner surrenders should be acquired from the owner's vet if possible. These records should be passed on to the new owner; HOWEVER, the previous owner's information (name, address, phone number, work phone number, etc.) should be obscured so the new owner cannot contact the previous owner.

If it is determined that a rescue dog originated with came from an AMSC breeder, the breeder MUST be contacted promptly and the dog should be returned to the breeder at his/her discretion.

If a rescue places another breed of dog and it is determined that the rescue dog originated with a breeder recognized by the national breed club, the breeder MUST be contacted promptly and the dog should be returned to the breeder at his/her discretion.

\*\*ANY COMPLAINTS ABOUT A GROUP PLACING A DOG AFTER BEING NOTI-FIED BY THE BREEDER THAT HE/SHE WANTS THE DOG RETURNED WILL RESULT IN IMMEDIATE SUSPENSION OF THE GROUP WHILE THE AMSC INVESTIGATES THE COMPLAINT.\*\*

Rescuers in each state should be adhereing to the laws applicable to his/hertheir state/region.

### MAC\_

On June 24, 2012. I notified the AMSC members via the List that the AMSC Health Committee had temporarily suspended Pedigree Analyses pending receipt of our complete committee files. While we have not received our files, we have spoken with Dr. Jerold Bell who initially recommended Pedigree Analysis based on what he was led to believe was a KNOWN mode of inheritance. He has conferred with Dr. Giger and received notice today from Dr Giger who has advised him that a recessive mode of inheritance for MAC is NOT proven at this time and, indeed, whether the defect is 100% penetrant is also unknown. Dr Bell advised that the major criteria for the appropriate use of pedigree analyses is a known mode of inheritance and based on this conversation with Dr. Giger, Pedigree Analyses would be inappropriate and misleading for the MAC defect.

Therefore, complying with the professional advice of Drs. Bell and Giger, the AMSC Health Committee will no longer be doing Pedigree Analysis. Pedigree Analyses previously done are not a valid tool for assessing pedigree risk for MAC and should not be used for breeding management decisions. If I can provide any additional information I will be please to do so.

### Email to Dr. Bell sent prior to the release of the HC protocol:

Recently, new cases have been disclosed to our committee that indicate there are many more carriers identified and these dogs are showing up in generations 3-5 of current pedigrees. These dogs are speard throughout several breeding programs who, as of now to our knowledge have not had any cases, but the risk is there.

Chi-square analysis and very limited testbreeding supports a SAR trait. Dr. Giger at UPenn is working on research to isolate this mutation currently.

Our health committee operates on a confidentiality rule, with a disclosure statement that allows the submitted to opt for privacy within the health committee or for public disclosure. Pet owners opt for public disclosure while breeder opt for privacy. Some breeders, especially those who exported producing dogs, discourage disclosure when they are contacted by the owner of an affected.

Desptie ths, we have substantial evidence of who the carriers are and where the risks exist. But, we cannot disclose the names of dogs for which we have no disclosure or private disclosure. We have taken hits on the chin for not telling breeders the names of these dogs.

Now we find ourselves making recommendations to try to stop the production of affected dogs without really having the board's backing, as we cannot require breeders to do what they should do. We tried in 2002 to get the board to approve a revision to the code of ethics that would require the owner of a producing dog to remove him from public use, and they were not willing to do this (it didn't help that a few of the board members had such dogs). Because of the zoonotic potential, several breeders are creating a stir about publicicty, dnagers ot humans, etc. so we feel we need to act qucikly to at least encourage the sharing of information.

The most our committee can do without board approval is to make recommendations. So we have developed a stratgey designed to make risk analysis available to all members who ask for it, so they can themselves identify at-risk dogs and producing dogs, without the committee violating our agreements with owners, and without having to involve the board. I've attached both the basic recommendations and the protocol we are working on to perform these risk analyses, as we want to encourage breeders to police themselves and to breed responsibly, while stopping the production of affecteds until we have a DNA test.

So, I am hoping you wouldn't mind examining these documents and letting us know your impressions and making any suggestions on how we can deal with this issue. I als want to ask if we may have your permission to use share your article on pedigree analysis/risk analysis/consequences to the breed for publication in our club newsletter, and if so, could you provide a copy for us?

Thanks so much, and as I stated, if there is a charge for your time please let me know. I'm very concernd about where this is heading if we don't act quickly to get our breeders unified.

I "listen" in on the committee to people that are more knowledgeable on health issues than I, all members, and especially Dr. Lisa Sarvas and Dr. Paula Steele. I give guidance to the committee on how to proceed and review all of their work. I am in complete agreement with them and support them fully.

As to my thoughts, I understand the HC, and I, have made a huge mistake by allowing only one member of the committee to be privy to the information used in making decisions. That will not happen again. The committee has taken a step back, since it is now apparent that we will not get the information taken from the committee back from the member that left and that communications with the researcher were not exactly what the committee was led to believe. The committee has spoken to Dr. Bell and moved on his recommendations based on his conversations with Dr. Giger.

I think we all need to make our own decisions in breeding our dogs. The AMSC can put out there what we know about this, or any, issue and breeders need to make their decisions using that information. This are a lot of unknowns in this issue and we cannot make recommendations. We are not a club like some around the world dictating what breeders can and cannot do, and we will not become that. We present information and people use that to make their own decisions.

As far as public forums, I continue to believe they are not appropriate forums for AMSC to discuss AMSC business, as much as some would like to try and drag us into those. The Global MS Health, or whatever it is called, on FB, it just another free-forall "Frank's World". I, or the HC, will not be dragged into it. We make the information we know on this issue known to Parent Clubs around the world. They disburse it to their members. IMO, that is the proper means for AMSC to communicate to the world, club-to-club, not club-to-non-members

We will continue to use amsc-l and AMSCope to communicate to our members

We all, just need to sit back, help the HC and researchers by being open and disclosing (any) issues, make informed decisions when breeding based on information supplied by the HC, and try to ignore the couple of people out there who continually try to discredit the AMSC for personal egotistical reasons.

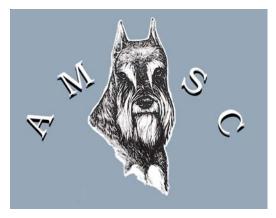


