- · Visitors to the AMSC website were up significantly since the last Board meeting, averaging 1,110 unique visitors per day in the months March through August. This amounts to almost 405,210 visitors per year creating some 4,757,000 accesses to files (hits) on the website.
- We now have 145 breeders listed in the AMSC website's Breeders List section, up from 143 in February.

·As of Sept. 20, there are 244 members subscribed to the AMSC-L email list and 13,755 messages accumulated in the searchable archive.

- There are 17 Breed Mentors listed on the AMSC website in Sept., up one since the last Board meeting. The committee moved to add email addresses to the mentor list. Seconded by Chris Levy. Motion passed, 13-0.

From the General Health Committee: Update on CHF Grant # 2447, Hypothyroidism Study the AMSC co-sponsored: update advised an approved extension, scheduled completion mid-2005. We are waiting for a final report.

Pancreatitis study at Texas A & M: several people submitted blood for normal/control dogs, but no samples from affected dogs were submitted.

U of Penn is now offering a DNA test for Miniature Schnauzers for MPS VI, mucopolysaccharidosis type VI. This is a lysosomal storage disease which causes symptoms similar to Legg Calves Perthes disease. Dr. Greene at U of Georgia, Athens is still investigating the biochemical aspects of susceptibility to M. avium infection in our breed. Dr. Giger at U of Penn is investigating the ge-

netic aspects of this problem. Both are collecting samples from avium affected Miniature Schnauzers, and will share samples with each other.

The following health problems have been reported to the Health Committee in the last several months: primary hyperlipidemia -1, LOC -1, skin fragility syndrome -6 of 9 pups, sick sinus syndrome -1, avian tb -2, hypodipsic hypernatraemia -1.

AKC/CHF Parent Club Canine Health Conference: Errolyn Martin will attend this conference from Oct 21-23 in St. Louis. Ms. Martin will provide a comprehensive report in a format to be determined based on the volume of material presented.

Discussion on prioritizing health issues in our breed: The health committee and board members discussed the goals of developing a prioritization scheme for health issues in our breed, to facilitate improved communication with the CHF and to help the AMSC more efficiently focus available assets on health issues.

Central DNA Bank: There are discussions of a possible central DNA bank for dogs. This bank is proposed to provide storage of DNA from dogs in a central resource so DNA will be readily available for researchers. The committee will investigate and report on this issue.

Recent discussion with a health member of the Cocker Spaniel Club revealed that LOC in their breed is not as significant as rumored. The contact stated that investigation into this defect by researchers indicates this defect in their breed is inherited as a complex trait, possibly composed of up to 15 different genes. The test litter puppies in our breed to date remain clear-eyed at approximately 3 years of age.

John Constantine moved to cover Errolyn Martin's actual travel cost, \$390.40, for her attendance at the CHF Health Conference. Seconded by Chris Levy. Motion passed, 13-0.

To rein in future costs for obedience judges, the Performance Committee has been asked to try to select a group of potential candidates as geographically close as possible to any given specialty obedience trial.

Judges selection can possibly be made by the Performance Committee or by putting potential judges on same ballot as conformation judges - in order to save cost of a separate mailing.

Lanny Hirstein moved that Sonny Lelle provide the board with a committee list of 5 members who represent a cross section of the US that would be responsible for the judges selection for performance events at the AMSC Specialties, in lieu of a membership vote. The name would be presented to the board for approval. Seconded by Bolivia Powell. Motion passed, 14-0.

The Committee would like to propose that in the future, our membership roster include a 'code' for a member's experience - - in this particular case, a "P" for any member who has Performance activity experience. That naturally brings up the question about whether we should also include a "C" for conformation experience.... A number of members have expressed an interest in being able to easily identify all the performance-interested members. Those members specifically interested in performance events could be contacted by email or normal U.S. mail should the occasion arise. Let me stress that this is NOT meant to segregate or discriminate against ANY member! This is SIMPLY meant as a helpful code to help identify the specific needs/interests of members.

Susi Atherton moved that there be an AMSCope announcement asking for performance competitors to identify themselves via email notification to Sonny Lelle at the time of membership renewal, and that Sonny then forward the list on to Carla Borrelli for inclusion as a list in the back of the annual roster. - 3. Mack Ledgerwood, Amy Gordon, Wyoma Clouss and Terrie Houck wrote a FAQ's section for the AMSC web site to try to alleviate some of the common questions that visitors ask.

ADJOURNMENT_ Susi Atherton moved that the meeting be adjourned at 10:30 PM. Seconded by Brian Bogart. Motion passed unanimously.

Appendix A

THIRD REVISED DRAFT

The American Miniature Schnauzer Club CODE OF ETHICS

PREAMBLE

This Code of Ethics is intended to serve as a guide that members of the American Miniature Schnauzer Club follow, recognizing their role as guardians of the breed, and having a common interest in the protection and wellbeing of the breed and of the individual dogs that members own and produce in their breeding programs. Implicit in membership in the American Miniature Schnauzer Club is the understanding and full acceptance of the Code of Ethics.

GENERAL CONDUCT

Members of the American Miniature Schnauzer Club strive to:

Comply with the Rules and Regulations of the American Kennel Club (AKC), the Constitution and By-laws of the American Miniature Schnauzer Club (AMSC) and the Code of Ethics.

Conduct themselves in a manner that reflects positively on themselves, the breed, and the AMSC.

Exhibit good sportsmanship and good will at all dog-related events.

Make no false or misleading statements concerning the Miniature Schnauzer breed or other breeds or breeders.

Be responsible dog owners, treating their dogs humanely and providing them with adequate food, water, shelter, veterinary care, exercise, grooming and the socialization and training necessary for them to be good family companions.

Make every effort to learn about the structure, anatomy, action, inherited traits and behavior of the dog, especially where such learning applies to the Miniature Schnauzer.

Use the official standard of the breed when evaluating and breeding their own stock, and encourage its application in judging.

Participate in efforts to assess and improve the health of the individual dog and of the Miniature Schnauzer breed, including, but not limited to, participation in valid, reliable and responsible testing for hereditary diseases, providing samples and information for development of hereditary disease tests, and sharing health information with other AMSC members. Be honest, factual and not misleading or fraudulent in any written or oral statement about dogs and breeding programs, whether about their own dogs or those of others.

BREEDING

Members of the American Miniature Schnauzer Club, as guardians of the breed, strive to breed conscientiously, taking responsibility for the lives they produce, including responsible placement of all puppies produced by any breeding, to ensure the safety and well-being of the individual dogs and of the breed.

Accordingly, members of the American Miniature Schnauzer Club will:

Educate themselves to recognize the correct conformation of the Miniature Schnauzer, familiarizing themselves with the AKC breed standard and representative dogs, prior to breeding a stud dog or a brood bitch.

At all times breed for the improvement of the breed as exemplified by the AKC standard.

Breed only animals that are in good health and who are physically and temperamentally sound.

Strive to produce puppies of such quality that they will serve to improve and complement the breed and avoid breeding individual Miniature Schnauzers known to have, or are strongly suspected of having, a serious inherited disease or defect that will likely be passed on to offspring and that, if inherited, would significantly affect the quality of life of any offspring that would be produced.

Represent each puppy sold as accurately as possible.

Share information gained through breeding with other Miniature Schnauzer owners.

Act as a mentor to persons with whom they place puppies and encourage an open dialog for the life of the dog.

REGISTRATION AND SALES OR TRANS-FER OF OWNERSHIP

Members of the American Miniature Schnauzer Club will:

Sell each puppy or adult with a written health quarantee, a three-generation pedigree, a record of immunizations, care and feeding instructions, and registration papers where applicable.

Inform the buyer of the characteristics of Miniature Schnauzers, and make available to the novice the benefit of his advice and experience.

Sell any puppy or adult having a known hereditary health defect or unsound temperament only with a Limited Registration and Spay/Neuter Contract.

If a puppy is sold as a companion animal, it may be sold one of two ways:

- 1) On a Limited Registration.
- 2) On a Spay/Neuter Contract whereby the breeder may withhold AKC registration papers until receipt of proof that the puppy has been altered.

The breeder shall remain responsible for the welfare of every dog he breeds, sells or places. This means making himself available to aid the new owner if and when the need presents itself. If in the future the owner is not able to keep the dog, the owner should be instructed to contact the seller and the seller will have the responsibility either to take the dog back or find it a new home.

The breeder will not sell or dispose of any dog through pet shops, wholesalers, commercial dealers or paid agents.

HERITABLE DISEASES/CONDITIONS

Members of the American Miniature Schnauzer Club will:

Make a determined effort to have all breeding animals tested for the presence of all heritable diseases or conditions known to afflict Miniature Schnauzers and not breed those discovered to be affected.

Send a report of the adverse test results to whoever the AMSC Board designates Health Committee to collect this information.

Lori also finished several of her champions herself and was selected 4 times to judge the Sweepstakes at the American Miniature Schnau-

She was the driving force in the formation of the Tampa Bay MSC for which she served as president for several terms. 




