### THE WAY WE WERE

This month **Geri Kelly** is sharing her information with us.

I originally wanted to call my kennel "Brudenberg Kennels." MY husband Dick and I were discussing it and he said, "What's wrong with Kelly? So Kelly it was.

1963 marked my entrance into the world of Miniature Schnauzers. However, I actu-

ally began my career in 1948 showing Bulldogs, and am proud to have been elected into the Bulldog Hall of Fame.

My first Miniature Schnauzer was a black and silver named Wellsworth Jefferson Kelly. His call name was "Willie". He came from Jonaire Kennels in Mt. Pocono, Pennsylvania. My mentor was Ann Paramore Escrigg. She was more popularly known as "Ann Finger"

I think all my dogs were important. If I had to name one it would be Ch. Kelly's Ebony Show Stopper, call name "Stopper." He was Best of Breed National Specialty Winner and the first Black Miniature Schnauzer to achieve this recognition. He was great! He was American, Canadian, and Japanese Champion. In addition he won 3 Best in Shows. I would be remiss if I didn't also mention two other great dogs. Ch. Kelly's Flamboyant Black, call name "Neffie." In two litters this black bitch had 11 champions and 1 Canadian Champion. Two of her daughters were also top producers. After "Neffie" came Ch. Kelly's Hallelujah, call Name "Hal". He was American,. Canadian and Bermuda Champion, winning Best in Show in all 3 Countries. He had a total of 5 Best in Shows, And of ves! "Nigel", Ch. Kelly's Right on the Money. He had 71 group First finishes in 1 ½ years. He also won 5 all breed Best in Shows.

I can't leave out Ch. Kelly's Charwin Bar None, call name "Buckwheat" At the age of 6 months she won All Breed Best in Show by beating 2500 other dogs. She was the only black bitch to ever achieve this. As you can see, I can go on and on about my dogs. They have all been important to me.



I groomed and showed my own dogs. I can't believe that as of December 15, 2009 I have bred/co-bred 298 Champions! I have also had 16 Best of Shows.

I have seen dramatic changes over the years. Particularly in terms of style of the dog and the type of grooming. Over the years it seems that more importance is being placed on the

grooming and cosmetics of the dog rather than the breed structure. People seem to be going for the "bling" not the structure.

Coming from Bulldogs where there is no grooming I had a new challenge. I learned to groom from a book. Then I went to work at a Terrier Kennel. I also went to the Murphy brothers and Pop Sayers for help.

Schnauzer Breeders for the most part have been diligent in protecting their quality breed. In the early 1960's, the issue was juvenile cataracts. In the 1980's and1990's it was PRA. Lately there has been a problem with megasophagus and there have been teeth issues, in particular tarter and the loss of teeth at a very early age.

How has the breed changed? In the first line of our breed standard it reads "Sturdy and Robust" I have seen a lack of chest and spring of rib.

Because of my love of the breed, I have always been willing to help each and every person that asks for it.

(What keeps you involved with Miniature Schnauzers?) It's funny that you should ask this question. Just today I looked at a French Bulldog. The reason being, no grooming! I could go from my motor home to the ring and have more time to enjoy the many friends I have met over the years. Although I have been an All Breed Handler, PHA, from the time when handlers had to be licensed and in spite of all the grooming, time and effort, the Miniature Schnauzer will always be my passion!

### Who is Eligible for Grand Champion Competition?

The following categories of dogs are entered in this competition: Dogs that are Champions of Record competing in Best of Breed or Best of Variety class. Dogs transferred to Best of Breed/ Variety which according to their owners' records have completed the requirements for a championship but whose championships are unconfirmed. (The showing of dogs whose championships are unconfirmed is limited to a period of 90 days from the date of show where a dog completed the requirements for a championship according to the owners' records.) Champions that win Non-Regular Classes and become eligible for Best of Breed competition. (Altered or spayed CH veteran class winners at independent specialties are eligible.) Winners Dog and Winners Bitch are not eligible for Grand Champion competition.

At the judge's discretion, Grand Championship points may be awarded to: Best of Breed or Variety Best of Opposite Select Dog Select Bitch

Grand Champion competition will not continue beyond Best of Breed competition and in breeds that are divided into varieties, Grand Champion Competition will not continue beyond Best of Variety competition.

### What are the requirements to earn the Grand Champion Title?

25 Grand Champion points.

A minimum of 9 points won at 3 shows with ratings of 3 or more points (Major wins) under three different judges, and one or more of the balance of points won under a 4th judge. At least one Champion of Record was defeated at three of these shows.

How are Grand Champion points computed?

Grand Champion points are only to be awarded to dogs the judge considers deserving. Grand Champions points awarded to the Best of Breed/Variety shall count all dogs of both sexes competing in the regular classes and in Best of Breed/Variety competition. Grand Champion points awarded to Best of Opposite Sex shall count all dogs of their sex competing in the regular classes and in Best of Breed/Variety competition.

Grand Champion points awarded to Select Dog/ Bitch shall count all dogs of their sex defeated in the Best of Breed/Variety competition as well as the dogs of their sex in the regular classes. (i.e. one less than the total entry in that sex) The entry of non-regular classes are not counted for computation of Grand Champion points to be awarded.

Judging Procedure: Choose BOB, BOW and BOS If quality warrants, choose a Select Dog (SD) and Select Bitch (SB) from the remaining Champions in the BOB ring (Do not consider

BOW, WD or WB) Annotate the judge's book certification as to the eligibility and quality of the Grand Champion points being awarded or withheld.

Award BOB, BOW, SD and SB ribbons if determined to be of eligible and deserving of the Grand Champion title. See: HYPERLINK "http://www.akc.org/pdfs/judges\_sheet\_conformation.pdf" http://www.akc.org/pdfs/judges\_sheet\_conformation.pdf for example of the revised judge's book form.

Administration: On May 12, 2010 Grand Champion competition will be included in all shows offering BOB or BOV competition. Premium lists – Other than prize listings, there is no requirement to address Grand Champion competition in the premium list since it is included in all shows that offer BOB or BOV. However, there is no restriction should superintendents and secretaries want to bring attention to the new competition.

Judging Schedule – No additional information is required.

Ribbons – BOB and BOS do not require an additional ribbon. Light blue & white ribbons for SD & SB. Flat ribbons or rosettes are equally acceptable. "Select" is acceptable wording however "Grand Champion Select" is acceptable and more descriptive. Ring Markers – Just as with BOB, BOW and BOS, there is no AKC requirement to have SD and SB placement markers. These markers are provided as a service by the club or superintendent.

### Early Spay-Neuter Considerations for the Canine Athlete One Veterinarian's Opinion

Those of us with responsibility for the health of canine athletes need to continually read and evaluate new scientific studies to ensure that we are taking the most appropriate care of our performance dogs. This article provides evidence through a number of recent studies to suggest that veterinarians and owners working with canine athletes should revisit the standard protocol in which all dogs that are not intended for breeding are spayed and neutered at or before 6 months of age.

### **Orthopedic Considerations**

A study by Salmeri et al in 1991 found that bitches spayed at 7 weeks grew significantly taller than those spayed at 7 months, who were taller than those not spayed (or presumably spayed after the growth plates had closed).(1) A study of 1444 Golden Retrievers performed in 1998 and 1999 also found bitches and dogs spayed and neutered at less than a year of age were significantly taller than those spayed or neutered at more than a year of age.(2) The sex hormones, by communicating with a number of other growth-related hormones, promote the closure of the growth plates at puberty (3), so the bones of dogs or bitches neutered or spayed before puberty continue to grow. Dogs that have been spayed or neutered well before puberty can frequently be identified by their longer limbs, lighter bone structure, narrow chests and narrow skulls. This abnormal growth frequently results in significant alterations in body proportions and particularly the lengths (and therefore weights) of certain bones relative to others. For example, if the femur has achieved its genetically determined normal length at 8 months when a dog gets spayed or neutered, but the tibia, which normally stops growing at 12 to 14 months of age continues to grow, then an abnormal angle may develop at the stifle. In addition, with the extra growth, the lower leg below the stifle likely becomes heavier (because it is longer), and may cause increased stresses on the cranial cruciate ligament. In addition, sex hormones are critical for achieving peak bone density.(4) These structural and physiological alterations may be the reason why at least one recent study showed that spayed and neutered dogs had a higher incidence of CCL rupture.(5) Another recent study showed that dogs spayed or neutered before 5 1/2 months had a significantly higher incidence of hip dysplasia than those spayed or neutered after 5 1/2 months of age, although it should be noted that in this study there were no standard criteria for the diagnosis of hip dysplasia.(6) Nonetheless, breeders of purebred dogs should be cognizant of these studies and should consider whether or not pups they bred were spayed or neutered when considering breeding decisions.

### **Cancer Considerations**

A retrospective study of cardiac tumors in dogs showed that there was a 5 times greater risk of hemangiosarcoma, one of the three most common cancers in dogs, in spayed bitches than intact bitches and a 2.4 times greater risk of hemangiosarcoma in neutered dogs as compared to intact males.(7) A study of 3218 dogs demonstrated that dogs that were neutered before a year of age had a significantly increased chance of developing bone cancer.(8) A separate study showed that neutered dogs had a two-fold higher risk of developing bone cancer.(9) Despite the common belief that neutering dogs helps prevent prostate cancer, at least one study suggests that neutering provides no benefit.(10) There certainly is evidence of a slightly increased risk of mammary cancer in female dogs after one heat cycle, and for increased risk with each subsequent heat. While about 30 % of mammary cancers are malignant, as in humans, when caught and surgically removed early the prognosis is very good.(12) Luckily, canine athletes are handled frequently and generally receive prompt veterinary care.

#### **Behavioral Considerations**

The study that identified a higher incidence of cranial cruciate ligament rupture in spayed or neutered dogs also identified an increased incidence of sexual behaviors in males and females that were neutered early.(5) Further, the study that identified a higher incidence of hip dysplasia in dogs neutered or spayed before 5 1/2 months also showed that early age gonadectomy was associated with an increased incidence of noise phobias and undesirable sexual behaviors.(6) A recent report of the American Kennel Club Canine Health Foundation reported significantly more behavioral problems in spayed and neutered bitches and dogs. The most commonly observed behavioral problem in spayed females was fearful behavior and the most common problem in males was aggression.(12)

### **Other Health Considerations**

A number of studies have shown that there is an increase in the incidence of female urinary incontinence in dogs spayed early (13), although this finding has not been universal. Certainly there is evidence that ovarian hormones are critical for maintenance of genital tissue structure and contractility.(14, 15) Neutering also has been associated with an increased likelihood of urethral sphincter incontinence in males.(16) This problem is an inconvenience, and not usually life-threatening, but nonetheless one that requires the dog to be medicated for life. A health survey of several thousand Golden Retrievers showed that spayed or neutered dogs were more likely to develop hypothyroidism.(2) This study is con-

### top 10 poisons

ASPCA Poison Control Center recently released a list of the top 10 poisons that affected cats and dogs in 2009. So take note, and be sure keep these toxic substances far away from your pets in 2010!

**Human Medicines.** Human drugs were the top cause of pet poisoning in 2009, the ASPCA reported. Last year, the Poison Control Center managed more than 45,000 calls from people whose pets had swallowed pills such as pain relievers, cold meds and antidepressants.

**Insecticides.** One of the most common insecticide problems was <u>misuse of flea and tick products</u>. Make sure to talk to your vet about how to properly use these products.

**Human Food.** Most people know chocolate is dangerous to dogs. But did you know that grapes, raisins, avocados and products containing <u>xylitol</u> (like sugar-free gum and candy) can also be harmful to your pets?

**Plants.** Dozens of common houseplants, including azaleas, rhododendrons, sago palm and kalanchoe are dangerous for pets. Lilies are particularly toxic for cats, and can cause deadly kidney failure.

**Vet Medicines.** Almost 8,000 cases of pet poisonings in 2009 involved pets that were given medicines incorrectly. Make sure you follow instructions and talk to your vet about how to safely apply over-the-counter and prescription medicines for your cat or dog.

**Rodent Killer.** Poisons that are attractive to mice and rats can also smell tempting to dogs and cats. Be sure to keep your pets away from potentially deadly rodent poisons.

**Household Cleaners.** Bleaches, detergents and disinfectants can cause serious gastrointestinal and respiratory problems. Keep cabinets locked to prevent your pets from swallowing or sniffing the harmful substances.

**Heavy Metals.** You know lead poisoning is bad for babies, but it's just as dangerous for your furry friends. Keep your pets away from paint chips, linoleum, and the dust produced when you sand the walls in older homes.

**Garden Products.** Fertilizers and other garden chemicals can cause severe stomach upset in dogs and cats. So let your dog stop to sniff the roses, but not the fertilizer, please.

Household Chemicals. Our homes often contain a lot of chemical substances, from antifreeze to paint thinner to drain cleaner. Such substances can cause stomach upset, respiratory problems and chemical burns in dogs and cats.

This special competition is designed to evaluate an overall breeding program rather than the traditional approach of evaluating a single specimen. Respected expert judges will evaluate the breeder's ability to consistently produce superior dogs of uniform type, health, and conformation - consistent with the breeder's mission of improving their chosen breed.

Each breeder will exhibit 3 dogs from at least 2 litters chosen from their breeding program. The 1st exhibitor must be breeder of record on all 3 dogs, and all 3 dogs must be over one year old. Breeders will be able to enter on the day of the show.

sistent with the results of another study in which neutering and spaying was determined to be the most significant gender-associated risk factor for development of hypothyroidism.(17) Infectious diseases were more common in dogs that were spayed or neutered at 24 weeks or less as opposed to those undergoing gonadectomy at more than 24 weeks.(18) Finally, the AKC-CHF report demonstrated a higher incidence of adverse reactions to vaccines in neutered dogs as compared to intact.(12)

I have gathered these studies to show that our practice of routinely spaying or neutering every dog at or before the age of 6 months is not a black-and-white issue. Clearly more studies need to be done to evaluate the effects of prepubertal spaying and neutering, particularly in canine athletes.

Currently, I have significant concerns with spaying or neutering canine athletes before puberty. But of course, there is the pet overpopulation problem. How can we prevent the production of unwanted dogs while still leaving the gonads to produce the hormones that are so important to canine growth and development? One answer would be to perform vasectomies in males and tubal ligation in females, to be followed after maturity by ovariohysterectomy in females to prevent mammary cancer and pyometra. One possible disadvantage is that vasectomy does not prevent some unwanted behaviors associated with males such as marking and humping. On the other hand, females and neutered males frequently participate in these behaviors too. Really, training is the best solution for these issues. Another possible disadvantage is finding a veterinarian who is experienced in performing these procedures. Nonetheless, some do, and if the procedures were in greater demand, more veterinarians would learn them.

I believe it is important that we assess each situation individually. For canine athletes, I currently recommend that dogs and bitches be spayed or neutered after 14 months of age.

## Cold Weather Canine Care Tips

© 2006 The American Kennel Club, Inc. (The whole Country has had more than it's share of cold...and more is to come)

A dog's need for food, shelter and loving care increases during the cold winter months. Keep your dog safe and warm by following these guidelines.

- Dogs can get frostbite or hypothermia when temperatures drop. Don't leave your dog outside in the cold for long periods of time. Provide a covered shelter, such as a doghouse or kennel, for the times the dog is out of doors.
- · When your dog is inside, keep him warm, dry and away from drafts. Tiles and uncarpeted floors may become very cold, so put down blankets or pads for him to lie on.
- Keep your dog a safe distance from supplemental heat sources such as portable heaters and fireplaces, which can cause severe burns. Place screens around fireplaces.
- Don't leave your dog alone in a car on cold days.
- Feed your dog additional calories, particularly if it spends a lot of time outdoors or if it is a working dog. The extra calories are necessary because it takes more energy in the winter to regulate body temperature.
- · Provide plenty of fresh water at all times. Dogs are just as likely to get dehydrated in winter as in summer. Snow is not a good substitute for water.
- Groom your dog regularly. Your dog needs a well-groomed coat to keep properly insulated. If you have a short-haired dog, consider a sweater or coat. If your dog is long-haired, clip the hair around its paws to ease snow removal.
- Dry your dog with a towel or blowdryer if it gets wet from rain or snow. Clean snow and ice from its paws to prevent cuts and cracked pads. A little petroleum jelly may help soften and soothe paw pads.
- Be extra careful when walking or playing with your dog near frozen lakes, rivers or ponds. Your dog could slip or jump in and be seriously injured.
- Rock salt, used to melt ice on sidewalks, can irritate paw pads. Rinse and dry your dog's feet after a walk.
- · Watch out for spilled antifreeze on driveways. Antifreeze smells and tastes good to dogs, but it can be lethal.
- Dogs, like humans, seem to be more susceptible to illness in the winter. Take your dog to the veterinarian if you notice any signs of illness

- · Dog's call name, registered name if applicable, breed, age and sex.
- · Owner/Nominator name(s), address, phone number. E-mail address if available.
- \*Please note that to be considered, dogs are not required to be AKC registered but must be an AKC recognized breed.


