# DETECTION OF JUVENILE RENAL DISEASE IN MINIATURE SCHNAUZERS

Kidney failure is a common cause of death in geriatric pets. It usually comes on in an insidious fashion. The owner first notices his pet is drinking more than usual, then urinating abnormally large amounts or more frequently than usual. The pet becomes less active, has a poor appetite, loses weight and begins to vomit frequently. Low protein diets and fluid therapy can help reverse the trend temporarily but the end result is inevitable. At some point, the diseased and/or debilitated kidneys can no longer keep up with the demands made upon them.

This scenario is especially tragic when it occurs in a pet that is seven months old, 18 months old, or three years old. We have seen this occur in a litter of Miniature Schnauzers affected by hereditary renal dysplasia.

The filtration mechanism in the kidney is called the glomerulus. The glomerulus is responsible for filtering body fluids so that important substances, such as proteins, stay in the body, and toxic substances, such as urea, are filtered out of the body. The glomerulus is responsible for keeping phosphorous, sodium, potassium, calcium and chloride levels balanced. It is responsible for regulating the amount of fluid in the body. The glomerulus is so efficient in doing its job, that up to 75% of the glomeruli in the kidney can be non-functional, and the kidney will still be able to perform its functions adequately. Once the 75% line is crossed, however, symptoms of kidney disease appear, and the BUN and creatinine levels in the blood become elevated (BUN or blood urea nitrogen and creatinine are protein breakdown products that the kidneys normally keep at a tolerable level in the body.).

Unlike geriatric dogs with renal failure, the Miniature Schnauzers we have seen with hereditary renal dysplasia are affected because their kidneys contain many immature glomeruli – glomeruli that never matured to the point where they could perform their necessary functions. Dogs will cross the 75% non-functional line at an earlier age and begin to die from renal failure depending on the number of immature (non-functional) glomeruli present in the kidneys.

Renal failure does not only occur because of immature glomeruli. It can also occur because of infection, immune-mediated diseases, cancer, traumatic damage, damage due to shock, toxins such as antifreeze and other types of birth defects. So how do you know if your Miniature Schnauzer is affected by renal dysplasia/immature glomeruli? The only way you will be able to determine this is to have a biopsy of the kidney evaluated by a pathologist. Dr. Michael Goldschmidt at the University of Pennsylvania is very experienced at evaluating kidneys for this problem and is able to give us a percentage of immature glomeruli after evaluating wedge biopsy samples. Dr. Mary Whiteley, DNA Solutions Inc., is presently trying to determine the mode of inheritance of this disease in Lhasa Apso for the national breed club.

Many concerned owners have asked whether normal BUN and Creatinine levels, a normal urinalysis or a normal ERD (early renal detection) test are good methods to determine whether their dog has renal dysplasia. Unfortunately, the answer is "no". Unless your pet has crossed that 75% threshold, none of these tests will show any abnormalities. These tests cannot presently determine the cause of kidney failure. We have found ultrasound to be useful in picking up some cases of JRD (juvenile renal dysplasia) before they cross the threshold, but it did not pick up cases where only 15% of glomeruli or less were affected. Please note that we refer to renal dysplasia as JRD to distinguish it from retinal dysplasia (RD).

A wedge biopsy sample can be taken shortly after death. It can also be taken surgically from a live dog by an experienced veterinarian. There is some risk in surgery. However, the risks of surgery must be weighed against the risks of introducing an affected dog into your breeding program.

The fact that your dog has had a normal BUN, creatinine, ERD, or even ultrasound, does NOT mean it isn't a carrier, or mildly affected. Also, a dog can produce a litter of affected puppies and be clear itself. This is why we need to try to identify the heredity mode. Roving Specialty: John Constantine \* All is set for our FIRST Roving Specialty to be heldtomorrow. I think the entry of 95 in regular classes and 21 in sweeps shows it has been well received. This is one of the biggest (if not the biggest) entries for a non-Montgomery Specialty that we have ever had. I want to thank the Board for embracing the idea back in October of 2001, for the club and exhibitors for supporting it, and for Don Cox for co-coordinating arrangements in Georgia. \* All is in order with the Roving specialty for 2006 in Louisville. It will be held in conjunction with Evansville KC on Saturday March 18, 2006. The club will receive \$2/dog. The Executive Inn West will be the host hotel. John Constatine was asked to investigate the possibility of hosting a judging and breeder seminar in conjunction with the show. The 3 Ohio clubs are hoping to hold specialties, as well; Cincinnati, Columbus, and Cleveland. The cluster gives clubs holding a specialty on Wednesday a \$500 bonus and \$5/dog (\$3/ dog would go to our judge). If we held our Specialty on Wednesday we would be making \$500 additionally and it would give us 5 shows and 4 specialties! The committee made the motion to change the date of the AMSC specialty from March 18 to March 15, 2006. - A. Versitilty: Beth Santure The Certificate As of March 31, 2004 we have received 11 applications for the award. The process of verifying the applicants' information is being done and we will be publishing a list of recipients in AMSCope soon. A framed copy of the certificate that will be awarded to qualifying applicants will be available for the board to see at this meeting. We thank Lori Bush for the generous donation of her time and artwork on this project. We would like to finalize this certificate by using an authentic looking seal of our club logo on each certificate.

After researching the best and most cost effective way to do this, our recommendation is to purchase pre-made embossed stickers. The cost of the initial artwork computerization, original plate and 1000 stickers (required minimum) is approximately \$269.37. Please keep in mind that these stickers can be used for other club items, awards or correspondence and they can easily be distributed to other committees for use. The final stickers will have an embossed impression of our logo, with wording and will be tow-tone silver, a dull silver background with the raised areas being a shiny silver foil. The printing of the certificates will be done professionally at a cost of \$1.00 a piece. This printing method has been chosen because of the professional looking results, and the high quality ink. The committee made the motion to go forward with printing of the certificates and the AMSC Logo stickers for the Versitility Award Certificates. Bev Verna seconded the motion. Motion passed, 14-0. **AKC ILP Numbers** One of the applications received for a Versatility award is for a Miniature Schnauzer with an ILP number. ILP numbers (Indefinite Listing Privilege) are given by AKC to purebred dogs that meet their requirements (i.e. neutered & purebred) so that they may participate in performance events. The committee made the motion that we include ILP numbers as proof of a type of registration with AKC for otherwise qualified Miniature Schnauzer applicants for the AMSC Versatility Award. As such the application will be changed to include a space for ILP numbers on it. Seconded by Chris Levy. Motion passed, 14-0.

This amounts to almost 308,000 visitors per year creating some 3.980.000 accesses to files (hits) on the website. \* We now have 132 breeders listed in the AMSC website's Breeders List section. up from 123 in October. \* As of March 23, there 212 members subscribed the AMSC-L email list and 9,315 messages accumulated in the searchable archive. \* The list of Breed Mentors was added to the AMSC website in March. Request for Office Software I would like to request that the Board provide funding to upgrade the software I use to perform AMSC functions. I am no longer able to update the web page with my copy of MS FrontPage 2000 due to incompatibility with the Cedant server FrontPage Extensions, and the databases and documents I keep for the AMSC could benefit from enhanced functionality in MS Office 2003 software. These would be especially beneficial in light of additional duties I may take on for the AMSC, and the Board may want to take that into consideration. T he projected outlay of expenses is \$327.00. Janet Taylor made the motion to approve the expenditures. Penny Hirstein seconded the motion. Motion passed, 14-0.

Also, they should review the minutes after each Board meeting, and update the quidelines if needed. D. I have paper copies all the guidelines with me and on CD for the President and Secretary.

12. HEALTH: Vera Potiker, Errolyn Martin, Gwen Mulheron, Dawn Dailey, Patti Ledgerwood Item 1: CHF Grant 2447: Genetic Determinants of Susceptibility of Hypothyroid Disease in Dogs. This grant is for a one-year study, with an approved amount of \$60,473.00. Hypothyroidism is the most common endocrinopathy in dogs, and diagnosis is difficult due to lack of good clinical diagnostic tests. Low levels of thyroid hormones can be diseases. caused bν many primary hypothyroidism is characterized by the presence of autoantibodies to thyroglobulin. The researchers have recently developed an assay to measure these autoantibodies, allowing the identification of animals with primary disease. The study could better our understanding of this condition and offer new approaches to its reduction in dogs. Our committee motions the AMSC sponsor this study with an amount of \$ 5.000.00 from the club's CHF donor advised fund. Kurt Garmaker seconded the motion. Motion passed, 10-3-1.

Item 2: Request for funding from DNA Solutions, LLC - Regarding Juvenile Renal Dysplasia. DNA Solutions LLC submitted a proposal for funding research into two candidate genes for renal dysplasia. Based on the written proposal, the primary breed of interest is the Lhasa Apso, and there is the potential that IF a causal mutation is identified in that breed, then the same genes could be evaluated in the Miniature Schnauzer. The Lhasa Club is funding the research on their breed. The funding proposal received is for a total of \$ 23,500.00, payable in increments as research progresses. The written proposal is brief, and does not identify

where our breed is to participate in the research plan, or how AMSC funds will be allocated. A peer reference check of the researcher/president of this company was positive. The proposal was sent to another researcher for an opinion of it's scientific merit, and this researcher stated it was interesting, but brief and that there was not enough information to form an opinion. Our committee solicited the assistance of the CHF in evaluating the proposal for merit. Although CHF does not fund research by for-profit organizations, they agreed they would help us evaluate the proposal for merit only. This would require the researcher to complete a regular application on the normal cycle. Then the Grants Administrator would walk the proposal through to the peer review committee. This committee is a panel of scientists and researchers who evaluate all proposals submitted to the CHF for scientific merit. An effort is being made to have the researcher rewrite the proposal to include more specific information on where DNA from our breed would be used, and how AMSC monies would be spent. Our committee motions the AMSC decline funding this research at the current time, while the health committee continues to correspond with the researcher to obtain a more complete proposal. Seconded by Bev Verna. Motion passed,

Item 3: CHF/CHIC Program - AMSC Participation. The AMSC approved enrollment in CHIC at the last meeting. Now CHIC has advised us that breed clubs enrolling usually have at least three "required" tests. Our initial testing was for an annual CERF exam (required) and a myotonia test (recommended). According to CHIC, this is not sufficient to make the database meaningful. CHIC requests that we revisit enrollment when we have more testing criteria.

Item 4: Myotonia test database submissions reminder. Our committee wishes to remind the membership that we are still collecting myotonia test result submissions for the AMSC Myotonia database. We would like to publish another updated list in AMSCope later this year, and hope that members who have had their dogs tested will consider sending their results in for the database, if they have not done so. The database is published with names of dogs that have tested clear only. Νo dogs carrier status will be published. See the May AMSCope for a submission form. Remember to include a copy of the test certificate with your submission form.

proposing a voluntary open list to identify Miniature Schnauzers affected with avian TB or producing affected offspring. This list would be completely voluntary, require specific diagnostic records, and require owner/co-owner consent.Recent discussions with the geneticists working on our DNA reveal that the candidate gene study is slow. This is due to the high relatedness of the dogs whose samples were provided. There is high homozygosity at numerous locations that are being compared to the candidate genes. This homozygosity makes it more difficult to rule out certain candidate genes. Our committee is soliciting a small number of samples from known producing dogs that may have more heterozygosity.

This development indicates that we are probably not going to have a DNA test within the next few years. Our committee recognizes that new cases are reported each year, with pedigrees indicating known producers as well implicating additional dogs as carriers. Our committee also recognizes that there are a few producing dogs at public stud in the US and abroad. Importantly, there is a lack of information and tools which would allow breeders to effectively deal with or avoid this issue in their breeding programs.

Clearly, these factors contribute to the potential increase in the defective gene carrier rate, thereby consequentially increasing the affected rate in our breed over time. This poses a significant risk to the breed population, as well as a potential health risk for individuals exposed to this pathogen through an affected dog. Although to date there has not been a recorded case of transmission from a Miniature Schnauzer to a human, this pathogen is potentially zoonotic, this is an opportunistic pathogen and poses а risk immunocompromised individuals. While most would think this means persons with HIV /AIDS, it also applies to persons with a multitude of immune disorders including other immune diseases, diabetes, cancer/chemotherapy, among others.

In the absence of a DNA test or a test to determine susceptibility, our breeders are unable to combat this defect, control the spread of the defective gene, or reduce the risk of producing an affected. Our committee hopes to offer breeders a method by which information can be obtained, that will assist them in making educated breeding decisions. This pro-active approach will facilitate reducing the affected rate over time, and assist in control of the carrier rate until a DNA test is developed.

This defect warrants aggressive management from the AMSC, not only for public health reasons, but to protect the future health of our

breed.

Our committee motions the AMSC approve the establishment and initiation of the "AMSC Voluntary Open List for Avian TB" as outlined in attachments A and B, and that this list be published in AMSCope as deemed necessary by changes to the list. The committee will include a disclaimeras well as a description of the status of the research where ever the information in disseminated. Penny Hirstein seconded the motion. Motion passed, 14-0.

#### Attachment A

This is a voluntary database. Submissions meeting the criteria will be published publicly for the AMSC membership.

Criteria for submission:

1. All submissions must be signed by all owners of the dog. 2. All submissions of affected must include а diagnostic report or necropsy report specifying a diagnosis of avian tuberculosis or mycobacterium avium, except as outlined in item 3. Submissions for disseminated mycobacteriosis without an identified species will be accepted, but not published, unless documentation is provided as outlined in item 2, to validate a full sibling was affected with avian tuberculosis. 4. All submissions of producing dogs, (dogs that have had an affected offspring) must include a diagnostic report or necropsy report for the affected offspring specifying a diagnosis of avian tuberculosis or mycobacterium avium, and either a copy of the offspring registration certificate or a copy of the offspring certified pedigree. 5. For producer submissions, the affected offspring will not be identified in the database based on the submission of the sire or dam. An affected dog must be submitted as outlined in item 2 to be listed in the database. 6. All submissions must include a copy of the submitted dog's registration certificate. 7. The health committee may notify the breeder of the dog's status, if deemed appropriate.

### Seme Harris Auslander, 76, dog breeder

Seme Harris Auslander loved dogs. She bred dogs, showed dogs in competition and served for years as secretary-treasurer of the International Kennel Club of Chicago, which puts on one of the nation's largest dog shows each February.

"She was involved in all of the hospitality, all of the keeping the building in fine shape, keeping all the committees working," said her husband of 57 years, Louis Auslander.

Mrs. Auslander had been battling cancer of the mouth for the last 12 years.

She was born Seme Harris, one of six children of Samuel and Dora Harris. She grew up in Hyde Park, started high school at Hyde Park High and transferred to Thornton High School when her father bought a hardware store in Harvey and moved the family to that south suburb. Upon graduation, she worked in her family's store and in department stores.

She and a girlfriend were rowing a boat on Lake Michigan just off Michiana Shores, Ind., in the summer of 1945 when a pair of young men on the beach noticed them. The girls put in to shore, sat on the sand some distance away, then wandered over to talk. One of the young men was Louis Auslander, whom she married in January 1947.

The couple found an apartment on the North Side, and Mrs. Auslander began breeding dogs. In a short time the couple moved to Lake Forest, on five acres near the interstate, where they established the Alpine kennel.

Mrs. Auslander bred miniature schnauzers, whippets, and smooth and wire-haired fox terriers. She herself was petite, standing 5-feet tall.

"She loved that part of the sport, breeding and raising the puppies. She did some showing of her own. She loved to groom the dogs. She was very good at that. She was a very involved person," her husband said.

While she exhibited dogs at shows, her husband became a judge, eventually judging 100 breeds.

The couple joined the International Kennel Club of Chicago and in 1983 took on responsibility for running its annual show, which draws thousands of dogs and tens of thousands of visitors.

"She was involved in the educational end of it — seeing that everybody understood what purebred dogs were and what dogs were bred for," her husband said.

She enjoyed knitting, turning out scarves and sweaters for her seven grandchildren. She also enjoyed cooking, especially casseroles, and made many cakes, pies and cookies.

During her long battle with cancer, "This is one woman who never complained," even when she could only have foods she could take through a straw, her husband said. Other survivors are a son, Carter; two daughters, Sindy Schneider and Dori Auslander, and seven grandchildren.


