Every breeder knows that certain rules exist within a dog pack. Especially in breeds within the Terrier Group, humans observe their terriers living out the "If I see it, it's mine!", or "If the dog that has it looks away, it's mine!" rules. No matter the breed, all dogs know that a play bow means "Let's play!" and if that play partner becomes a bit too rough in the game, the other dog will either retaliate with aggression or refuse to play any longer. Such rules, we breeders recognize and accommodate into the general animal husbandry of caring for our dogs. However, recently, more and more research by animal behaviorists and psychologists points to the realization that dogs operate within an ethical framework.

In other words, dogs have morals. In fact, many animals demonstrate a sense of morality, but scientists focus on canids (animals in the dog family), because when researchers study dogs, wolves, and coyotes, they discover behaviors that hint at the roots of human morality. The only point of contention is whether dogs learned morals through spending time with humans, or the ethical structure within dogs reflects an evolutionary process that improved the pack's survival - a process that continued to a more complex cognitive level in humans.

Psychologists previously held the premise that animals lack the "sense of self' needed to experience the more complex emotions of jealously, embarrassment, or guilt. In her experiments, Dr. Friederike Range, of the University of Vienna's neurology department, showed that dogs feel intense jealousy when they see that they are being treated unfairly compared with other dogs. "Dogs show a strong aversion to .inequity," she said. Owners of multiple dogs have always known that, but objective, carefully controlled experiments in a university setting had to prove this truth to a doubting scientific community. Dr. Range's study has

included several species of animals including cows, horses, cats, and sheep, Her experiments have proven that animals are far more self-aware than was thought.

Dr. Paul Morris, a psychologist at the University of Portsmouth who studies animal emotions told the London Sunday Times: "We are learning that dogs, horses, and

perhaps many other species are far more emotionally complex than we ever realized. They can suffer simple forms of many emotions that we once thought only primates could experience." Even Harvard University has opened a Canine Cognition Lab in which researchers attempt to gain insight into the psychology of both humans and dogs.

Natural historian Jake Page states that biology no longer dismisses dogs and other animals as "furry automaton" driven only by instinct and food. Page authored the Smithsonian article, "Do Dogs Smile?" in which he showed that the same areas of the brain in both dogs and humans activate when a human laughs or a dog displays a rhythmic pant - a dog's laughter. It would seem that scientists formerly failed to accurately "read" the facial expressions of dogs. Any observant dog owner can clearly see and respond to the grinning, wide open mouth and joyous expression in the eyes of his/her dog. Page explains that Marc Bekoff, professor emeritus of the University of Colorado, has "figured out how to measure these things. It's a whole new ballgame for studying dog personalities and emotions." Bekoff maintains that a dog's code of ethics is on display daily in parks, backyards, and family rooms. "We're not trying to elevate animals," Bekoff said. "We're not trying to reduce humans. We're not saying we're better or worse or the same. We're saying [that] we're not alone in having a nuanced moral system."

In gathering research material for Wild Justice, a book he co-authored with Jessica Pierce, Marc Bekoff spent thousands of hours observing coyotes, wolves, and dogs in the field. He analyzed videotapes frame by frame, and he concluded that these animals possess empathy and compassion. the emotions upon which a moral sense is built. While much the same can be said of monkeys, elephants, dolphins, whales, and other social animals, dogs remain special cases - they share in human lives. As Bekoff observes, "I'm convinced many animals can distin- guish right from wrong." He cites a long list of observable emotional and ethical behavior in dogs:

Dogs have a sense of fair play. They dislike cheaters. They experience joy in play. They delight in friends. The big guys handicap themselves in games with little guys.

Dogs get jealous when a rival gets more or better treats or treatment. They are resentful, unnerved, or saddened by unfair behavior. They are made anxious by suspense. They get afraid. They are embarrassed when they mess up or do something clumsy. They feel remorse or regret when they do something wrong. They seek justice. They remember the bad things done to them but sometimes choose to forgive.

Dogs have affection and compassion for their animal and human friends and family. They defend loved ones. They grieve their losses.

They have hope.

Skeptical critics downplay Bekoff's observations of dog behavior as anecdotal, as anthropomorphism. Bekoff counters that thousands of anecdotes equal data. Anthropomorphism, he says, is a misleading label for what is actually a shared evolutionary history.

Bekoff maintains that it is in play that canids teach their young the social graces of pack life. Vigorous play biting and body slamming could easily be misinterpreted by participants. Years of painstaking video analyses by Bekoff and his students show, however. that individuals carefully negotiate play, following four general rules to prevent play from escalating into fighting.

Communicate clearly. Animals announce that they want to play and not fight or mate. Canids use the play bow to initiate play, and the play bows always look the same so that themessage is clear. Even when an individual follows a play bow with seemingly aggressive actions such as baring teeth, growling, or biting, his companions trust the play bow's message that whatever follows is meant in fun. Trust in one another's honest communication is vital for a smoothly functioning social group.

Mind your manners. Animals consider their play partners' abilities and engage in self-handicapping and role reversal to create and maintain equal footing. For instance, a dog might not bite her play partner as hard as she can, handicapping herself to keep things fair. A dominant pack member might perform a role reversal, rolling over on her back - a sign of submission that she would never offer during real aggression -to let her lower-status play partner take a turn at "winning". By keeping things fair in this manner, every

member of the group can play with every other member, building bonds that keep the group cohesive and strong. Admit when you are wrong. Even when everyone wants to keep things fair, play can sometimes get out of hand. When an animal misbehaves or accidentally hurts his play partner, he apologizes - just as a human would. After an intense bite, a bow sends the message, "Sorry I bit you so hard - this is still play regardless of what I just did. Don't leave; I'll play fair." For play to continue, the other individual must forgive the wrongdoing. Forgiveness is almost always offered; understanding and tolerance are abundant during play as well as in daily pack life.

Be honest. An apology, like an invitation to play, must be sincere. Individuals who continue to play unfairly or send dishonest signals will quickly find themselves ostracized. This has far greater consequences than simply reduced play time. Bekoff's long-term field research shows that juvenile coyotes who do not play fair often end up leaving the pack and are up to four times more likely to die than those individuals who remain with others. Violating social rules, established during play, is not good for perpetuating one's genes.

Fair play, then, can be understood as an evolved adaptation that allows individuals to form and maintain social bonds. Canids, like humans, form intricate networks of social relationships and live by rules of conduct that maintain a stable society. Basic rules of fairness guide social play, and similar rules form the foundation for fairness among adults. This moral intelligence which is so evident in both wild canids and domestic dogs, probably closely resembles that of our early human ancestors. It may just have been this sense of right and wrong that allowed human societies to flourish and spread across the planet.

Jonathon Haidt agrees. Haidt is a professor at the University of Virginia in the Social Psychology area of the Department of Psychology. Haidt proposes that a sense of morality is an evolutionary adaptation for intensely social species such as canids. These speciesmake moral judgments to evaluate the actions or character of others with respect to the cultural values of their group. For packs of wild canids or domesticated dogs, it proves extremely beneficial to tell the difference between friends and enemies and also to differentiate

between cheaters and those who cooperate with you. While dogs cannot create a culture that includes opera or ice hockey, their societies do have moral rules that govern behavior, according to Haidt, and such rules are an important part of the cultural basis of social morality in humans,

too.

Dogs do have an ethical, moral code by which this intensely social species can function . effectively. Those that claim dogs came by this moral code from living for so many years with humans have fallen once again into the trap of hubris. Such a premise cannot explain that the dog's wild canid relatives have a similar ethical structure with moral rules that reinforce pack cohesiveness. The ethical rules which govern dogs' behaviors with each other evolved naturally as a means of strengthening their social bonds. By studying their behavior, scientists now have a glimpse of how primitive human societies developed. As always, our dogs continue to teach us such important lessons - if we remain open and willing to learn. • Sandra Murrav

Two Common Household Objects That Can Poison Your Pet

In 2012, over 180,000 pets were exposed to potentially toxic substances in and around their homes. And for the fifth year in a row, prescription human medications topped the list. Other items in the top 10 pet poisons list include insecticides, over-the-counter human medications, veterinary drugs, household products, people food (including chocolate), plants, rodent bait, and lawn/ garden products. A lesser-known item also toxic to pets is the penny. Pennies produced after 1982 contain zinc, and a pet's stomach acid can quickly erode an ingested penny, releasing the zinc into the bloodstream. Zinc damages red blood cells and the results can be fatal. Another potentially deadly situation can occur if your pet eats a piece of your clothing. Worn socks are a particular favorite. Indested cloth doesn't show up on x-rays, and it takes about 48 hours for the average pet to start showing symptoms like vomiting or loss of appetite. If the item is found and removed quickly, most pets fully recover. But the longer ingested cloth remains inside an animal, the greater the risk of a fatal side effect.

AKC Delegates' Meeting Report June 11, 2013

 Social Media/Public Relations: In March Christopher Walker joined AKC to spearhead improving AKC's social media program. In the 90 days since the March meeting, on Facebook AKC went from 100,000 likes and 4,000 engaged participants, to almost 370,000 likes and 80,000 engaged people. Alan Kalter, AKC Chairman, reported that while HSUS has many more likes, they only have 28,000 engaged participants. AKC also now has a blog with over 130,000 visitors. And AKC is working on improving the website to make it more "user friendly."

In addition, AKC has retained the public relations firm Edelman as their new public relations partner. Edelman is the world's largest public relations firm, with 4800 communication experts in 67 offices worldwide. According to Mr. Kalter, Edelman has the experience and the expertise to anticipate, monitor, and respond to news attacks from the opposition or other threats to AKC's reputation 24/7. In the Chairman's Report, Mr. Kalter said "The key here is "anticipate" something we will become expert at in short order. We have some other plans, but I believe HSUS and ASPCA are some of the most avid readers of our reports, including this one. So, rather than reading about our plans, they can enjoy experiencing them instead."

2. <u>First Breeder-to-Breeder</u> <u>Seminar:</u>

On Friday, December 13th, the AKC will host its first breeder to breeder seminar at the Orange County Convention Center, in Orlando Florida in conjunction with the AKC/ Eukanuba National Championship. Championships. This will be a seminar for breeders by breeders of all categories, from the novice to the long-time breeder. There will be individual speakers covering topics such as canine genetics, the whelping process, pedigree analysis and the litter grading process. and posted on AKC.org for all to see. After the seminars each presenters will participate in a round table discussion for questions and answers by breeders. And each speaker will give their presentation twice during the day.. More information will follow shortly about signing up and attendance.

3. Voting:

A. Amendment to Article VII of the Bylaws which would preclude any former AKC employee from serving on the Board of Directors.

After discussion, the vote was taken and the amendment did not receive a two-thirds majority. The Amendment failed.

B. Amendment to Chapter 14, a new Section 18A of the Field Trial Rules and Standard Procedures for Pointing Breeds - Rules for Pointing Breed Trials. This amendment would allow the Irish Setter Club of America to hold a Gun Dog Championship open to walking handlers only. The proposed amendment was brought forward by Irish Setter Club of America and is approved by the Performance Events Department and the AKC Board of Directors.

There was no discussion. The vote was taken and the amendment passed.

4. <u>Proposed Amendments to be voted</u> on at the September meeting:

A. The following proposed amendment was read to the Delegates, and will be published in two issues of the AKC Gazette. The Delegates will vote on this amendment at the September 2013 meeting.

Proposed amendment to Chapter 4, Section 2, of the Rules Applying to Dog Shows - Approval of Judges' Panels and Premium Lists. This amendment would eliminate different time frames for sending premium lists out. The phrase "*if sent by other than First Class Mail and at least FOUR WEEKS if sent*

by First Class Mail." will be removed. The revised Section 2 would read:

> SECTION 2. Premium list and entry forms must be printed and sent to prospective exhibitors at least FIVE WEEKS prior to the closing date for entries of show. Four copies of the premium list must be sent to The American Kennel Club at time of distribution.

This amendment was brought forward by the Delegate Dog Show Rules Committee and is approved by the AKC Board of Directors.

B. An Amendment applying to Chapter 5, Section 2 regarding ribbons and rosettes was to be read to the Delegates. The Chair announced that at the request of the Dog Show Rules Committee, the proposed amendment was withdrawn.

3. Fall Specialty: Brian Bogart

- The guidelines for this committee were updated and sent to the AMSC President, John Constantine.
- Lists of AMSC Officers, Regional Delegates & Board Members have been submitted to the Montgomery County Kennel Club (MCKC) for publication in their premium list and show catalog. Mailing and email addresses of our secretary and treasurers were sent to the MCKC.

- Correspondence was sent to the MCKC requesting two trophy tables and two ring stewards for this show. Ring stewards will be provided and will be free of charge.
- An email was sent to the AMSC trophy committee requesting they submit a trophy and prize money lists to the MCKC Trophy Chair. A copy of this communication was sent to the chair of this committee.
- A copy of the "Code of Ethics for Specialty Shows and/or Shows Which Sweepstakes Are Held" was emailed to the sweepstakes judge.
- An email was sent to the AMSC President and Treasurer requesting a change in the verbiage of our expense policy. Currently the AMSC Expense Policy states "Receipts are required for all reimbursements and must be sent to the Show Coordinator within 7 days following the Specialty." The proposed modification was "Receipts are required for all reimbursements and must be sent to the AMSC Treasurer within 7 days following the Specialty." (This change was discussed by John and Sharon and both felt comfortable with this change and did not feel it presented a problem for the club.)
- A letter was emailed to the regular class judge reviewing the AMSC expense guidelines on expenses and reimbursement.
- Our regular class judge, Penny Hirstein and sweepstakes judge, Joan Huber were contacted concerning their need for help with travel or hotel arrangements. In addition, they were both invited to the 2013 Annual Dinner and Meeting with compliments of the AMSC.
- Correspondence was sent to the AKC for clarification on their disabled confirmation handler policy. Their reply was:

"The AKC strives to provide an opportunity to participate in its events. In the case of conformation judging, where decisions are based solely on the quality of the dogs, a judge may modify the regular judging procedure to accommodate a disabled handler. If a modification of normal judging procedures is required, the judge needs only to determine that it would not inhibit the ability of the other handlers in the ring to show their dogs. A disabled handler may compete using a cane, crutch, or electric-powered wheelchair. However, when gaiting the dogs as a group, the judge should ensure that a handler who cannot maintain a normal gait for the breed being exhibited, be placed in line where it will not interfere with the ability of the other dogs to gait properly.

Blind handlers may have a second person assist them in individual and group gaiting of the dogs. If the ring surface or terrain makes it difficult for the assisted handler to gait the dog at a normal speed, the judge may adjust where the dog is placed in line to give all handlers an equal opportunity to show their dogs. Blind handlers may have the second person assist in placing table dogs onto tables and verify weight and measurements that may be required under the breed standard. The primary function of exhibiting the dog is the responsibility of the handler and not the second person in the rina.

If the handler believes they need further modification then what the guidelines allow, this can be requested through AKC's Legal Department. This must be done in writing."

It was interesting to note that the Standard Schnauzer presentation included a "whatever", "it's only a fault" position about docked or undocked tails, the Miniature Schnauzer presentation emphasized our recent breed standard changes of DQ for not allowed colors, DQ requiring black nose, and re: tails "A properly presented Miniature Schnauzer will have a docked tail as described; all others should be severely penalized", and the Giant Schnauzer, though they have not adjusted their breed standard, were emphatic that the G.S. is a docked breed.

We had a good number of members bringing their dogs to help with the "hands on" portions, as well as several helping during the ringside mentoring in the next days. We received several very nice compliments on the quality of the dogs, both for the presentation and hands on, and those in the ring, and for the presentation itself. I experimented with focusing judges on Size (a deal breaker), Shape (square but much more detail), Coat (texture), and Color (another deal breaker). This idea is similar to what a number of other breeds are trying - i.e. Pugs use "Round head, Square body, Curly tail"... and much more, but those three for judges to focus. We shall see...

Sodium Bisulfate: It Might Burn Your Pet's Mouth, Throat, and Stomach - But They're Adding It to Food Anyway

Pet food manufacturers, anticipating new regulations as a result of the Food Safety Modernization Act, are focused on product safety issues and in particular, salmonella contamination.

Pet food producers are testing different strategies to control salmonella, and one of those is an additive called sodium bisulfate, which is an acid salt currently used in some processed pet foods to acidify urine, reduce pH levels, and control microbes in soft treats and liquid digest. Recent studies indicate sodium bisulfate can control salmonella contamination on the surface of dry pet food.

However, sodium bisulfate isn't an entirely benign additive. In humans, symptoms from swallowing more than a tablespoon of this acid can include burning pain in the mouth, diarrhea, vomiting, and severe low blood pressure. The Material Safety Data Sheet classifies sodium bisulfate as a corrosive.

It's important to remember that the danger of salmonella poisoning from pet food is a risk to the humans serving the food – not the dogs or cats eating it. Healthy pets are able to handle a much higher bacterial load than their owners. Following a few simple handling precautions should keep you and your family safe from contamination.
